








WRITE FOR RIGHTS

It only takes a few minutes to write a card or letter. But this simple act means a lot to someone whose rights are being abused.

For a prisoner wrongly detained, for family members waiting for news of a relative who has 'disappeared', for a torture survivor fighting for justice, cards bearing messages of solidarity are a source of hope, strength and inspiration.

Letters can pressure the authorities to address cruelty and injustice. Presidents, police chiefs and prison governors take note when they receive appeals to release a prisoner, stop the harassment of an activist or change an unjust law.

Even when we don't immediately achieve the change we are hoping for, the powerful effect of cards and letters from people like you is evident in the feedback we receive (see page 22).

DATES TO REMEMBER

The Write for Rights Campaign runs from **1 November** to **31 December**. International Human Rights Day is **10 December**.

THIS YEAR'S CAMPAIGN

For the majority of cases in this booklet, there are two actions you can take:

- + Send a solidarity message to the person or people suffering human rights abuses
- + Write a letter appealing to the authorities who have the power to remedy the abuses.

For some cases we ask you to make online solidarity actions or send tweets.

GETTING STARTED

If you are new to this campaign, here are a few tips.

- + Each page has all the information you need to act on one case. Just follow the advice given. See Frequently Asked Questions, page 19, for explanations about the advice.
- + Don't feel you have to take action on all 12 cases: choose one or two if that's easier.
- + Write your own personal message of support and solidarity. It's always best to use your own words, but if you're unsure, there is a suggested message as a guide.
- + When writing to the authorities, include your name, address and country. This shows the letter is genuine and personal. Think about the people who read your letter. Write to them as one human being to another, but keep requests clear and polite.







BURKINA FASO

Forced marriages

ONE IN THREE GIRLS MADE TO MARRY OLDER MEN

Maria (not her real name) was just 13 when her father threatened to kill her if she refused to marry a 70-year-old man. She walked nearly three days to seek refuge. One in three girls in Burkina Faso are married off before they turn 18. Some are as young as 11. They are expected to have as many children as their husbands want, regardless of their own wishes or the health risks brought about by early pregnancy. Once married, many are compelled to cook, clean, fetch water and work in the fields, dawn to dusk. Very few go to school. Some girls are doing all they can to escape forced marriages, despite huge pressure from their families and wider society.

Salutation: Dear Minister

In your letter: Urge the government to enforce and ensure the application of national laws and international obligations prohibiting forced and early marriage. Call on the authorities to set up more shelters and guarantee support services for victims of early and forced marriages. Please DON'T mention abortion as this is a sensitive question in Burkina Faso.

FACING JAIL FOR STUDENT PROTEST

Young activist Phyoe Phyoe Aung is secretary-general of the All Burma Federation Student Union, one of the largest student unions in Burma (Myanmar). She has been in prison since 10 March 2015 after being violently arrested during a protest against the newly adopted National Education Law. Phyoe Phyoe Aung and more than 100 student protesters have been charged with a range of criminal offences. Many face sentences of more than nine years' imprisonment. Despite what appears to be a systematic clampdown on the student movement, there is reason to believe that the authorities can be pressured into releasing Phyoe Phyoe Aung and the others.






DEMOCRATIC REPUBLIC OF CONGO

Fred and Yves

BEHIND BARS FOR PROMOTING DEMOCRACY

Congolese activists Yves Makwambala and Fred Bauma were arrested on 15 March 2015 during a press conference in Kinshasa at which three Democratic Republic of Congo youth movements launched a platform called Filimbi ('whistle'). Filimbi aims to strengthen civic education among young people ahead of the 2016 general elections. Fred and Yves were kept in secret detention for two weeks by the national intelligence service, without access to family or lawyers. Yves was transferred to Makala prison in Kinshasa after 40 days, followed by Fred 10 days later. They face a range of charges, including 'conspiracy against the head of state', which carries the death penalty.



Teodora Del Carmen Vásquez



IMPRISONED FOR SUFFERING A STILL-BIRTH

Teodora del Carmen Vásquez was sentenced to 30 years in prison for 'aggravated homicide' in 2008 after suffering a still-birth. Expectant Teodora, already mother of an 11-year-old boy, started experiencing severe pain while at work. She went into labour and was unconscious when she gave birth to a still-born baby. When she came round, bleeding profusely, police handcuffed her and arrested her on suspicion of murder. Only then did they take her to hospital. In El Salvador, women who suffer still-births are often suspected of having had an abortion, which is considered a crime, under any circumstance. Teodora's trial was deeply flawed; she was presumed guilty and could not afford an effective legal team.

We plan to collect the images at the end of the campaign and make them into a newspaper which local partners, Agrupación Ciudadana, can show to Teodora's family. Her family or lawyer can then take the newspaper to show her when they visit.

STUDENT'S DISABILITY GETTING WORSE IN CUSTODY

Student Israa Al-Taweel was arrested on 1 June 2015 and taken to the National Security office in central Cairo, where she was blindfolded and interrogated about links to the Muslim Brotherhood. She had no chance to contact a lawyer or her family – who for 15 days were desperately looking for her in police stations, courts and prisons. She is now held in Al-Qanater prison, accused of 'belonging to a banned group' and 'broadcasting false news'. In January 2014, Israa was shot in the lower back at a protest. The injury left her unable to walk and she uses a wheelchair. Her condition had begun to improve with physiotherapy, but is deteriorating now that she is no longer receiving treatment.




GREECE

Costas

ATTACKED FOR BEING IN LOVE

While sitting on a bench in central Athens in August 2014, Costas and his partner, who is a refugee, were badly beaten up by thugs in a homophobic and racist attack. No suspects were ever identified. Between 2014 and 2015, the number of reported attacks against gay, lesbian, bisexual, transgender or intersex (LGBTI) people in Greece has more than doubled. Police and the government have done little to discourage such racial and homophobic violence. Greek law doesn't recognise same-sex relationships. Costas and his partner live in constant fear for their safety. In March 2015, his partner was attacked again.

TEENAGER TORTURED INTO TV 'CONFESSION'

Saman Naseem was 17 when he was arrested for allegedly taking part in armed activities against the state. He says he was tortured and forced to make a 'confession' on state television. He was sentenced to death. After a worldwide campaign to stop his execution in February 2015, Saman was transferred to an undisclosed location and held incommunicado for nearly five months. Following a judicial review the authorities quashed the death sentence imposed for 'enmity against God' and 'corruption on earth'. Saman now faces a full retrial. He deserves one without the use of torture-tainted evidence and without recourse to the death penalty.



In your letter: Don't call for Saman's release. Focus on the need for a fair trial. He is not a prisoner of conscience – this is an issue of juvenile detention and the execution of minors. Call on the authorities to ensure that Saman's new trial is in accordance with fair trial standards, in line with the principles of juvenile justice, and without recourse to the death penalty. Insist that confessions obtained under torture are not used as evidence of guilt.

FACING JAIL FOR TWEETING CARTOONS

Political cartoonist Zulkiflee Anwar Ulhaque, aka 'Zunar', is facing a long prison sentence for cartoons he tweeted on 10 February 2015. They lampooned the decision to jail opposition leader Anwar Ibrahim on sodomy charges. Zunar is charged under the Sedition Act, a colonial-era law often used to clampdown on freedom of expression in the guise of protecting national security and deterring racial or religious unrest.

Zunar has been targeted numerous times for his political cartoons; he holds the record for the highest number of sedition charges in Malaysia. He was briefly detained in 2010 after the publication of his book Cartoon-O-Phobia. Five of his books have been banned for content allegedly 'detrimental to public order'.

CONFESSED TO MURDER AFTER 15 HOURS OF TORTURE

In July 2012 Yecenia Armenta was arrested by plain clothed state police who accused her of ordering the murder of her husband, who had died a week previously. The officers took her to an unknown location where she was asphyxiated with a plastic bag, subjected to waterboarding and forced to strip naked. She was hung upside down, beaten and raped. Yecenia gave in to demands to confess after 15 hours of torture, when police officers threatened to bring her children in to rape and kill them. She was still blindfolded when she signed the confession. Independent medical experts have confirmed that she was tortured. Yecenia deserves to be free – and to see her torturers brought to justice.

JAILED FOR 'INSULTING THE JUDICIARY'

Waleed Abu al-Khair is a prominent human rights lawyer who has represented many victims of human rights violations, including his brother-in-law Raif Badawi, who was sentenced to 1,000 lashes for blogging about free speech. After being harassed and and interrogated on numerous occasions by the authorities, Waleed was sentenced on 6 July 2014 to 15 years in prison, plus a 15-year travel ban. He was found guilty of 'insulting the judiciary', 'disobeying the ruler' and 'harming the reputation of the Kingdom'. Waleed suffers from diabetes, and says he has been tortured. He has been regularly moved between prisons, making it difficult for his wife and child to visit him.

ABDUCTED MOTHER AND SIX CHILDREN

Rania Alabbasi is a successful dentist in Damascus, Syria, and the busy mother of six children, Dima, Entisar, Najah, Alaa, Ahmad and Layan, aged between three and 15. On 9 March 2013, Syrian government agents came to her home and took away her husband. Two days later, they came for her and her children. None of them has been heard of since. The Syrian authorities have refused to give Rania's relatives any information about what happened, or where they are now. The Syrian government has ignored a 2014 UN resolution calling for an end to these 'enforced disappearances'.

IN SOLITARY CONFINEMENT FOR 43 YEARS

Albert Woodfox, 68, has been in solitary confinement in Louisiana since his conviction in 1972 for the murder of a prison guard. He has always maintained his innocence, claiming he was targeted because of his affiliation with the prison chapter of the Black Panthers. There is no physical evidence to link him to the crime; the conviction relied primarily on the testimony of an eye witness who received favours, including his release, for cooperation. Albert's conviction has been overturned three times yet he remains in prison as the state appeals every decision in his favour. In June 2015 a federal court ordered Albert's immediate release, but the state appealed again and he remains in jail pending a further ruling.



Last year, hundreds of thousands of people in more than 200 countries and territories took part in our global **Write for Rights** campaign, resulting in more than 3 million actions. Here's an updates on the 12 cases.

BANGLADESH

Kalpana Chakma

We are still waiting for the Police Superintendent of Rangamati Hill District to submit her report on the investigation of Kalpana Chakma's case.

CHINA

Liu Ping

For the first time, Liu Ping's daughter was allowed to visit her in prison at the end of 2014. We believe the international attention generated by Write for Rights contributed to this.

GUATEMALA

Yolanda Oqueli

On 15 July 2015 an appeal court ordered the suspension of construction work at the El Tambor mine until proper consultations are conducted with the affected communities of San Pedro Ayampuc and San José del Golfo. It's a huge victory for Yolanda and other activists campaigning against the damage caused by the mining project.

NIGERIA

Moses Akatugba

The Governor of the Niger Delta responded to pressure from Amnesty supporters and granted a full pardon to Moses, who had been sentenced to death aged 16 for allegedly stealing three phones.

NORWAY

John Jeanette Solstad Remo

Following our campaign in support of John Jeanette, the Norwegian government said it would change the law, so that people who want to change their legal gender can do so without undergoing compulsory medical treatment.

PHILIPPINES

Alfreda Disbarro

The two policemen identified by Alfreda as her torturers were found guilty of grave misconduct. Both received a one-rank demotion.

SAUDI ARABIA

Raif Badawi

He was flogged on 9 January 2015 – the first 50 lashes in his sentence of 1,000. The news quickly went around the world and boosted the campaign for his release. Although his sentence was upheld in June, he has yet to endure further flogging.

SRI LANKA

Prageeth Eknaligoda

There has been no further progress in the case, although the election of a new President of Sri Lanka in January 2015 brought hope of change to the country.

TURKEY

Hakan Yaman

The investigation into the police attack on him continues. Our campaign has ensured attention from the Ministry of Justice for the case.

UNITED ARAB EMIRATES

Dr Mohammed al-Roken

The human rights lawyer remains in prison, serving a 10-year sentence. However, our international campaign has helped human rights activists and prisoners' families in the UAE feel less isolated from the world.

USA

Chelsea Manning

Together, we took more than 240,000 actions for Chelsea Manning, serving 35 years in prison for leaking classified US government material. She remains in prison and is preparing a court-martial appeal. The US military have agreed to provide her with hormone therapy treatment.

UZBEKISTAN

Erkin Musaev

The family of Erkin Musaev, falsely accused of spying and jailed for 20 years after unfair trials, told us your letters gave him 'strength, optimism and faith'. Erkin thanks everyone who took action. He remains in prison.



QUESTIONS

FREQUENTLY ASKED QUESTIONS

Why can't I post a letter to all the people featured in this booklet?

We give a postal address wherever possible. But in some cases, it may not be safe for the person to receive mail, or the postal service in their country may be unreliable. In some prisons the authorities limit the amount of mail prisoners can receive.

Why can't I send religious cards to all the people featured?

If we ask you not to send a religious card, it is for the safety of the recipient/s. In some cases association with a particular faith or with Amnesty's human rights work could put them at greater risk.

What counts as a non-religious card?

Cards illustrated with things like snowy scenes, fir trees or robins. The message 'Season's greetings' is non-religious.

Can I send cards produced by other organisations?

That is fine, as long as their work cannot be considered 'political' as this might cause problems.

Why are there only 12 cases?

The 12 cases are carefully chosen, so please focus on those in the first instance. However, we have eight extra cases for people who want to do more. Contact sct@amnesty.org.uk

Why do we use drawings rather than photos?

We don't have good photos for all the cases. Drawings enable us to present them all in the same way.

What if the fax number or email address for the appeal letter doesn't work?

Please send a letter instead. The fax/email may have been switched off because the addressee has been overwhelmed by appeals.

What if I receive a reply?

Please send a copy to the Individuals at Risk programme. It will help us assess the impact of the campaign.




