New refugee campaign 'I welcome'

Last month, Amnesty launched a new global refugee campaign, I Welcome. The aim of the campaign is that refugees are protected, welcomed and enjoy their human rights, including through strengthened global responsibility-sharing and international cooperation.

"Who is a refugee?

A refugee is a person who cannot return to their own country because they are at risk of serious human rights abuses there, or because of who they are or what they believe in. Because their own government cannot or will not protect them, they are forced to flee their country and seek international protection.

Who is an asylum-seeker?

An asylum-seeker is someone who is seeking international protection abroad, but is yet to be recognized as a refugee.

Who is a migrant?

A migrant moves from one country to another, usually to find work, although there may be other reasons such as to join family. Some move voluntarily, while others may feel compelled to leave because of economic hardship or other problems. People can migrate "regularly", with legal permission to work and live in a country, or "irregularly", without permission from the country they wish to live and work in.....

.....On 19 September 2016 the United Nations (UN) General Assembly collectively, and spectacularly, failed the 21 million refugees of this world. The "High-level Summit to address large movements of refugees and migrants" was to address the global refugee crisis, a crisis in which, daily, millions fleeing war and persecution in countries like Syria, South Sudan, Myanmar and Iraq suffer intolerable misery and human rights violations. World leaders at the General Assembly agreed an Outcome document that said they would help, but agreed no actual plan. Empty words that change nothing."

There is, I feel, a problem for us to internalise what "21 million" (21,000,000) really means. When it comes to such large numbers we have no sense of scale. So, if the report had said 22 million I would not register that as a major change (think about it). However, it's 1,000,000 people. That represents about 3.5 cities the size of Brighton and Hove combined. (pop Brighton and Hove 2016 estimated at 277,000).

To give an idea of scale have a look at the map below. If Brighton and hove has 277,000 then this is the space that 21 million would need with the same density of houses.



That space would be filled SOLID with dwellings. Except, of course, there is nothing solid about the accommodation for most of these people.

Although members of the Youth Movement LUCHA, including Fred and Yves, have been released, the charges against them have not been dismissed. We sent letters and a petition to President Kabila asking him to take all necessary measures to drop these charges.

Also we urged him to end human rights violations related to elections. We asked him to respect the rights to freedom of expression, association and peaceful assembly, including political opponents and pro - democracy activists.

We collected 90 signatures for the petition and had 60 letters signed by people in the street. Well done Amnesty Activists of Brighton and Hove!

Campaign Nazanin Zaghari Ratcliffe (British - Iranian Charity Worker)



CHARITY WORKER DETAINED WITHOUT CHARGE

Nazanin Zaghari Ratcliffe a British-Iranian project manager, was arrested on 3rd April this year at Tehran's international airport. She was due to return to the UK with her 22 month old daughter Gabriella, following a family visit. Before being taken away she was allowed to leave Gabriella with her parents, but the authorities confiscated Gabriella's British passport. Unidentified officials later told the family Nazarin was being held in the city of Kerman, and had been arrested for 'national security' reasons. She has no access to a lawyer and may have been coerced into 'confessing'.

On 11th May Nazarin was finally permitted to meet her family, though security agents remained present. She was allowed to make phone calls to relatives in Iran, but prevented from speaking to her husband Richard who is in the UK. In June Nazarin was moved to Evin prison. She is now able to see her mother and Gabriella, and has spoken to Richard but her family has no way of contacting her. In August Nazarin was brought before a Revolutionary Court for the first time.
