N.B Please note that the Pride Committee are being extra careful regarding security this year and insist that groups in the Parade know who is in their group BEFORE the event – so that means you cannot just turn up on the day.

CHECHNYA: STOP ABDUCTING AND KILLING GAY MEN Over a hundred men suspected of being gay have been abducted, tortured and some even killed in the southern Russian republic of Chechnya.

According to independent daily newspaper, Novaya Gazeta, up to 100 men suspected of being gay have been abducted as part of a coordinated government campaign.

It claims the men have been tortured and otherwise ill-treated, and three are reported to have been killed by their captors – but there could be more.

Our researchers have spoken to some of the men who managed to escape Chechnya. They talked about their harrowing experiences, but for the sake of their safety we are unable to provide details.

We do however, need you to urge the Russian and Chechen authorities to investigate these abductions and bring those responsible to justice.

DRC: Human rights grievances fuelling a "desperate and dangerous" situation

Responding to an urgent appeal by former UN Secretary General Kofi Annan and nine former African heads of state warning that the future of the DRC is in grave danger, Sarah Jackson, Deputy Regional Director for East Africa, the Horn of Africa, and the Great Lakes said:

"The launch of this appeal is extremely timely and we echo the concerns raised by Kofi Annan. The Democratic Republic of Congo is a powder-keg of human rights grievances that frequently spill over into violence. Instead of taking concrete steps to ease the tensions, the government has chosen to focus its efforts on quashing dissenting voices, killing and imprisoning dozens of protesters in the process.

"Violent conflict in the Kasai region has forced 1.3 million people to flee their homes and requires urgent and immediate action from the UN Human Rights Council. Hundreds of extrajudicial executions and other human rights violations committed by the armed forces have gone uninvestigated fuelling a conflict now affecting eight provinces in which an estimated 500 to 1,000 people have been killed.

"The international community, and African leaders in particular, cannot afford to continue ignoring this desperate and dangerous situation."

Democratic Republic of Congo – July campaign update

Our campaign around human rights in the DRC continues, as does the violence and instability, unfortunately. With President Kabila still in power after his constitutionally mandated two-year term of office ended in December 2016, there is huge frustration at further delays of voter registration and therefore elections. Efforts to implement a power-sharing deal with opposition parties has so far failed. Fighting between armed militias and Government forces continues in many areas, often affecting civilians with hundreds of thousands being displaced, and as if the country's fortunes weren't bad enough, there has been an outbreak of Ebola.

For all these reasons we must keep up our campaign supporting democratic movements, human rights defenders and those brave enough to speak out and challenging the many corporate interests that seek to benefit financially from this extremely resource-rich but economically poor country.

Initially our campaign came under Amnesty International's *Individuals at Risk* (formerly known as *Prisoners of Conscience*) and we campaigned for the release of two men detained for their establishment of, and active participation in, LUCHA (*Lutte pour le Changement / Struggle for Change*), an educational youth movement. Having secured their release, no doubt thanks in part to the international publicity and our worldwide letter-writing campaign, Amnesty would like us to concentrate on the shocking human rights abuses, and in particular the use of child labour, in the mining of cobalt, which is used extensively in the batteries of all our personal electronic gadgets and many car batteries. (More than half the world's supply of cobalt is found in DRC.)

We have already had two very successful letter-writing stalls outside the Amnesty bookshop in Sydney Street, where we have collected nearly 200 signed letters to Volkswagen and Samsung. These also proved very useful opportunities to engage with members of the public about this issue and our other campaigns.

Andrew, Sue, Madeleine and Celia worked hard for two hours talking to passers by and asking them to sign a letter to Samsung in Korea about their mining of **COBALT in the DEMOCRATIC REPUBLIC OF CONGO.**

A key component of rechargeable batteries is a metal called cobalt. These batteries recharge our phones, laptops, electric cars etc. Over 50% of the world's supply of this metal comes from the DRC. Samsung often use children as young as 7, on 12 hour shifts, hauling loads of the raw ore, and often working underground in very unsafe conditions. They get paid US\$1-2 a day. This practice has been documented by Amnesty. We think it is wrong for children to be forced to work at all and certainly not to produce goods for western consumers such as us. These children have a right to education and a normal childhood.

Our letter asked Samsung to stop these human rights abuses and to improve working conditions for adult miners.

The public were very receptive and we got 120 letters signed.

DR SALEM MOHAMED BEITELMAL ABDUCTED IN LIBYA


On Saturday 10th June, with Sue, Julian, Andrew and Celia, our Amnesty stall campaigned for the release of Dr. Beitelmal who was kidnapped by local militia while driving to work at the University of Tripoli. His car had been abandoned near his home and in spite of family and neighbours searching for him, there was no trace of him. The area where he had been abducted, Siyyad, is under the control of several militias, all affiliated to three different factions struggling for power in this dangerous country.

Dr. Beitelmal is an engineer involved in the reconstruction of his country and much respected by his students and colleagues. In spite of his family being in contact with the authorities, they have been unsuccessful in getting information and no group has claimed responsibility for his abduction. His health is not good and his family are very concerned.

Thank you for campaigning for this prisoner of conscience.
