# **BRAVE Campaign**

Campaigning for the increased recognition & protection of Human Rights Defenders

On 16 May 2017, Amnesty International launched a new global campaign, BRAVE, to strengthen the recognition and protection of human rights defenders around the world. The campaign is in response to the increased attacks and targeting of Human Rights Defenders (HRD), Activists and civil society organisations around the world. The campaign will run until the end of 2019 and will also be a priority campaign at Amnesty International UK.

### GOOD NEWS - Dr Mudawi Ibrahim Adam released!

On 29<sup>th</sup> August, Dr Mudawi Ibrahim Adam, a human rights defender from Sudan was given a Presidential Pardon and released from prison. Dr Mudawi Ibrahim Adam is one of five human rights defender cases that Amnesty UK are campaigning on as part of our Brave campaign.

Dr Mudawi was released, along with five other human rights defenders, late on 29 August. He faced six trumped-up charges, including 'undermining the constitutional system' and 'waging war against the state', both of which carry either the death penalty or life imprisonment. These false charges are part of a wider patterns of smear campaigning targeting Dr Mudawi and other Human Rights Defenders in Sudan. All charges against him have been dropped.

Sarah Jackson, Amnesty International's Deputy Regional Director for East Africa, the Horn and the Great Lakes, said:

"It is a great relief that this awful chapter has drawn to a close. Dr Mudawi, a prisoner of conscience, has been reunited with his family and is once again a free man.

"Dr Mudawi's eight months in prison represent a grave miscarriage of justice and his release must serve as a first step towards ending the criminalisation of human rights work in Sudan. The authorities' relentless assault on any form of criticism endangers anyone who dares to speak out, and it must stop."

### Take Action for Tep Vanny – Cambodian Housing Rights Defender

#### **Tell Cambodia to release Tep Vanny**

Tep Vanny is a housing rights activist, human rights defender and a community representative. She was arrested on 16<sup>th</sup> August 2016 for defending her community's land following their forced eviction from their homes in Phnom Penh.

Write to the Prime Minister, Samdech Hun Sen:

- Stating that Tep Vanny is a human rights defender and prisoner of conscience, detained on baseless charges for her peaceful activism defending the right to housing and freedom of expression
- Calling for her immediate and unconditional release, the dropping of all charges and the end of all criminal investigations against her
- Calling on the authorities to publicly condemn and order an end to harassment and violence against human rights defenders, including unwarranted legal action and imprisonment.
