#### **United Arab Emirates**

This month sadly marks the 7th month that Ahmed Mansoor has been in jail and also means that he will very likely spend his birthday in prison on the 22nd October.



To mark this, our group will once again hold a vigil at the St Peter's Square entrance to the Town Hall

(by the cenotaph) before our regular group meeting. We will meet at 6.30pm, hold the vigil for about 30mins and then walk to the meeting at MadLab.

In addition, this month, a meeting of groups and individuals that work on behalf of Ahmed Mansoor and Dr. Mohammed Al-Roken was held at the Garden Court North Chambers, Manchester. At this meeting, future events were discussed and planned.

#### Journeys Festival

Over the weekend of Sat 14 - Sun 15th October, Journeys Festival took over Cathedral Gardens for JOURNEYS Weekender with a line-up of live music, workshops and food. We were delighted to be part of this with a stall featuring our Refugee campaign.



We collected 82 signatures for the 'keep refugees families together' petition and 75 for the 'stop violence against the Rohingya' petition.

#### **Crisis and Tactical**

#### Palestine - 50 Years of Unlawful Occupation

The occupation of Palestine by Israel started in 1967 during the 'Six-Day War'. This occupation has been declared unlawful by international organizations, including the UN.

According to Amnesty International this occupation has resulted in grave human rights violations, including the destruction of homes, forced evictions, unlawful killings, arbitrary detentions, movement restrictions, exploitation of resources and collective punishment.

The Israeli settlements into Palestinian occupied territories (OPT) use unlawfully appropriated Palestinian resources, including land, water and minerals. These resources are transformed to produce goods, which are sold for private profit and to sustain the settlements' economy. In 2015, the Israeli Ministry of Economy estimated the worth of settlement exports to the EU each year to be around 154-230m GBP.

To mark 50 years of the occupation of Palestinian territory Amnesty International has launched a new campaign calling for the ban of Israeli settlement goods. At the October meeting we will have the opportunity to sign this petition.



#### Syria - Action against War Crimes

At the October meeting we will have the opportunity to send letters to our MPs asking them to take a stand against the horrific crimes against humanity that have been taking place in Syria since the start of the conflict in 2011. The sample letter has been prepared by our friends at the Rethink Rebuild Society.

**Exhibition 'Silenced Voices: Syrian Women in Assad's Prisons'**. At the beginning of October a reduced version of this exhibition was displayed at the Manchester Museum, as part of Journeys Festival International. We were again pleased to be able to offer support to Rethink Rebuild and have an Amnesty International stall.

#### Yemen - Breakthroughs and Setbacks

• At the end of September 2017 the UN Human Rights Council has passed a resolution mandating a group of international experts to investigate abuses by all parties to the conflict in Yemen. This resolution is the result of years of campaigning and lobbying by Yemeni human rights organizations, Amnesty International and other international organizations.

"This resolution is a victory for Yemenis whose suffering at the hands of all parties to the conflict has been overlooked by the international community." said Anna Neistat, Amnesty International's Senior Director for Research. Ms Niestat also added "Given the long delay, it is imperative that the group of experts is established as soon as possible and given adequate resources to get to work without delay, and that it receives full cooperation from all parties to the conflict."

For the past two and a half years all parties to the conflict in Yemen have flagrantly flouted international law. In 2015 Saudi Arabia effectively blocked efforts to set up an inquiry by tabling its own draft resolution.

• In early October 2017 the UN included the Saudi Arabia-led coalition into its annual Children and armed conflict report (CAAC) which covers the year 2016. According to this report, 683 children were killed or injured by the Saudi-Arabia led coalition in 2016.

However, as a result of diplomatic pressure from Saudi Arabia, the report contains a new category that acknowledges the efforts of the coalition to "put in place measures during the reporting period to improve the protection of children".

Amnesty International has seen no evidence of such measures. In recent weeks, Amnesty International confirmed the use of a US-manufactured bomb by the Saudi-Arabia led coalition in an August attack that killed seven children.

According to UNICEF's latest Monitoring and Reporting Mechanism (MRM) figures, between 26 March 2015 and 31 March 2017, at least 1,595 children were killed and 2,542 others injured in Yemen. The Saudi-led coalition is responsible for the majority of these child casualties.

In 2015, Saudi Arabia was included in the CAAC report but was later removed by then secretary general Ban Ki-moon following intense diplomatic pressure.

Amensty Interational has stated that "the international community has caved in to political pressure again, underplaying the suffering of hundreds of Yemeni children".

At the October meeting we will do an action on Yemen.



#### East Asia (inc Burma)

The plight of the Rohingya people remains critical with little international effort being made to improve their situation. ## International Day of the Girl and the fight for girls' rights across the world

The following article by Gladys Burini was posted on the Children's Human Rights Network blog to mark the International Day of the Girl on 11th October.

'Today we celebrate International Day of the Girl. There are 1.1 billion girls in the world, and every one of them deserves equal opportunities for a better future. However, there are still many issues holding back girls' progress today across the globe.

#### We need an end to child marriage

Shockingly, every day 41,000 girls are married before they turn 18 years old. That's 15 million girls every year. Additionally, one in three girls in developing countries (with the exception of China) is married before they turn 18.

Girls forced to marry early often fail to complete, or even begin, their secondary education, and so cannot progress to higher education. The result is girls who are less skilled and unable to exploit their full potential. The World Bank has calculated that ending child marriage could increase earnings and national productivity by an average of 1%.

#### Child pregnancy: a global crisis

Every day 20,000 girls under the age of 18 years old give birth. This amounts to 7.3 million births a year. Due to the tender age at which these girls fall pregnant, complications during pregnancy

and childbirth are the second cause of death for 15 – 19 year-old girls. This is truly a global crisis.

For most, these pregnancies aren't out of choice, but result from early forced marriages or brutal sexual abuse, as well as lack of proper sexual and reproductive education and healthcare.

Even worse, some countries have banned pregnant girls from attending school. This sudden end to their education curtails their opportunities to later compete for well-paying jobs, and thereby contribute to the economic growth of their countries.

#### Fighting for the leaders of tomorrow

There is a lot that can be done to tackle these challenges facing girls. To begin with, governments should call upon their state intuitions to urgently collect data on issues affecting girls in their country. This would mean every country has a clear picture of the problems affecting girls that they need to address.

Governments also need to uphold their duty to protect girls from all forms of sexual exploitation and sexual abuse, and uphold the Convention on the Rights of the Child.

The media has a duty to report on these issues. A lot can be achieved from having an open dialogue about the problems that face girls. We need to constantly remind ourselves that every girl has the right to education, and we all stand to gain by ensuring they remain in school and complete their education.

Today, let girls be girls. Give them the opportunity to become the entrepreneurs, innovators, household heads, political leaders and mothers of tomorrow.'
