Write for Rights

Every year, Amnesty International runs 'Write for Rights', a campaign over November and December where we are encouraged to write messages of support to people around the world who have suffered injustice.

In 2016, 152,000 people across the UK took part in Write for Right. Amnesty does this because they know it works – see https://www.amnesty.org.uk/writing-rights-works.

This year's campaign features the cases of 10 human rights defenders (with a further 4 cases on line) as part of the global BRAVE campaign.

We are busy planning our involvement this year, with the BRAVE campaign subgroup lead by Hazel taking the lead.

Things aren't fully finalised yet, but this is what we currently have in the pipeline:

Sat 18th Nov. We have already held our first Write for Rights event at the Eighth Day Café writing appeal letters on behalf of the 10 cases. 9 turned up and 21 letters were written.



Mon 27th Nov – We will be writing messages of solidarity in greetings cards at our November group meeting

Sat 2nd Dec - We have a Write for Rights stall at the Birch Community Christmas Fair – an extra volunteer would be useful.

Sat 2nd Dec – Whalley Range Peace and Justice group are running their regular Write for Rights event at St Margaret's church. They have food and singing as well as lots of tables for card writing – a fantastic event and well worth getting along to. We will have a stall to publicise the Manchester Group and will feature the BRAVE campaign and sell Christmas cards – an extra helper would be useful.

Thurs 7th Dec – Another stall at the Acoustic Amnesty concert – two volunteer needed.

Sat 9th Dec – A Write for Rights stall at the Eccles Human Rights Day vigil.



Sunday Dec 10th – We hope to run a Write for rights event at the Manchester Sunday Assembly at the Wonder Inn, shudehill 11am-12pm – volunteers needed.

Sun 3rd or Sun 17th Dec – St Clements in Chorlton - we plan yet another stall! – one more volunteer needed!

Tues 12th Dec, 7-9pm: Friends of the Earth event (including Write for Rights stall) – an extra volunteer would be useful

'I Welcome' Refugee Campaign

Help us change the law for refugees



Restrictive rules mean that many refugees in the UK have no hope of being reunited with their family. Together we can change the rules which keep refugee families apart. Angus MacNeil MP has introduced a **private members bill**, which will receive its second reading on **Friday 16th March 2018**.

We need 100 MPs voting in favour of the bill to ensure it progresses to the next stage.

United Arab Emirates

Human rights activists, Ahmed Mansoor and Mohammed al-Roken are still in jail in the UAE.

Our group will once again hold a vigil at the St Peter's Square entrance to the Town



Hall (by the cenotaph) before our regular group meeting. We will meet at 6.30pm, hold the vigil for about 30mins and then walk to the meeting at MadLab.

Henrike has lead this work since we took up the case of Mohammed al-Roken. Very sadly, she is moving to Liverpool and will struggle to get to meetings in the New Year. Given the links that Manchester city council and football teams have with the UAE, it is important that we continue this campaigning. Does anyone fancy taking a lead on this?

Crisis and Tactical

PALESTINE - Amnesty's campaign has gone viral !

Through a recently launched new campaign for Palestine, which marks the 50th anniversary of the Israeli occupation, Amnesty is asking governments to ban Israeli's settlement goods. These goods contribute to Israel's economy, while penalising Palestine's. In 2015, the Israeli Ministry of Economy estimated the worth of settlement exports to the EU each year to be between 154M and 230M GBP.

Amnesty's campaign has already made some noise. On October 17th, Israeli media reported that Israeli Finance Ministry planned to take action against Amnesty by changing the status of Amnesty International's Israeli section so that donations to the organisation are no longer tax-deductible.

On November 17th, Raed Jarrar, Amnesty USA 's Middle East and North Africa advocacy director was refused entry into the OPT (Occupied Palestinan Territories) on the grounds of 'public security'. Raed's was on a personal trip, visiting his family, following the death of this father. During the questioning at the border the Israeli official asked Raed: '*Why does Amnesty International have a problem with Israel*?'. Raed was also asked to give the names of Amnesty's staff at the Israeli section in Tel Aviv and the International Secretariat branch in Jerusalem.

In the coming monthly meetings, we will sign petition sheets and cards addressed to the UK Foreign Secretary to support Amnesty's message.



SYRIA - Another veto from Russia

At the United Nations Security Council (UNSC) on October 17th, Russia used their veto power to block a one-year term extension for the joint investigative mechanism (JIM) mandated with investigating chemical attacks in Syria.

Sherine Tadros, Head of Amnesty International's UN office in New York stated: "For the ninth time, Russia has used its veto power to shield its ally, the Syrian government, from any punitive consequences it could face for war crimes and crimes against humanity committed since the start of the conflict over six years ago ... This routine abuse of the veto has become the equivalent of a green light for war crimes, allowing all parties involved in the conflict in Syria to act with complete impunity and disregard for international law, with civilians paying the ultimate price ... The UN Secretary General as well as Security Council members can no longer idly stand by as the UNSC is transformed into an instrument for political posturing between permanent members, and which has consistently failed to enforce resolutions adopted to end war crimes and crimes against humanity."

September 17th marked the second anniversary of the Russian military intervention in Syria with 5,233 estimated civilian casualties (information provided by Rethink Rebuild).

New report from Amnesty

Amnesty has just released a new report stating that the tactic of using starvation as a method of warfare is a crime against humanity. The report reads: 'Since the beginning of the armed conflict in Syria, the Syrian government has imposed sieges on populated civilian areas, using starvation as a method of warfare, and blocking or arbitrarily restricting access to basic necessitiesincluding food, water, medicine, electricity, fuel and communications. It has also blocked aid organisations from entering besieged areas. The effects have been devastating, pushing populations to the brink of starvation and causing people to die from otherwise treatable conditions.'

In an interview with Amnesty, a lawyer from Damascus stated that 'the government made its objective to destroy everything and leave us with nothing to stay behind for.'
