**Labour Rights in the Medical Supply Chain**

*We are delighted to welcome Arthy Hartwell from the British Medical Association to talk about this little known issue: We will hear about the manufacturing of medical gloves mostly in Malaysia and Thailand, by migrant workers in extremely poor working conditions and with many human rights abuses.*

#### West Africa: Mauritania



We wrote to President Aziz regarding the deteriorating right to freedom of expression in the West African state. The country is a highly centralised Islamic State with pervasive human rights violations. These include the use of torture, arbitrary arrest and long periods of pre-trial detention. Prisons are harsh, overcrowded and dangerous. The country suffers from slavery, slavery-related practices and trafficking. Violations of freedom of the press, association, and conscience are of serious concern. The case we have taken up is in support of **Mohamed Cheikh Ould Mohamed**, a blogger, detained for freely exercising his right to freedom of expression. He was originally sentenced to death for blogging in 2014 this was reduced to a two-year sentence on appeal. Due to be released in

November, he has so far not been set free. We wrote calling for his immediate release and that laws suppressing press freedom and freedom of expression be abolished.

#### Monthly Letter: Chile



The first Monthly Letter of 2018 is on behalf of a human rights defender, **Rodrigo Mundaca** who has had four criminal cases filed against him for defending human rights in Petorca province on behalf of those campaigning about illegal water extraction. Rodrigo works for a peaceful activist organisation, MODATIMA, whose members have been harassed and persecuted for their peaceful activism. ### China: Where is Liu Xia?



Since her husband's death the whereabouts of Liu Xia have remained unclear. She has been held under illegal house arrest since 2010 despite never having been charged with any offence. According to reports, she needed surgery in recent months, and her mental health has by all accounts declined further. She wrote to Herta Müller the 2009 Nobel Literature Prize Laureate "*I have no right to speak, speak loudly. I live like a plant. I lie like a corpse*". Despite international criticism, the Chinese authorities show no sign of loosening their repressive grip on Liu Xia's right to freedom. We wrote to the authorities calling for her immediate release, the right to leave China and to receive urgent medical care.
