# Campaigns

## **BRAVE Campaign**

Brave is a two year international campaign launched by Amnesty

in 2017 to highlight human rights defenders across the world who often work under conditions of intimidation, harassment and persecution.



### Suffragette Spirit

As we celebrate 100 years since women (well some women) got the vote and the valiant work done by the suffragettes, AIUK have launched a new initiative to celebrate Britain's women human rights defenders of today.



This campaign has featured strongly in the local media, including the Manchester Evening News. In response to their article our

secretary wrote a letter welcoming the initiative and thanking the MEN for giving in prominence – and the letter was published at the top of the Viewpoints page.

If you know someone in Greater Manchester who has carried out amazing human rights work, Amnesty want to hear from you. They might have helped the



homeless, aided refugees, or campaigned for better access to healthcare. They could have challenged bad business practices, supported the rights of refugees, or prevented forced evictions – any way they've made a difference.

Amnesty plan to take your nominations and use them to make an interactive map of women human rights defenders across the country. Not only will this show the sheer scale of human rights work by women in the UK, it will help people discover causes in their local area and help people link up to work together.

## 'I Welcome' Refugee Campaign

#### Families Together campaign

Refugee families, separated by war and persecution, are being kept apart by restrictive UK rules on family reunion. On **Friday 16 March**, MPs will debate an important bill to improve these rules and reunite refugee families. At least 100 MPs need to turn up

and vote on 16 March to change these unfair rules that keep refugees in UK apart from those they love.

To win this vote you need to tell your MP that you support refugee family reunion and urge them to attend the vote (it is a Friday when many MPs



head to their constituency, it is important that they realise that their constituents want them to stay and take part in this debate). See briefing attached with this newsletter.

### **United Arab Emirates**

Human rights activists, Ahmed Mansoor and Mohammed al-Roken; they are still in jail in the UAE.

Our group will once again hold a vigil at the St Peter's Square entrance to the Town Hall (by the cenotaph) before our regular group meeting. We will meet at 6.30pm, hold the vigil for about 30mins and then walk to the meeting at MadLab – check our Facebook page for last minute updates.

Henrike has lead this work since we took up the case of Mohammed al-Roken. Very sadly, her job has moved to Liverpool and she will struggle to get to meetings regularly. Given the links that Manchester city council and football teams have with the UAE, it is important that we continue this campaigning. Does anyone fancy taking a lead on this?

#### Screening of 'The Workers Cup'

There will be a special screening of "The Workers Cup" on the 27<sup>th</sup> February at 6.30pm at the Salford University, B4 Orange Tower, Salford Quays. The screening will be followed by a panel discussion about the film. The film gives an insight into the labour camps of Qatar, African and Asian migrant workers building the facilities of the 2022 World Cup compete in a football tournament of their own: The Workers Cup. With unprecedented access, this film unfolds largely inside a Qatari labor camp that the migrant workers compare to a prison.

### **Crisis and Tactical**

#### CHEMICAL WEAPONS ATTACK ON SARAQEB

In a press release issued on 6<sup>th</sup> February, Amnesty highlights that testimony gathered strongly points to the use of chlorine gas by the Syrian government in an attacked on the town of Saraqeb

on  $4^{\text{th}}$  February. The attack resulted in 11 people needing emergency treatment.

According to eyewitnesses from Syria Civil Defence (the White Helmets), barrel bombs with chlorine gas were dropped by a helicopter. The attack caused casualties, who included 3 members of the White Helmets, to gasp for air, suffer severe irritation to their skin and eyes, vomit and collapse.

Lynn Malouf, Amnesty International's Middle East research director stated: 'Once again, Syria's government has shown its utter contempt for international law by developing chemical weapons. Direct attacks on civilians are absolutely prohibited and are war crimes. The fact that the government feels free to flagrantly carry out such attacks using internationally-banned chemical weapons reflects the complete impunity enjoyed by those who order war crimes and crimes against humanity in Syria'.

### **Children's network**

#### Palestine

On 15 December, Ahed Tamimi and her family were protesting Trump's decision to recognise Jerusalem as the capital of Israel. In a horrifying turn of events, Ahed's 14-year-old cousin, Mohammed, was shot in the head at close range by an Israeli soldier.



On the same day, Ahed also came face to face with Israeli soldiers, when they entered the yard of her family's house. A video, which has since gone viral, shows the unarmed teenage girl slapping, shoving and kicking two armed Israeli soldiers who are wearing protective gear. It was clear she posed no actual threat to them – as they lightly swatted her advances away.

Ahed and her mother, Nariman, were arrested by Israeli soldiers and she faces up to 10 years in prison, if convicted of any of her alleged crimes. This punishment is blatantly disproportionate to her actions. Ahed, who has just turned 17, already spent a birthday in prison.

Her trial is imminent – we must act quickly. If you haven't already taken action sign the on-line petition NOW

# **Group News**

### **Past meetings/events**

#### **January Group Meeting**

We were delighted to welcome Kate Allen, Director of the UK section of Amnesty International to our January meeting. It was great to see good turn out and both new and old faces in the audience.

She started off by telling us about her recent trip to the Bangladesh/Myanmar border where Amnesty is talking to Rohingya refugees to find out what they really want. The upshot appears to be that most would like to go back to their homes but only with full citizenship rights.

She also talked about the plight of the AI staff in Turkey and how she would be at the court hearing the following week (which saw Taner Kılıç freed and then immediately rearrested). AIUK has been in contact with the UK government on this issue at the highest level and has received considerable support.

She gave us a resumé of the current priority campaigns, including the need to mobilise MPs for a private members bill (see Refugee campaign) and the forthcoming Suffragette Spirit initiative (see BRAVE campaign).

She reported back on 'the impact of the movement' initiative which is an ongoing consultation of how to improve our impact – an initial report in imminent. It is estimated that some 673,000 people are currently involved in Amnesty's work in the UK in some way and she emphasised the role of local groups in being Amnesty's public presence and told us that a survey has shown that people trust the local media more than the national media.

After a lively Q&A session Kate left as she was heading further north to the Isle of Lewis group (via Glasgow).

### Darwin Day Event Stall

We ran a stall featuring the BRAVE campaign at the Darwin Day event on February 12<sup>th</sup> at Manchester Conference Centre. The exhibition seemed busier than last year and we managed to get 206 appeal cards signed for the 4 key human rights defenders featured in this campaign. Thanks to Steve and Anne for their efforts.



### Film Screening - 'The White Helmets'



We held a free screening of the Oscar winning documentary 'The White Helmets', a 2016 British short documentary film which follows the daily operations of a group of volunteer rescue workers of the Syrian Civil Defense, also known as the White Helmets. Some 30 people came along to watch the very moving

film and to join in a discussion over Skype with Orlando von Einsiedel, the film Director and Khaled Khatib, a member of the White Helmets.

Everyone at the event was really engaged in the



discussion after the screening. Both Orlando and Khaled highlighted the importance of carrying on speaking about Syria and giving people access to information about Syria. We will carry doing our bit to allow this to happen.

Many thanks to Simona and our friends in Rethink Rebuild for getting this together.

#### **Party for Palestine**

On 11th February we took part to the event 'Party for Palestine' organised by Jane from City of Sanctuary. We celebrated Palestinian culture with great food, music and dance. A woman who recently completed her programme with EAPPI (Ecumenical Accompaniment Programme in Palestine and Israel) gave her testimony of the daily abuse of human rights Palestinian people are subjected to. These abuses make their every-day tasks, like going to school or work or access to clean water, a struggle.

### **Group Officers**

We will have our group AGM in March and one of the tasks will be to elect new officers and campaign leads for the group. The discussion at the February meeting should inform which areas of campaigning we will need leads for. However, we are definitely in need of a group chair person and a media lead.

Apart from chairing meetings, being chair involves a bit of coordinating the various campaigns and providing some direction for the group. The actual amount of work is not great as most of the admin is done by the newsletter and membership secretaries. You would always be supported by the coordinators group and we have occasional meetings to thrash out group policy and direction.

The media role would be to take a lead in promoting our activities via contact with the local media, e.g. via press releases, and use of social media. You would get support from our Regional Media Officer and training is available, there being a training day in Manchester scheduled for April 24<sup>th</sup>. It would be possible to job share this role if we had more than 1 volunteer.
