### 'Ban Israeli Settlement Goods' Vigil

Sunday June 10<sup>th</sup>

For half a century, Israel's occupation of the West Bank, including East Jerusalem, and the Gaza Strip has resulted in systematic human rights violations against Palestinians living there.

Amnesty wants

governments to stop enabling the economy that keeps these illegal settlements growing and fuels the suffering of Palestinians. Amnesty UK is calling on the Foreign Secretary to ban Israeli settlement goods from entering UK markets, and to stop companies in the UK from operating in settlements or trading in their goods. Using the verbal testimonies of refugees, *This Is Who I Am* is a reading that focuses on the challenges faced by LGBT people going through the UK asylum process.



## Campaigns

### United Arab Emirates

#### AHMED MANSOOR ON TRIAL

There are no updates on the situation of Ahmed Mansoor as yet. However, he appeared before a court in Abu Dhabi in the United Arab Emirates (UAE) in March and April. Amnesty International considers him to be a prisoner of conscience.

It is not known which court is hearing his case, the exact charges he is facing nor whether he has a defence lawyer.

Thus, it is important to take action:

– Calling on the UAE authorities to release Ahmed Mansoor immediately and unconditionally, as he is a prisoner of conscience detained solely for peacefully exercising his right to freedom of expression, including through his human rights work;

– Urging them to disclose, pending his release, his exact whereabouts and information about the stage of his trial, and ensure that he is held in an official place of detention and he is not subjected to torture and other ill-treatment;

– Urging them to ensure he is granted immediate and regular access to a lawyer, his family, and any medical care he may require.

The Urgent Action was sent round with last month's newsletter but is attached again. PLEASE take action as soon as possible if you haven't already.

### PALESTINE

#### Amnesty calls for arms embargo on Israel

There has been extensive coverage in the press about the recent unrest in Gaza, part of the OPT (Occupied Palestinian Territories). These protests are part of the 'Great March of Return', through which Palestinians peacefully request to go back to their pre-1948 lands and homes, from which they were expelled in 1948.

The protests are planned to end on 15<sup>th</sup> May 18., which coincides with the anniversary of the 'Nakba' (catastrophe), the mass eviction.

Amnesty has condemned the violence adopted by the Israeli forces towards protesters. Since the start of the protest on 30th March 18, according to Amnesty, 35 Palestinians have been killed and more than 5,500 people have been injured, with some of the injuries being life changing.

Research from Amnesty shows that the Israeli armed forces are "carrying out a murderous assault against protesting Palestinians ... who pose no imminent threat to them".

Amnesty has also renewed its calls on "governments worldwide to impose a comprehensive arms embargo" towards Israeli. According to Amnesty, the USA is the largest supplier of military equipment to Israel (with \$38 billion in military aid agreed for the next 10 years). However, also the UK, Germany, France and Italy have trade agreements in place with Israel.

## SYRIA

### The increasing challenge of doing research in Syria

In April 18 Amnesty has attended a meeting in Brussels, organised by the EU, called "Syria: The Road Towards Accountability". During his speech, Lynn Maalouf, the Middle East Research Director at Amnesty International, explained that carrying out research in Syria has become increasingly difficult. When the protests started in Damascus, Amnesty researchers witnessed them first-hand.



As the conflict deepened, their access to opposition-held areas decreased due to security reasons. Access to government-controlled areas was never an option, because the Syrian government has denied it to them repeatedly. To overcome the lack of access, Amnesty collected first-hand testimonies from people on the ground or in diaspora, as well as images, videos and satellite imagery, which were extensively examined to verify authenticity, and also obtained analysis from medical and weapons experts.

A new aspect, however, has come to the fore: people on the ground have every reason to fear retaliation for speaking out. Lynn Maalouf stated: "never before has it been as limpid that the main victor in this conflict today is widespread fear and disillusionment of the survivors".



## Women's Rights

Noura Hussein was 16 years-old when she was forced into marriage. Her father and new husband signed a marriage contract, but she wanted to finish her education and train as a teacher. When her family insisted that she marry Hammad Hussein, she ran away to her aunt's house.

Three years later, when she finished school in April 2017, she was tricked into returning home by her family. They handed her over to her husband, forcing her to move into his home.

The first time Noura's new husband raped her, he got his two brothers and a male cousin to pin her down while he did it. The next day he tried to rape her again, but she defended herself. In the ensuing struggle, Hammad sustained fatal knife wounds.

Noura went to her family and told them what had happened, her father took her to the police station and her family have disowned her. The police charged Noura with murder.

### Sentenced to death

At her trial, the judge applied an outdated law which does not recognise marital rape. A medical examination report from the fight with Hammad indicated she'd sustained several injuries,

including a bite and scratches. Noura was charged with intentional murder, though she was defending herself from her rapist. Now, at just 19 years-old, she has been sentenced to death.

### 'A Cambodian Spring' film screening – June 4th

'A Cambodian Spring' charts the lives of three Cambodian activists over the course of six tumultuous years. You can see the film trailer here

The three central characters are a fearless Buddhist monk and two bold female leaders who rally neighbours to oppose land-grabbing politicians and businesses, but at considerable cost to their own personal lives. Through his 'engaged Buddhism' as a filmmaker activist, the Buddhist monk is defending the rights of his fellow Cambodian's against a corrupt and violent government. He is faced with the corruption of his own religious leaders and must walk a difficult path between enlightenment and activism.

One of the female participants from the film is currently in jail in Cambodia for standing up for her community, and we are using the film as an advocacy tool to raise awareness about her case and to petition for her release. She is also the focus of the global Amnesty International campaign Stand up for the Brave <https://www.amnesty.org/en/get-involved/brave/?viewCampaign=69135>

The film has been showing at major international film festivals around the world and won several prestigious awards. It will be released in cinemas on the 18th of May across the UK and will be shown at the Odeon Great Northern in Manchester on 4<sup>th</sup> June. See <https://www.ourscreen.com/screening/46433>
