#### Supporting Transgender Rights in Finland.



We were delighted to welcome **Richard Kotter** to the meeting. He spoke about the troubling case of **Sakris Kupila** who was a teenager when he realised his birth gender didn't express who he is. Sakris has faced abuse, harassment and threats in Finland because of his public campaign to get the law around transgender issues changed, forcing him to give up his studies as a medical student. In Finland, to have his gender legally recognised, he is required to be forcibly sterilized. Transgender people face intimidation and threats in many countries, but the law was successfully changed in Norway so that

forced sterilization is no longer required and the same is true in France. In the UK the government is consulting in a change in the law that will make gender transfer easier. Over 350,000 people have joined the Amnesty campaign in support of Sakris and as a result, he is now safer and has been able to resume his studies. The law remains oppressive in Finland for transgender people, but Amnesty is hopeful the international campaign will promote progressive change.

#### **Good News:**



Liu Xia, the widow of Chinese dissident Liu Xiaobo was unexpectedly released in early July around the anniversary of her husband's death and allowed to travel to Germany. Liu Xia had spent nearly eight years under house arrest in Beijing, without charge after her husband was awarded the Nobel peace prize in absentia. He was jailed in 2009 for his part in writing a political manifesto, Charter 08, calling for peaceful political reform and the end of one-party rule. Liu, who we were proud to have as our Prisoner Action File, died in

2017 of liver cancer after being denied permission to leave the country for medical treatment. Liu Xia herself was never charged with any crime but she was restricted to her Beijing apartment, where she was kept virtually incommunicado and under heavy surveillance. She battled severe depression and threatened to kill herself earlier this year, so news of her surprise release was greeted with joy by friends and activists.

### **Supporting the BRAVE:**



As part of Amnesty's **BRAVE Campaign**, we wrote to our MPs calling for the increased recognition and protection of Human Rights Defenders (HRD's) worldwide. This campaign is in recognition of the shocking increase in attacks, intimidation and killings of those on the frontline defending Human Rights. 2017 was the deadliest year yet with over 300 HRD's killed according to the organisation Frontline Defenders. Amnesty considers this to be a global crisis and believe the UK Government must respond with renewed efforts to ensure HRDs all over

the world receive support consistently from the UK by offering strong and effective Ministerial leadership
