Right now, children and their parents are still being thrown into cages in overcrowded detention centres at the US border. Go to the AIUK website home page www.amnesty.org.uk and follow the links.

Round up of June and July group news

At our July meeting, Cherry gave us a very interesting talk on some of the major human rights issues in **India**, which include the treatment of indigenous ethnic groups and caste discrimination; corporate accountability and corruption; treatment of women and girls including violence and sexual harassment; communal and ethnic violence including abuses by armed groups and government forces. These issues are highlighted by three campaigns supported by Amnesty India, which may soon be adopted as casefiles by AIUK:

 In Manipur (NE India) the Extrajudicial Execution Victim Families Association Manipur (EEVFAM) is led by Salima Memcha, whose husband was killed in 2010. They are documenting many such executions and seeking justice for families through the courts, but as a result have been subjected to harassment and threats of violence.



- In Chhattisghar (central India) Pavitri Manjhi, activist and Village Head, is seeking justice for Adivasi families forced to give up their land for development of a coal fired power station. She also has been subjected to intimidation and threats, which the local police refuse to investigate.
- In Uttar Pradesh (north/central India) Chandrashekhar Azad, campaigner for the rights and education of Dalit people (the lowest caste), remains in jail without charge.

Summer Days Out - a report by Jenny Gateau

After weeks of preparation, Saturday 16 June saw a minibus full of fourteen Syrian friends from Taunton arriving in Minehead promptly at 1030. Out spilled eight excited children aged from 6 to 14, and six adults, laden with picnic bags. Five volunteers from Minehead and District Refugee Support Group welcomed them all warmly with hugs



and handshakes, and then into the Beach Hotel for a complimentary coffee from the kind staff, and a slice of the splendid cake baked by Audrey and Clive, of St Michae'ls Alcombe, duly iced in pink and white and saying 'Eid Moubarek' - Blessings for Eid.

The day turned out to be one of laughter and smiles. On the beach, the smaller children built a sand castle village, while the older ones set up a splendid and often hilarious cricket match. There was much laughter as rules were ignored (the dads) and wicket keeping hopeless (me). Later they all went off to paddle, despite the lack of sunshine, and by 1 pm everyone was ready for the picnic of both Syrian and English food. There were so many delicious items on the menu, it took us at least an hour to share it all out. In the afternoon the Big Wheel generated squeals of delight as nearly everyone had a ride, thanks to the generosity and empathy of the lady in the kiosk. Then it was time for more beach games, races and writing our names in the sand - simple pleasures but all that space to play on was clearly a real treat. Then we were off to Alison and Roy's in Roadwater for a delicious cream tea in their calm and peaceful home – just what we needed after all the excitement and activity. The children each had a small gift and a book to take home. They all climbed back on the minibus full of thanks and goodbyes and home-baked scones, leaving behind some Syrian biscuits and many happy memories.

Four more families are due to come on 18 August and in September (the July date had to be postponed). If you can help, phone me (Jenny) on 01643 708471. Another family will enjoy a little August holiday in Porlock, thanks to an Amnesty member there. Campaigns news

I Welcome Refugees [Jill Walmsley]: President Trump backtracked after global outrage over the inhumane separation of children from their parents at the US/Mexican border. But we have no evidence that families have been reunited. His immigration policy criminalises refugees. See action overleaf. We are circulating a petition, which can also be signed online, to our Home Secretary asking that the restrictive rules keeping refugee families apart be changed, family members allowed to join those who have found safety in the UK, and legal aid reintroduced for family reunion cases. The second reading of the bill was passed in March - this is the next step. We shall have the petition at Roadwater Fete.

Ethiopia: more positive news [Cherry Bird]. There have been some really positive developments in the few months since the new Prime Minister Abiy Ahmed took office. Not only have both Eskinder Nega and Andy Tsege been released, along with a number of other political prisoners, but the PM has brought an end to an armed and seemingly intractable conflict with neighbouring Eritrea that has lasted over 20 years. By unilaterally renouncing economic preconditions insisted upon by previous Ethiopian governments he has brought the veteran authoritarian leader of Eritrea to the negotiating table. Reciprocal visits have taken place, diplomatic relations have been restored and it was reported that 'previously unthinkable concessions are being tossed around by both sides'. A new broom indeed!

Nepal: *[Cherry Bird]* Of current concern is lack of justice for women and girls who were sexually abused during the 1996-2006 armed conflict. Their pain and trauma and the continuing stigma has blighted their lives, but when the government formulated an interim compensation policy in 2009 it failed to categorise them as conflict victims, thus excluding them from any compensation. The current process for filing complaints with the Truth and Reconciliation Commission is complex and difficult. Child marriage continues to be an issue, with 37% of girls married under the legal age of 18.
