

Speakers

Felix Jakens – 20 Years of the Human Rights Act Plenary

Felix is the head of campaigns and individuals at risk at Amnesty UK, overseeing the strategy and delivery of our priority campaigning projects. His previous work involved campaigning and advocacy on international development issues, primarily on access to health, education and micro finance in low income settings.



Tom Davies – I Welcome Workshop

Tom is a Priority Campaign Manager for Amnesty International UK (AIUK) and is currently leading our I Welcome Refugees campaign, which calls for a better international response to the global refugee crisis. He has a background in international development and has worked for AIUK for more than 10 years. In this time, he has led campaigns on issues ranging from torture, freedom of expression in Zimbabwe to refugee and asylum rights in the UK. He was until recently a member of the UK Foreign Secretary's Advisory Group on Torture Prevention.



Naomi Westland – I Welcome Workshop

Naomi Westland is Football Welcomes Manager at Amnesty International UK, working with football clubs across the UK to develop their work with refugees and people seeking asylum, whilst also coordinating the Football Welcomes weekend in April. Football Welcomes comes under the I Welcome campaign and aims to contribute to creating communities more welcoming to refugees and asylum seekers.



Jon Cornejo – Israel/Palestine Workshop

Jon is our Crisis & Tactical Campaigner; his role is to develop campaigns against grave human rights abuses at times of crisis and conflict and identify tactical opportunities for campaigning impact. He was a student union activist in a previous life, is an LGBTI rights campaigner, and is a photographer.



Shaimaa Hassan – Israel/Palestine Workshop

Shaimaa is an Amnesty Speaker and Human Rights Trainer. She has a lot of experience delivering sessions on human rights subjects. She has a master's degree in Refugee Studies and she is the founder of Women's Action Against Violent Extremism - WAVE, a human rights charity.



Lydia Parker – Toxic Twitter Workshop

Lydia Parker is a Campaigner focussing on Human Rights in the UK at Amnesty International UK. She leads on the Toxic Twitter campaign in the UK, working with women and feminist organisations from across the sector.



Azmina Dhrodia – Toxic Twitter Workshop

Azmina Dhrodia is a Researcher on Technology and Human Rights at the Amnesty International Secretariat in London. She authored, #ToxicTwitter: Violence and abuse against women online, a report on the human rights impact of online abuse against women on Twitter, which includes interviews with female politicians, journalists, bloggers and activists in the UK and USA.



Ellie Kennedy – With Great Power Comes Great Responsibility Workshop

Ellie manages AIUK's Urgent Action Network and leads the UA Plus Programme, mobilising activists and delivering strategic campaigning in urgent individuals at risk cases.



Eilidh Macpherson – With Great Power Comes Great Responsibility Workshop

Eilidh manages AIUK's Individuals at Risk team, which includes campaigning on urgent actions, and long-term casework. Eilidh also leads the delivery of the annual Write for Rights campaign.



Richard Glynn – Funding Change Workshop

Richard has worked at Amnesty International UK since 2011 in various roles. He is responsible for supporting the fundraising activities of all Amnesty activist groups including student groups. A big focus for this year and next is strengthening Amnesty International UK's relationship with RAG societies to give Amnesty a bigger presence on campus.



Grainne Teggart – Abortion Rights Plenary

Grainne Teggart is the Northern Ireland Campaigns Manager at Amnesty UK, where she manages our strategic litigation and advocacy across a range of issues including abortion reform. 
Hodan Yusuf – Check Your Privilege, Use Your Power Workshop

Introducing reserved spaces on the Student Action Network Committee

This conference resolves to call on the Board of Amnesty International UK Section to add the following to the Amnesty Student Action Network terms of reference;

- There are 4 reserved seats on the Student Action Network Committee, 1 for each of the UK nations; England, Wales, Northern Ireland and Scotland.
- Students are eligible to run for the reserved seat of the nation in which their University is based, as well as one of the 4 unreserved seats. They can run for either both or only one of these seats.
- If, at the close of nominations, there have been no nominations for a reserved seat that seat will become unreserved.
- All affiliated student groups can vote for all reserved and unreserved positions and candidates.
- All members of the Student Action Network Committee represent all students within the network regardless of which seat they occupy.
