Crisis and Tactical

MYANMAR

Here is a summary of what has been happening throughout Sep and Oct 18:

 $ightarrow 3^{rd}$ Sep: Two Reuters journalists sentenced to 7 years in jail for breaching Myanmar's Official Secrets Act. The two journalists were investigating the atrocities committed by Myanmar's Security Forces.

- →6th Sep: The ICC confirms that it can prosecute Myanmar for alleged crimes against humanity. Myanmar is not a signatory to the ICC, but ICC's prosecutors state that "even though the allegedly coercive acts that forced the Rohingya to flee took place in Myanmar, the crime would not have been completed until the refugees entered Bangladesh, which is a part to the Rome statue that governs the court". (The Guardian on 6th Sep 2018)
- →13th Sep: Aung San Suu Kyi defends Myanmar's decision to arrest the two journalists, stating that decision has 'nothing to do with freedom of expression' This statement, delivered at the World Economic Forum has been condemned by Amnesty International.
- $ightharpoonup 15^{th}$ Sep: Amnesty UK calls on Jeremy Hunt to show the UK's commitment to human rights during is planned visit to Myanmar. In Amnesty's press release, Kate Allen, states that the UK must back the UN's call to refer the situation in Myanmar to the ICC (International Criminal Court).
- Amnesty International and Human Rights
 Watch to the UN Human Rights Council stating that unless an accountability mechanism is put in place, the crimes committed by Myanmar's Security forces towards the Rohingya are going to be repeated. Both organisations have called for an independent, impartial mechanism to be established to investigate the terrific crimes.
- \rightarrow 19th Sep: The chief prosecutor at ICC announces she is launching a preliminary investigation into the deportation of the Rohingyas to Bangladesh.

- →20th Sep Amnesty calls on Japan to join in the call for justice in Myanmar. According to Amnesty, Japan has a "significant role in Myanmar's affairs". The two countries have strong military co-operation and Japan has invested substantial capitals in Myanmar (in Jan 18 Japan donated US\$ 20 million in humanitarian aid and assistance for Rakhine State). Japan has never condemned the actions of Myanmar's military forces. On the contrary, they have kept carrying on diplomatic meetings.
- $ightharpoonup 25^{th}$ Sep Amnesty make their call for accountability in Myanmar visible! A lorry with images of General Min Aung Hlaing, the Commander-in-chief of Myanmar military drives through New York city. and this image has been shared on Facebook and Twitter.



- →27th Sep The UN's Human Rights Council passes a resolution calling for an accountability mechanism to collect and preserve evidence of human rights crimes in Myanmar;
- →10th Oct Three more journalists are jailed for writing an article criticising financial management by the Yangon Regional Government. If charges and convicted, they will each be spending two years in prison. Amnesty has issued a press release calling for their release.
- →12th Oct Amnesty release a public statement calling on the Myanmar's authorities to release human rights lawyer Khin Khin Kyaw accused of 'contempt of court'. Amnesty believes Khin Khin Kyaw has been targeted by Myanmar authorities for her role as a defence lawyer for 58 student protesters and activists who were detained in March 2018 during a violent police crackdown on peaceful protests in Letpadan, Bago Region.

Report from Amnesty: "We will destroy everything" Back in June, after nine months of extensive research, Amnesty produced a new report, which names 13 military officials involved in the atrocities committed against the Rohingya community.

in the atrocities committed against the Rohingya community. Senior General Min Aung Hlaing, commander in-chief of the armed forces, is one of the people named. Amnesty has called on the UN Security Council to refer the situation in Myanmar to the International Criminal Court. This report can be sent to you by e-mail, if you wish so. Let us know.



PALESTINE

Ban Israeli Settlement Goods - Progress in Ireland

On 11th July the Upper House of the Irish parliament voted in favour of the Control of Economic Activity (Occupied Territories) Bill, which aims at banning the import of products produced in the



OPTs (Occupied Palestinian Territories). The Bill will now go through the committee stage.

Destruction of Bedouin village approved

On 5th Sep 18 the Israeli Supreme Court approved the demolition of the Bedouin village of Khan al-Ahmar, in the West Bank (part of the OPT). The destruction will allow more space for Israeli settlements, which carry on despite the international outcries. To prevent the local school from being demolished, the Palestinian Ministry of Education set the reopening of the school after the summer holidays two months earlier than planned. However, this did not persuade the Israeli authorities. Khan al-Ahmar, established more than 60 years ago, is surrounded by Israeli settlements, a settlement industrial area and an Israeli army base.

SYRIA

Idlib - De-militarisation needed to protect civilians

The 15th October marked the deadline for the set-up of a demilitarised zone in Idlib, the last remaining stronghold of the opposition to the Syrian government. This de-militarisation would give protection to civilians living in the area.

Amnesty international has called on Turkey, Russia and Iran to prevent a catastrophe of civilian lives and ensure the set-up of this area.

Back in Aug 18, eleven NGOs including Amnesty International, Rethink Rebuild and Human Rights Watch issued an open letter addressed to the Astana Working Group* on Syria, which planned its third meeting early Sep 18. In their letter, the organisations invited the working group to include in their discussion how to address the question of "the fate and whereabouts of those the [Syrian] Government continues to arbitrarily detain and those it has forcibly disappeared, and those who have died in detention".

*The Astana Working Group includes representatives of foreign ministries of Turkey, Russia and Iran and meet to discuss the Syria conflict.

Women's Rights

Support for women seeking abortions during antiabortion vigil outside clinic

People may remember that some of us helped to provide a prochoice presence to support women seeking abortions at the Marie Stopes International clinic in Fallowfield in spring this year. The anti-abortion campaigners are demonstrating again and will be doing so until early November.

Mary Gibbs, our Women's Rights lead, believes that this is at MSI in Fallowfield again and that it will be taking place over slots from early morning till lunchtime from Tuesdays through to Saturdays. She knows that Sister Supporter are organising it again, and are asking for volunteers. They are also keen to get a PSPO (Public Space Protection Order) put in place, after the refusal by the government to allow the implementation of nationwide buffer zones outside abortion clinics earlier last month, so they want any reports of the anti-abortion campaigners' actions which can be provided.

Please email her if you are interested in helping to provide a supportive presence for women coming to the clinic, and she will provide more information, including how to sign up for shifts.

Consultation on the Gender Recognition Act

The government has launched a consultation on the Gender Recognition Act (GRA). This was enacted in 2004, and allows (some) trans people to change their legal gender on birth certificates. For trans people, having their gender legally recognised is critical to be able to live freely, authentically and openly. Trans is an umbrella term which includes non-binary and gender variant people, although not all of them would identify as trans.

There are several layers of bureaucracy and barriers within the current process; the process is also costly and so inaccessible to some because of this.

Amnesty's position is that:

- A new GRA must be based on human rights standards
- Children and young people should have access to legal gender recognition
- Non-binary people need legal recognition
