Amnesty action: campaigns & letter-writing

Action: Write for Rights campaign, 1 November - 31 December

As you know, our annual letter-writing campaign launched on 1 November. As always, your letters and cards will have a huge impact on the lives of this year's cases. For some people, speaking out for freedom, justice and equality means putting themselves at risk – of humiliation, imprisonment, violence, even death. That's why we run Write For Rights. Every year, we ask people like you all over the world to send messages of hope and support to people under threat.

As part of launching this year's Write for Rights campaign and to mark the Annual Human Rights Day (10 Dec), Amnesty will be hosting a launch event in parliament to introduce the campaign and related cases to Members of Parliament. Attending is a great way for MPs to be introduced not only to the cases but the wider campaign and issues and threats facing Human Rights Defenders (HRD) around the world but also to increase the understanding of the role HRDs play in achieving social change and upholding and furthering human rights for all.

Action: Egypt: 80-year-old Egyptian's death sentence upheld

On 24 September 2018, the Court of Cassation upheld the death sentence of Sheikh Abdel Rehim Abdel Halim Gabreel – an 80-year-old Quran tutor – in one of Egypt's largest mass trials since 2011.

Egypt's Court of Cassation, which issues final rulings that cannot be appealed, upheld the death sentences of 20 Egyptians, including Sheikh Abdel Rehim Abdel Halim Gabreel. The 20 were convicted of killing 13 policemen during the 2013 attack on a police station in the Giza suburb of Kerdasa. The case relates to what is commonly known as "the Kerdasa Massacre". On 26 September 2013, Sheikh Abdel Rehim Gabreel was arrested from a mosque. After six months of investigations without a lawyer, he was put on trial. On 2 February 2015, he was sentenced to death.

What you can do:

Please write before 24 December:

- Urging the Egyptian President to grant Sheikh Abdel Halim Gabreel a presidential pardon to halt his execution.
- Urging the Egyptian authorities to halt any planned executions, to commute all existing death sentences and immediately establish an official moratorium on executions, with a view to abolishing the death penalty;
- Calling on them to ensure that Sheikh Abdel Halim Gabreel has adequate and regular access to qualified health professionals
 providing health care, including access to prescribed medication, in compliance with medical ethics, including the principles of
 confidentiality.
