### United Arab Emirates

#### BIRTHDAY PARTY FOR AHMED MANSOOR AND MOHAMMED AL-ROKEN

The Manchester group of Amnesty International is working on behalf of human rights blogger Ahmed Mansoor and the human rights lawyer Mohammed al-Roken, who are both imprisoned in the UAE because they have spoken critically about the UAE government. On 3<sup>rd</sup> **November** we held a public celebration of Ahmed and Mohammed's birthdays in St Peter's Square to mark another year in prison. We collected messages of support on a giant card and more than 130 signatures for a petition to the UAE. We experienced fantastic support from councillors and MPs who came along or showed their solidarity if they were unable to attend. ## Crisis and Tactical

### MYANMAR

#### Rohingya to be repatriated to Rakhine State

On 30<sup>th</sup> October, the governments of Myanmar and Bangladesh announced their decision to repatriate some of the 720,000 Rohingya people, who fled to Bangladesh in search for safety against the violence by the hand of the Myanmar military, which includes rape and brutal killings.

According to the agreement, the UNHCR (United Nations High Commissioner for Refugees) must 'vet' families before their repatriation. However, according to Amnesty, refugees were not consulted. The announcement caused panic among them, leading to some of them trying to escape from the refugee camps, go into hiding or even attempting suicide.

Nicholas Bequelin, Amnesty International's Regional Director for Southeast Asia, said: *"These women, men and children would be sent back into the Myanmar military's grasp with no protection guarantees, to live alongside those who torched their homes and whose bullets they fled. 'A population traumatised by Myanmar's deadly campaign is now terrified of what their future holds – and when. Returns at this time cannot be safe or dignified and would constitute a violation of Bangladesh's obligations under international law."*

Amnesty has called on the governments of Bangladesh and Myanmar to halt their plan.



#### 50 organisations call on the immediate release of two Reuters journalists

On 5th November more than 50 human rights organisations issued an open letter addressed to Aung San Suu Kyi, calling on her to intervene for the release of 2 Reuters journalists, arrested in September for investigating military operations in northern Rakhine State. The journalists were specifically looking into summarily executions of ten Rohingya men and boys in the village of Inn Din at the hands of Myanmar military forces. Aung San Suu Kyi publicly supported the convictions, claiming that they were made according to the law.

The 50 organisations, which include Amnesty, Human Rights Watch, International Press Institute (IPI), PEN Myanmar and Reporters Without Borders (RSF) consider these arrests as attempts to stem freedom of expression. According to the organisations, the law applied for these convictions is broadly worded and has been used conveniently.

#### Amnesty strips Aung San Suu Kyi of the 'Ambassador of Conscience' award!

On 12TH November, Amnesty announced that a letter had been sent to Aung San Suu Kyi stripping her of the 'Ambassador of



conscience' award given to her in 2009. This comes following Aung San Suu Kyi's failure to make a clear statement condemning the treatment of the Rohingya people in Myanmar.

In his letter, Kumi Naidoo, Amnesty's new Secretary General, wrote: *"As an Amnesty International Ambassador of Conscience, our expectation was that you would continue to use your moral authority to speak out against injustice wherever you saw it, not least within Myanmar itself. Today, we are profoundly dismayed that you no longer represent a symbol of hope, courage, and the undying defence of human rights. Amnesty International cannot justify your continued status as a recipient of the Ambassador of Conscience award and so with great sadness we are hereby withdrawing it from you."*

## PALESTINE

### **Destruction of village Khan al-Ahmar postponed**

In October, the Israeli authorities ordered the destruction of the Bedouin village Khan al Ahmar, in the West Bank. Amnesty defined this decision as "heartless", "discriminatory" and "illegal". The inhabitants were offered two other locations as alternatives: one near a former municipal garbage dump and one near a sewage plant.



An update from Palestine Solidarity Campaign, dated 19th Oct 18, reads: *"Israeli bulldozers stormed the Palestinian village of Khan al-Ahmar earlier this week accompanied by soldiers and police. Activists protesting against the imminent demolition of the community were violently removed, and several arrested."*

*Meanwhile, a nearby illegal Israeli settlement flooded Khan al-Ahmar with waste water and sewage in an attempt to drive out residents and activists. This has not worked, and the week has seen global condemnation of Israel's actions - including from UK Prime Minister Theresa May. Maintaining international pressure is essential".*

A further update issued on 23rd Oct 18, through the petition site Change.org, states that protesters against the destruction of this village were tasered by the Israeli army. However, the international pressure has brought the Israeli government to postpone the destruction



## **Tension in Gaza escalates**

During November, the tension between Israeli and Palestinian armed forces in Gaza escalated, causing civilian deaths. Amnesty called on both parties to stop the violence, since the situation for civilians in Gaza is already dire. Gaza has about 2 million residents, who live in poverty and constant deprivation of basic rights, like access to water and electricity. A ceasefire was agreed by the parties on 13th Nov.

## SYRIA

### **French government issues arrest warrants for 3 top Syrian officials**

On 5th November it was announced that French prosecutors issued arrest warrants for: Ali Mamlouk, Director of the National Security Bureau, Jamil Hassan, Head of Airforce Intelligence (already subject of an arrest warrant by the German authorities) and Abdel Salam Mahmoud, Head of the Airforce Intelligence Investigative branch at Mezzeh military airport. The charges are of torture, enforced disappearances, crimes against humanity and war crimes.



Since the start of the conflict, Amnesty has been calling on international leaders to support a UN Security Council referral of the situation in Syria to the ICC (International Criminal Court) and to co-operate with the IIIM (International, Impartial and Independent Mechanism) set up by the UN for the investigation and prosecution of crimes committed in Syria, under international law.

## YEMEN

### New petition

The conflict in Yemen, which started in 2015, has had an enormous impact on civilians: at least 16,000 have been killed, thousands have been injured and many of those who survived are facing starvation. The UN has defined the current situation in Yemen as the 'world's worst humanitarian crisis'.

The conflict is being fought between Yemen's government forces and its opponents, the Huthis. Yemen's government is being supported by a military coalition led by Saudi Arabia, which has bombed residential streets, hospitals, schools and mosques.

Amnesty reported that on 12th November an attack reportedly carried out by the Saudi Arabia/UAE-led military coalition nearly hit al-Thawra hospital, the largest in the Hodeidah region. Some medical staff and many patients, still in their robes and in very poor health conditions, fled the hospital in terror.

Amnesty has collected evidence that the Saudi Arabia-led military coalition has been using UK-made cluster munitions, which are banned under an international treaty.

## Europe (inc Turkey)

There are currently two actions on Amnesty websites concerning Turkey:

### STOP Erdoğan's attack on human rights!

Since a violent coup attempt in 2016 the Turkish government has unleashed a crackdown on human rights defenders, journalists, lawyers, academics and many others seen as opponents. Many of the abusive emergency decrees put into place after the coup attempt have now been made permanent. These include extraordinary powers to arbitrarily dismiss judges and other public officials, restrict people's travel within Turkey, ban public assemblies, and empower police to hold suspects for extended periods without charge.

Those on the frontline of defending human rights have faced great personal cost, but there is also hope. This summer defiant LGBTI activists and allies took to the streets in Istanbul for Pride, despite a citywide ban. In August, Amnesty Turkey's Taner Kilic was released on bail after spending over 14 months imprisoned simply for doing his job as a refugee rights lawyer.

As Turkey faces both political and economic uncertainty, a strong civil society, a free press and an independent judiciary is more important than ever. President's government must not be allowed to continue this destruction of human rights. Sign the petition to demand that President Erdoğan take steps to end human rights abuses in the name of 'national security' in Turkey.

### STOP silencing the Saturday Mothers

In August, police descended on a peaceful protest in Istanbul. They shot tear gas, water cannons and plastic bullets. The protestors – a group of mainly women, some in their 80s – were forced to flee.



The group are the 'Saturday Mothers', who have been holding a regular vigil to protest the disappearance of their relatives for over 20 years. That morning marked their 700th vigil. The Turkish authorities have allowed this vigil to happen for years. The ban is yet more evidence of a worrying crackdown on human rights in Turkey.
