# Persecuted for youth work

Geraldine Chacón always wanted to defend other people. Aged nine she dreamed of being a lawyer. At 14 she stood for her local youth government. And at university she started a network of Amnesty activists pushing for change. As her mother says, 'Any injustice she saw, she fought against.'

This passion inspired her to work for the Community Ambassadors Foundation, an organisation working with young people in some of the poorest areas of the capital, Caracas.

But on 1 February 2018, the 24-year-old was arrested at her home in Caracas by armed officers. It was part of a big crackdown on critics of the government and human rights activists. Geraldine spent four months in prison in appalling conditions. She could not even get a drink of water when she needed it.

She was released on 1 June but her case remains open. This means she cannot leave the country and could be re-arrested at any time.

# KYRGYZSTAN GULZAR DUISHENOVA

# Campaigning for the rights of disabled people

Gulzar Duishenova lost the movement in her legs after a car accident in 2002. The next year her husband died, leaving her as the sole carer for her two young children. Later Gulzar met other people living with disabilities in the capital, Bishkek, and realised they faced similar problems. Workplaces and public transport are not adapted for wheelchairs, so it is hard to find a job and you have to rely on other people to lift you on to buses.

Gulzar campaigns for people with disabilities in Kyrgyzstan to be able to live with dignity and move around freely. She meets officials, organises training for bus drivers, and campaigns on social media. But she still faces barriers and daily discrimination in a society where women are not meant to speak out and people with disabilities are seen as 'invalids' with an incurable disease.

# **SEYI AKIWOWO**

#### Bombarded with online abuse

Seyi used to be a local councillor in London. After a video of her speaking at the European Parliament spread online, she received many cruel and insulting messages. She reported more than 75 messages – most of them were sexist and racist – to social media companies, including Twitter. But Twitter did nothing about it and did not even reply to her.

Frustrated, Seyi decided to speak out about the abuse in the media, and eventually Twitter stopped the accounts of some of the people targeting her. She went on to launch Glitch, an organisation that aims to end online abuse.

Online abuse of women and girls is common in the UK and can stop them saying what they want to say. Earlier this year, Amnesty and a polling company did a survey about this. One in five women told us they had suffered abuse or bullying on social media and companies like Twitter were not doing enough to deal with it.
