Protecting individuals at risk, and securing justice for those whose rights have been abused or denied, remains at the heart of our work.

Responding to human rights crises, helping to protect civilians and ensuring that perpetrators of mass human rights violations are held to account.

Supporting human rights defenders around the world, to make sure that they can continue to challenge sexism and racism, campaign for justice, condemn human rights violations and hold leaders to account.

Protecting the rights of refugees, working with the Amnesty movement in a global campaign to ensure that people fleeing conflict and persecution receive the protection they need.

Ensuring that human rights are protected and promoted in the UK, creating a more positive understanding of human rights and defending the Human Rights Act.

Ensuring that human rights education in the UK is available to all children, young people and adults, so that everyone knows, values and can claim their rights.

LEAVING A GIFT IN YOUR WILL

Making a Will and leaving a gift in your Will is easier than you may think and is one of the best ways you can help us to change the future for the better. **Any gift, whatever its size, really is priceless to us** – gifts left in Wills by our supporters now pay for around one in ten of our campaigns.

Making a Will is one of the most important things you can do to ensure your wishes are respected. Without a Will, it's the legal system which decides who gets what from your estate.

The money and assets that make up your estate may be subject to Inheritance Tax. Gifts to charity are exempt from this tax, and could reduce the amount your family would have to pay. Please see the loose sheet on Inheritance Tax at the back of this booklet, which also includes a handy guide to working out the value of your estate.

We always advise you to consult a solicitor when making your Will.

DIFFERENT WAYS TO LEAVE A GIFT IN YOUR WILL

A SHARE OF YOUR ESTATE (residuary gift)

Once you have taken care of your loved ones, the remainder of your estate is known as the residue, which you can choose to leave a share of to charity. Even a small percentage could make a huge difference to Amnesty in the future as it will not devalue over time.

A CASH GIFT (pecuniary gift)

This is when you leave an exact amount of money to us. Inflation will reduce the value of a pecuniary gift, so you can revise them from time to time according to your wishes.

A SPECIFIC GIFT

This is a named item rather than money, for example, a piece of art or shares. You must describe these items exactly and clearly state to whom you are leaving them.

A REVERSIONARY GIFT

A gift to someone for their lifetime, which after their death, goes to someone else. For example, you could leave a property to a relative, which after their death would be passed on to Amnesty International. Reversionary gifts can be quite complex, so it's best to consult your solicitor about them.

WORDING TO LEAVE A PERCENTAGE SHARE OF YOUR ESTATE

(residuary gift)

HOW TO CHANGE YOUR WILL

If you already have a Will, adding a gift to Amnesty International is straightforward. Ask your solicitor to draft an amendment, which is called a 'Codicil'. This is then kept with your Will and has legal status.

In the back of this booklet you'll find a Codicil form which can be added to an existing Will.

HOW YOUR LEGACY HAS IMPACT

Leaving a gift to Amnesty in your Will is one of the most valuable ways you can continue to empower human rights change around the world.

- **With your help, just 1% of a £50,000 estate could** help cover the cost of our school speakers programme, teaching young people about human rights and inspiring the next generation of human rights defenders.

- **A legacy from you of £5,000** could pay for media fellowships in developing countries for four journalists, enabling them to report and raise awareness of human rights violations.

- **Leaving a 10% share of a £300,000 estate** could enable us to conduct two human rights investigations in crisis countries with security equipment, satellite imagery and forensic support.

FREE WILLS SERVICE

Making a Will and keeping it up-to-date is the only way you can be sure your wishes will be respected. Without a Will, it's the legal system which decides who gets what from your estate.

To help you complete this important task, we offer a **Free Wills Service** in partnership with the **National Free Wills Network**. The scheme enables you to make or update your Will for free, using a local participating solicitor.

WRITE YOUR WILL FOR FREE IN 3 QUICK & EASY STEPS

STEP 1

Complete and return the form at the back of this booklet, or email legacy@amnesty.org.uk, to request a referral.

STEP 2

We will refer you to the National Free Wills Network, who will send you contact details for the six solicitors nearest to you..

STEP 3

Request an appointment with your chosen solicitor who will draw up your Will for free.

Most people who use the Free Wills Network do kindly choose to leave a gift to Amnesty in their Will. You don't have to but we hope you will consider it.

INHERITANCE TAX

It comes as a surprise to many people to discover they are liable for Inheritance Tax. But the value of your assets can quickly add up, particularly if you own your home.

A properly drawn up Will can reduce your Inheritance Tax liability. For example, leaving a gift to charity such as Amnesty International can lower the amount of Inheritance Tax payable on your estate.

So you can support Amnesty International and reduce the amount of tax your family or other beneficiaries will have to pay.

The current Inheritance Tax threshold is £325,000 and the rate is set at 40%.

EXAMPLE

Your estate is worth **£500,000** and your tax-free threshold is **£325,000**.

The Inheritance Tax charged will be **40%** of **£175,000** (**£500,000** minus **£325,000**).

From April 2012, Inheritance Tax legislation changed, meaning in some situations, **anyone leaving 10% or more of their taxable estate to charity may qualify for a reduced rate of Inheritance Tax** – 36% rather than 40%.

The threshold and the rates change from time to time, so we advise checking the current figures on the **www.gov.uk** website.

Your solicitor or financial advisor will be able to help you with these and other relevant issues, including how to keep your Inheritance Tax liability as low as possible.

YOUR ESTATE

CALCULATING THE VALUE OF YOUR ESTATE AND UNDERSTANDING INHERITANCE TAX

Many people put off making a Will, or don't specify a gift to charity, because they feel they don't have a lot to leave. However, it's often a surprise to find out just how much your assets add up to.

You can save time with your solicitor by working out your assets in advance. Simply fill in this checklist then deduct your total liabilities from your total assets to arrive at the approximate value of your estate.
