UAE case update

"The silent days of Christmas have been used to again silence prisoners of conscious in the UAE.

Four days before Christmas we received information that Nasser Bin Ghaith's health had deteriorated sharply and that he had started to loose his eyesight. Nasser Bin Ghaith has been on hunger strikes for various lengths of time over the past 75 days in protest at his jail sentence and prison conditions. On 29 March 2017, human rights defender and prominent academic Dr. Nasser bin Ghaith was sentenced to 10 years in prison under the Cybercrime Law and the 2014 Counter Terrorism Law for tweeting about human rights violations committed by the Egyptian authorities and for criticising the politicisation of the judiciary in UAE. https://www.amnesty.org/en/latest/news/2018/12/uae-fears-grow-for-health-of-unjustly-imprisoned-academic/

One day later, we were informed that the appeal of Ahmed Mansoor was set to be heard at the Federal Supreme Court in the UAE on Christmas Eve. The court hearing was rescheduled for the 30th December and, unfortunately, the Federal Supreme Court in the United Arab Emirates (UAE) upheld the conviction and the 10-year prison term for prominent Emirati human rights defender Ahmed Mansoor. Following this, the UN human rights office has called for his release.

Review of 2018

Apart from our first meeting of the year when Kate Allen, AIUK director, came up to talk to us and over 30 members came along to meet her, we have struggled with getting people to our regular meetings in 2018, exacerbated by changes in venue. However, we have still managed an eventful year and have generally been well supported when out and about. Here is a summary of our main activities.

Thanks to all who have helped us in our campaigning and fundraising over the last year.

UAE campaigning

We have continued to work on behalf of two human rights defenders currently imprisoned for speaking out for human rights – human rights lawyer Mohammed al-Roken and blogger Ahmed Mansoor.

We started the year by holding regular vigils outside the Town Hall before our group meetings to draw attention to their plight. These drew a lot of interest from passers by but, unfortunately, we had to stop doing these on a regular basis when Henrike changed her place of work.

In March, some of us attended the public meeting "Is Manchester living up to its radical past, and how do we continue to make positive progress" which focussed on the case of Ahmed Mansoor and was chaired by Nicholas McGeehan, an ex Human Rights Watch researcher and academic.



The meeting sparked a great discussion of how Manchester citizens can further support Ahmed Mansoor and led to a couple of signed letters on behalf of Ahmed Mansoor. In addition, the UAE subgroup also attended the film screening "The workers cup" where the case of Ahmed Mansoor was again raised and the links between Manchester and the UAE discussed.

At the begging of the autumn, we also started a regular letter writing rota to the UAE authorities and so far have sent some 37 letters on behalf of Mohammed al-Roken and Ahmed Mansoor



On **3rd November** we held a public celebration of Ahmed and Mohammed's birthdays in St Peter's Square to mark another year in prison. We collected messages of support on a giant card and more than 130 signatures for a petition to the UAE. We experienced fantastic support from councillors and MPs who came along or showed their solidarity and got a great article in Mancunian Matters.

Lastly, Henrike had a stall at the public meeting From Housing to Human Rights which looked at the partnership between Manchester City Council and Abu Dhabi at which Oscar Jenz, the AlUK UAE country coordinator gave a talk.

Brave Campaign

Our main contribution to the BRAVE campaign for Human Rights Defenders has been our work on the UAE. However, we ran a stall featuring the BRAVE campaign appeal cases at the Darwin Day event on February 12th at Manchester Conference Centre and we also had a letter on the Manchester Evening News viewpoints page drawing attention to the suffragette Spirit initiative.



Crisis and Tactical

This area of campaigning concerns countries such as Syria and Palestine.



In February we held a screening of the Oscar winning documentary 'The White Helmets' in conjunction with the Rethink Rebuild Syrian community Society. This was followed by a very moving Q&A session via Skype with the Director, Orland von Einsiedel, and a member of the Syrian Civil Defence (the White Helmets).

We also took part in a silent protest in Piccadilly Gardens against the relentless bombing of Eastern Ghouta, alongside Rethink Rebuild. During the protest, a recording of

bombing that took place the day before was being played.

In May, AIUK staff member Jonathan Cornejo came to talk to us about the 'Ban Israeli Settlement Goods' campaign which prepared us for a silent vigil the following month alongside the Quakers of Manchester, outside their building in the city centre. We also featured this campaign at our stall at the Didsbury Festival and the Whalley Range Peace and Justice Group Write for Rights event.




Refugee Campaign

Our main involvement in this aspect of Amnesty's campaigning was centred around Refugee week in June when a full theatre watched the Ice and Fire theatre company's production 'This is who I am' at HOME. This gave moving personal



accounts of LGBT refugee's experience of going through the UK asylum application process and was followed by a lively Q&A session featuring Moud Goba from Micro Rainbow International, Estelle Worthington

from Asylum Matters and our very own Sen Raj representing Amnesty International and the Amnesty UK's LGBTI Network.





We had a stall at Sparkle in the Park over the weekend of 7/8th July, an event to celebrate the trans community where we got 94 cards signed on behalf of Kupila Sakris in Finland and 101 signatures on a petition for Alejandra in Brazil and we raised the profile of Amnesty's work.

We had a great presence at the Manchester Pride Parade with some 35 supporters turning out to march with us under the strap line 'Love is a Human Right'.

Many thanks to Sen and Lil for masterminding it this year.









Trump Visit

A group of us, along with a couple from the Fylde Coast group, took part in the Manchester Against Trump demo during Trump's visit to the UK in July. Our three Statues of Liberty stood together against hate

Individuals at Risk

Every two months we held drop in letter writing sessions at the eighth Day café, writing letters on behalf of individuals at risk around the world – some 120 letters were written, and much cake was consumed.

We also took an active part in this year's Write for Rights campaign in the run up to the festive season. Between us we held stalls at Central Library, Birch Community Fair, Sunday Assembly in Hulme, St Clements Church, Chorlton and St Andrews Church Dearnley in the run up to Christmas and got 132 cards signed in total with an additional 28 appeal letters.



We also held a stall at the marvellous Write for Rights event run by the Whalley Range Peace and Justice group – we sold Christmas cards and garnered signatures for the Ban Israeli settlement goods campaign whilst the local community wrote some over 800 messages of support to the Write for Rights cases.

Other activities

The above is just a snap-shot from our main campaigns. We should also mention the talk by our member Necmettin on Turkey, attending the National conference in force, another successful Acoustic Amnesty, £173 raised at our city centre street collection
