- ✓ Call on Saudi Arabia to release Israa al-Ghomgham who faces execution for simply taking part in non-violent protests. Israa's home was raided in December 2015 and she's been imprisoned ever since, along with several others. Now she faces the death penalty for peacefully defending human rights. Go to the AIUK website www.amnesty.org.uk and find the action on the home page.
- ✓ Join us on Thursday 24 January for our event to mark Holocaust Memorial Day (HMD) 2019. Between 1200 and 1400 we are inviting the public to drop in to the Minehead Quaker Meeting House to reflect on the horrors of genocides around the world, to write a card, to see the display of HMD and AI materials and to light a candle. Round up of December and January group news

Our **Amnesty tree** was on display among 40 trees at the annual **Christmas Tree Festival** in Minehead. After the festival was over, our tree stayed in the Methodist Church until the end of December, so hopefully lots of people saw it. The theme this year was 'Celebrating the Seasons' so our tree included messages such as 'Defending human rights through the seasons' and 'Writing letters through the seasons'. It also carried photos of the women featured in the Write for Rights campaign.



Our third and final **Write for Rights** event for 2018 was on 14 December, when we hosted the weekly coffee morning in the Avenue Methodist Church and invited the public in to sign cards and letters. We chose five cases out of the Write for Rights booklet and collected about 55 signatures on each of the greetings/solidarity cards, and between 35 and 55 on each of the letters to the



relevant authorities. In addition, 17 action cards were signed for Nonhle Mbuthuma (South Africa) and Geraldine Chacon (Venezuela). Our steady stream of visitors said they enjoyed the welcoming and relaxed atmosphere in the church, and people took their time to read the case sheets and then stop for coffee and cake. We were particularly pleased that the Mayor of Minehead, Cllr Norman Hercock, was able to join us and sign all the cards and letters.

Campaign news

I WELCOME REFUGEES: *Jenny Gateau* reported that she attended a meeting of the Syrian Forum in Taunton on 11 January. More families have been settled in Taunton and Bridgwater and positive developments are taking place. The new families are keen to come on a day outing to Minehead, so no doubt Jenny will be looking for help once planning gets underway.

HOLOCAUST MEMORIAL DAY 2019: the theme this year is 'Torn from Home' which fits well with our refugee campaign. As you'll have seen overleaf, our group is marking the day by hosting a drop-in session where people are invited to come in to read about the genocides that continue to take place in the world, to reflect and write a card, to light a candle, and to find out more about Amnesty campaigns and also the work of the West Somerset Refugee Support Group. Please join us if you can on Thursday 24 January between 1200 and 1400 at the Quaker Meeting House. There will also be an exhibition in Minehead library. And as the actual day, 27 January, is on a Sunday this year, we hope that local churches might also mark the day in some way. If you are a church-goer, please tell them about it!

NEPAL: Cherry Bird reports. <u>Transitional justice</u>: Amnesty Nepal is concerned at the lack of progress towards achieving justice for victims of the 1996-2006 conflict. Political party leaders continue to wrangle over the future of the two transitional justice bodies formed in 2015 - Truth and Reconciliation Commission and Commission of Investigation on Enforced Disappeared Persons. Meanwhile, activists say there has been no investigation of the 63,000 complaints of human rights violations registered. <u>Migrant workers</u>: In another example of the lack of rights of migrant workers in the Gulf, 150 Nepali migrant workers are stranded in Abu Dhabi (UAE) after their employer laid them off seven months ago. Since then they have not been paid and the company refuses to renew their visas or provide them with air tickets home. For the last three months the company has also stopped providing them with food.

INDIA: Cherry Bird reports. Rohingya: Amnesty India is campaigning to stop the forcible return of Rohingya people to Myanmar, which is against international law. For example, on 4 January, the UN Refugee Agency (UNHCR) stated that a family of five detained Rohingya people sent back to Myanmar the previous day were asylum-seekers registered with UNHCR in India, and that Indian authorities had not responded to its requests for access to the detainees to determine whether they wanted to return to Myanmar. The Refugee Agency said it regretted India's decision to return the asylum-seekers to Myanmar, where conditions are not conducive for their return.

<u>Human Rights Day</u>: Numerous groups took part in events across India to mark Human Rights Day on 10 December. Amnesty India notes that the past year has seen an increasing pattern of demonising and criminalising organisations and individuals who raise their voices against human rights violations of the poorest and most marginalised communities in India. As well as the recent raid and freezing of accounts of organisations like Amnesty and Greenpeace, 10 eminent lawyers and human rights defenders have been arrested under draconian counter-terrorism laws. Other activists and journalists have been threatened and harassed for seeking state accountability.
