### Crisis and Tactical

#### YEMEN

**Talk on Yemen -Monday 11<sup>th</sup> Feb at 19.30 pm -Cross St. Chapel, Manchester, M2 1NL**

The war in Yemen has had devastating effects on Yemeni civilians, since its start in 2015. The UK has contributed to this, by selling weapons to a Saudi Arabia-led coalition, which is supporting the Yemeni government against the Houthis rebels. Ahmed and Ameen will tell us how the situation in Yemen developed, its effects on the population and the role of Saudi Arabia.

Ahmed is a Yemeni citizen who worked for Daso, an organisation with the aim of ending the tribal conflicts in Yemen. Ahmed worked this organisation until before the war broke out in Yemen in 2015.

Ameen is a UK-based human right activist from Saudi Arabia, who writes and delivers talks about Saudi Arabian policies and its motives.

## MYANMAR

### Rohingya people still in precarious situation

In November 18 the governments of Bangladesh and Myanmar announced that they were planning the repatriation to Myanmar of 720,000 Rohingya people, who fled to Bangladesh in search for safety against the brutality of Myanmar's armed forces.

In panic, hundreds of Rohingyas hid in camps, like Cox's Bazar (Bangladesh), to avoid repatriation.

Their journey to Bangladesh has been more than any of us could take. For many of them the only option was to get away on foot, taking with them whatever they could put together. Many of them died of starvation along the journey, or succumbed to their wounds and illness. Many Rohingya refugees have still not recovered from the trauma they experienced during this journey and do not want to go back to a country where they do not feel safe.



Today Cox's Bazar is the largest refugee camp in the world, with nearly one million Rohingya refugees stretched across 6,000 acres. The camps are densely populated with 60,000 to 95,000 people per square kilometre even more than the most densely populated cities in the world today. They live in temporary bamboo shelters. (Amnesty source)

Amnesty has stressed the importance for the international bodies to continue their efforts to bring the perpetrators of the crimes committed against the Rohingya people in Myanmar to accountability. Furthermore, Amnesty has put forward the suggestion of a third country relocation for the Rohingya, given that Bangladesh's limited resources, despite the country's generosity so far, could lead to a premature repatriation.

## PALESTINE

### Ban Israeli Settlement Goods -54,220 signatures!



In December 18, Kate Allen, Amnesty UK's Director, delivered Amnesty's petition calling on the UK government to ban Israeli settlement goods to the Foreign Office. The petition was signed by 54,220 people. The petition was accompanied by a special Christmas hamper filled with olive oil, wine, dates and oranges all labelled with specially created "Delicious but tainted" stickers.

We must keep the pressure on, until the ban is in place!

### New campaign

In 2019 Amnesty will launch a new campaign, targeting businesses that profit from Israel's policy on the Occupied Palestinian Territories (OPT).

Other organisations have already started this campaign and some progress has been made:

- Nov 18 - Airbnb announced that it would withdraw 200 property listings in the occupied territories;
- Dec 18 -HSBC confirmed that it has divested completely from Israeli weapons manufacturer Elbit Systems\*. This petition was organised by 'War on Want' and led over 24,000 people to email HSBC expressing their concern.

\*Elbit Systems has been a leading force in militarised walls, state surveillance on civilians, and deadly drones in Palestine and the U.S.-Mexico border.

However, in its new report '[Destination: Occupation](#)', Amnesty states that Airbnb is still profiting from over 100 settlement listings in East Jerusalem, also part of the OPT. Amnesty also lists TripAdvisor, Expedia and Booking.com among companies that are contributing to the existence and expansion of Israeli's illegal settlements, by attracting tourism to them.

## Refugee I Welcome

### Families together action

Refugees in the UK often find themselves separated from their families following brutal experiences of conflict or persecution, but restrictive Home Office rules prevent many families from being together just when they need each other the most.



Last year groups around the country lobbied their MP to call on them to support the Refugees Family Reunion private members bill. Over 100 MPs supported the bill in Parliament, and now we need their support again.

There are two opportunities to change the rules on refugee family reunion; the Immigration and Social Security Co-ordination (EU Withdrawal) Bill and The Refugee Family Reunion Bill, which

remains in Parliament. It's important that MP's hear from as many of their constituents as soon as possible, as they will be deciding by 29th March.

## Individuals at risk

### Letter Writing Drop-in

Only 3 of us turned up for our last letter writing drop in at 8th Day Café and wrote 11 letters to Azerbaijan (PoC), Mozambique (journalist), Bahrain (man deported to Bahrain from Netherlands) and the Russian Federation (homophobic crackdown in Chechnya).

The next session will be **Saturday 30th March**.

### Mikhail Benyash

At our September meeting with Sergei Nikitin, we took action on a UA on behalf of Mikhail Benyash, (a lawyer detained on 9 September after meeting his client who had taken part in a peaceful protest against pension reforms in Krasnodar, Russia). He was released on bail on 23 October 2018 however, the politically-motivated criminal charges against him are still pending. He faces up to five years imprisonment if found guilty.

Sergei contacted Mikhail after his release and told him about the AI Glossop and AI Manchester groups who signed the UA. Mikhail has sent us the following message:

*Please tell the Amnesty International activists that my recognition as a prisoner of conscience was shocking news for the administration of the Temporary Detention Centre and the Remand Prison. And of course, the daily visits of lawyers and members of the Public Observance Commission was an unpleasant surprise for them too.*

*What Amnesty International does is very, very important.*

*I felt this personally - as an individual who has twice been in Russian prisons, I know it for sure. The first time I was arrested was in 2010, by order of the chairman of the Krasnodar Regional Court. The second time it happened in 2018.*

*My first imprisonment went publicly unnoticed, but the second case had significant public coverage and I entered the Remand Prison as a prisoner of conscience.*

*The difference is huge.*

*And most importantly, Amnesty International has added me inner strength and confidence that what I was doing was right. And I could not allow myself to break down.*

*I do not know how my fate will turn out and how the court will end, but I can say that if Amnesty International needs the help of a lawyer in the Krasnodar Territory, then I'm at your service.*

*A colossal number of innocent people are imprisoned in Russia. The conditions of detention in prisons are terrible, and political repression is being taken to a higher level, becoming more widespread and harsh.*

*We do what we do and we will never stop fighting for justice. The way we have chosen is very, very difficult and very often it is scary. But we are not afraid. I'm not afraid.*

*It is very hard for us, but because of your support it feels a little bit easier.*

*While in prison I had time to think over many things (it happens to many of those who find themselves behind bars). I understood that I should give people more, I ought to change the very system of their defence.*

*And now my friends and I are busy with what we call the "awakening of the Russian legal profession". It seems to be working. Lawyers from all over the country write that they see my story as an example of disinterested assistance to both ordinary people and among lawyers themselves.*

*We have been able to give lawyers hope that not everything has been lost, that there are still good, real people, and that good can win.*

*Amnesty International helped me to survive with dignity. To a large extent, credit for the appearance of this hope is yours too.*

## LGBTI Rights

### CHECHNYA

Many of you will be aware of the increase in arrests, torture and killings of LGBTI people in Chechnya, with the authorities torturing people to disclose the names of others, who are in turn arrested. Many – it is impossible to be sure how many, probably hundreds – were tortured and killed in 2017, and no one was ever held to account. Now it is happening again.

Amnesty has an urgent action to try to persuade President Putin to take action: any improvement in the present situation would be worthwhile. The URL for the action is
