### Crisis and Tactical

#### MYANMAR

##### New evidence of more violations in Rakhine State



In February 19, Amnesty stated that there is new evidence of more violations in Rakhine State by the hands of Myanmar's security forces.

These violations include shelling villages, looting valuables from bombed properties, blocking civilians from accessing food and humanitarian assistance and using vague and repressive laws to detain civilians in the area.

These violations follow a crackdown that began following armed attacks on four police posts in Northern Rakhine by the Arakan Army, ethnic Rakhine armed group, in early January. Reportedly 13 police officers were killed in these attacks.

According to Amnesty, the security forces involved in the crackdown include soldiers from the 99th Light Infantry Division (LID), which Amnesty implicated in the atrocities against the Rohingya people in 2017 and against ethnic minorities in Northern Shan in 2016.

Following these attacks and reprisals, more than 5,000 civilians, including children, women and elderly, have been displaced and have very little food and cash to rely on.

The Myanmar authorities have also imposed restrictions on humanitarian access in Rakhine. All UN agencies and international humanitarian organisations, except the International Committee of the Red Cross (ICRC) and World Food Programme (WFP), have been barred from operating in five conflict-affected townships.

## PALESTINE

### Check Out Campaign

In February Amnesty launched a new petition against online tourism company

TripAdvisor, which has been identified by Amnesty as one of the main businesses profiting from the OPT (Occupied Palestinian Territories). With more than 70 different attractions based in the OPT, TripAdvisor is contributing to finance Israel's illegal settlements. Amnesty is asking TripAdvisor to 'check out' of Palestinian land.

### Update from Palestine Solidarity Campaign (PSC)

In January 19, the organisation Palestine Solidarity Campaign received the news that they have won the right to appeal to the Supreme Court against the judgement that made it legal for the UK Government to stop Local Government Pension Schemes from divesting from companies complicit in Israel's violations of human rights in Palestine. This year they will take the UK Government to the Supreme Court and are looking for financial support. If you wish to do so, please go to:

PSC has also campaigned for businesses to stop profiting from Israel's activities in the OPT (Occupied Palestinian Territories).

One of these businesses is HSBC, which is investing in companies directly involved in Israel's policy on Palestine. One such investment has approximately £100 million worth of shares in Caterpillar, which is manufacturing specially designed bulldozers for the demolition of Palestinian homes and villages.



## SYRIA

### Amnesty support for Syria

Despite the complex situation in Syria, Amnesty will carry on offering support in this severe crisis by:

- Supporting Syrian human rights activists to develop strategy and campaigns through training programmes and ongoing advice and assistance;
- Exposing human rights violations and hold perpetrators to account;
- Demonstrating solidarity with imprisoned activists.



## YEMEN

### The UAE is arming unaccountable militias with weapons from Western countries

*Extract from Amnesty's Press Release dated 6<sup>th</sup> Feb 19:*

"A new open-source investigation published by Amnesty International today has highlighted how the United Arab Emirates is arming out-of-control militias operating in Yemen with a range of advanced weaponry - much of it sourced from Western countries, including the UK.

The investigation - "[When arms go astray: Yemen's deadly new threat of arms diversion to militias](#)" - shows how the UAE has become a major conduit for armoured vehicles, mortar systems, rifles, pistols, and machine guns - which are being diverted to

unaccountable militias accused of war crimes and other serious violations.

According to publicly-available data, since the outbreak of the Yemeni conflict in 2015, Western countries have supplied the UAE with at least US\$3.5billion worth of arms. These include heavy conventional weapons - including aircraft and ships - small arms, light weapons, and associated parts and ammunition. Despite the serious violations attributed to the UAE and militias it supports, the following countries, among others, have recently supplied the Emiratis with arms: Australia, Belgium, Brazil, Bulgaria, Czech Republic, France, Germany, South Africa, South Korea, Turkey, the UK and the USA. Meanwhile, Denmark, Finland, Norway and the Netherlands have announced suspensions in arms transfers to the UAE.

Amnesty is calling on all countries to halt arms transfers to all parties to the Yemen conflict while there is a substantial risk they would be used to commit or facilitate serious violations of international humanitarian and human rights law.

#### UK role



Since the start of the Yemen conflict, the UK has licensed nearly [£600 million worth of arms](#) to the United Arab Emirates - including military vehicles and their parts and components worth £150 million, small arms and light weapons valued at £25 million, and £243million of military aircraft and their parts and components.

Oliver Sprague, Amnesty International UK's Arms Expert, said:

"According to its own arms export rules, the UK should long ago have halted the sale of all weapons to all parties to the conflict in Yemen because of the clear risk they would fuel further human rights abuse."
