UAE (Mohammed al-Roken & Ahmed Mansoor)

PALESTINE

Think Twice!

In March, Amnesty sent a new report called 'Think Twice' to all companies in the FTSE 100 and FTSE 250 Index, as well as to leading corporate law firms, the Confederation of British Industry, the Institute of Directors and the Association of British Insurers.

The report warns companies that they will be involved in human rights violations including war crimes - if they



illegal Israeli settlements in the West Bank, including East Jerusalem.

Under the UN Guiding Principles on Business and Human Rights, all companies have a responsibility to respect international humanitarian and human rights law, wherever they operate in the world. Israel's settlements breach the Geneva Conventions and amount to war crimes.

Peter Frankental, Amnesty International UK's Economic Affairs Programme Director, stated:

"... if you're a company operating in or doing business with the settlements, then you're involved in systematic injustice, discrimination and other human rights violations perpetrated by the state of Israel against Palestinians."

The Think Twice report comes ahead of the long-awaited publication of a UN database listing companies known to be operating in the settlements.

The victim states that when she reported to TripAdvisor having been abused by a tour guide whose business is promoted on their website, TripAdvisor dismissed her. She started a petition through Change.org, which has gained a lot of media attention.)

SYRIA

Syrian Government Attacks Civilians

Throughout March 19 the Syrian government, abetted by Russia, has carried out several attacks on civilian facilities.

According to witnesses interviewed by Amnesty, attacks have escalated in the past few weeks, causing the death of civilians, the destruction of civilian buildings and the displacement of the population from towns to farming fields and close to the border with Turkey.

In the areas of Saraqeb, Khan Sheikhoun, Talmans and Sheikh Idriss in Idlib, aerial and artillery attacks struck hospitals, a blood bank, an ambulance response unit, a Syrian Civil Defense (or White Helmets) unit, bakeries, medical clinics and a school.

Amnesty's Digital Verification Corps was able to corroborate many of the witness accounts by video analysis, verified open source information, social media photos and videos.

Lynn Maalouf, Middle East Research Director at Amnesty International, said:

"Eight years into the crisis, the Syrian government continues to show utter disregard for the laws of war and the lives of civilians. Deliberate attacks on civilians and on civilian objects, including hospitals and other medical facilities, and indiscriminate attacks that kill or injure civilians are war crimes."

Russia and Turkey, as the key backers of the parties to the conflict, should heed the warning of the UN and ensure that the imminent offensive on Idlib prioritises the protection of civilians and does not exacerbate the humanitarian crisis. Turkey should open its borders to civilians wishing to flee and to humanitarian organisations providing impartial relief to civilians in need of assistance in parts of Syria under Turkey's control."

YEMEN

UK: Stop Arming Saudi Arabia

The conflict in Yemen started in 2015, following on from the 'Arab Spring', when rebel Houthies tried to topple the Yemeni Government. Since the beginning of this conflict, Saudi Arabia has led a coalition in support of the Yemeni Government to try and restore its power.

As explained by Ahmed and Ameen at our group meeting in February, Saudi Arabia has a political interest in maintaining the Yemeni Government in power and its indirect control over the country.

Since the beginning of the conflict the UK has sold 600M GBP worth of military equipment and 5M GBP of arms to the Saudi-led coalition. This has contributed to:

- Bombardment of hospitals, schools and civilian buildings causing a high number of civilian deaths;
- Starvation at unprecedented levels due to the inability of civilians to procure food safely (the UN estimates 14 million people have been affected);
- Arms ending up in the hands of militias, which are not accountable to any government;
- Rape as weapon of war. Amnesty has reported allegation of rape of children at the hands of militias and called for investigation into the matter.

Amnesty is calling for the UK to stop arming Saudi Arabia.

Five Opposition Parties Call for an End of Arms Sales to Saudi Arabia

On 25th March the Guardian published an article stating that the leaders of 5 opposition parties have written a joint letter to the UK's foreign secretary, Jeremy



Hunt, calling on the UK to end arms sales to Saudi Arabia.

The letter signed by the Labour party, Scottish National party, Liberal Democrats, Plaid Cymru and the Green party states that "it is morally reprehensible that the UK government is not only not considering changing its policy, but is actively lobbying other foreign governments, as it did with Germany, to resume arms sales to Saudi".

The authors also call for an independent investigation into Saudi conduct in the war.
