MYANMAR

GOOD NEWS - Reuters journalists released!

In December 17, Reuters journalists Wa Lone and Kyaw Soe Oo were arrested in Myanmar after having reported the atrocities committed by Myanmar's army in Rakhine State. In April 19 Myanmar's Supreme Court ruled to uphold their conviction and seven-year prison sentence. However, on Tuesday 7th May 19 they were released!

Upon their release, Nicholas Bequelin, Amnesty International's East and Southeast Asia Director stated: "Today marks an important victory for press freedom in Myanmar. While all those who campaigned for their release (of Wa Lone and Kyaw Soe Oo) welcome the government's decision, the reality is the country retains a range of repressive laws used to detain journalists, activists and any perceived critic of the authorities. Until these laws are repealed, journalists and activists remain under a permanent threat of detention and arrest."



PALESTINE Airbnb

Last year Airbnb announced that it would remove listings from the Occupied Palestinian Territories. However, recently Airbnb have announced that they will no longer be removing them following a lawsuit by Israeli lawyers.

Mark Dummett, Amnesty International's Business and Human Rights Researcher, said: "Airbnb are trying to absolve themselves by stating they will donate the profits from these listings to charity, but that fails to change the fact that by continuing to drive tourism to illegal settlements they are helping to boost the settlement economy.

Airbnb had a clear opportunity to make the right decision to uphold human rights and use their influence to set a precedent in the tourism industry. Instead, they have chosen to bury their heads in the sand - ignoring blatant evidence that they are helping to fuel violations that cause immense suffering to Palestinians.

Airbnb's reversal demonstrates why we can't just rely on companies to take the right decisions, and that we need governments to fulfil their obligations by intervening and passing laws obliging their companies to respect human rights."

ACTIONS!

- ➤ Write a letter to **Airbnb** CEO Brian Chesky following the following guideline advised by Amnesty:
- Say that you welcome Airbnb's decision in November 2018 to pull around 200 listings in Israel's illegal settlements but call for the decision to be implemented immediately.
- Say that you are concerned to discover that Airbnb will continue to promote properties located in illegal Israeli settlements in East Jerusalem and call on them to remove these listings from their service.
- Under international humanitarian law the settlements are illegal and have a devastating impact on the human rights of Palestinian people

They also reminded us of how the accusations of anti-semitism, which are aimed at anyone who supports the Palestinian cause, are a tool to stem this growth in support. The message from both organisations is to carry on in our support and remind people of the 3 key requests from Palestinians:

- 1-Right to return;
- 2-End of occupation;
- 3-Equality for all Israeli citizens

Raqqa: rhetoric versus reality

A new investigation from Amnesty International and Airwars has revealed that more than 1,600 civilians were killed as a direct result of thousands of US, UK and French airstrikes and tens of thousands of US artillery strikes during the US-led Coalition's military assault on the Syrian city Raqqa in 2017. Many of the cases documented by Amnesty are likely to amount to violations

of international humanitarian law and warrant further investigation.

The findings are contained in a new interactive website - Rhetoric versus Reality: How the 'most precise air campaign in history' left Raqqa the most destroyed city in modern times, which forms the most comprehensive investigation into civilian deaths of any modern conflict. The website combines photographs, videos, 360-degree immersive experiences, satellite imagery, maps and data visualisations to highlight the cases and journeys of civilians caught under the Coalition's bombardment. Users can also access data on civilians who were killed, many of them after having fled from place to place across the city.



Amnesty and Airwars have frequently shared their findings with the Coalition and with the US, UK and French governments. In response, the Coalition has admitted responsibility for killing 159 civilians - around 10% of the total number - but has routinely dismissed the remainder as "non-credible." In July 2018, UK Defence Secretary Gavin Williamson said in the House of Commons that Amnesty's findings were "unfounded", "deeply disappointing and disgraceful", while praising the "amazing professionalism of our Royal Air Force".

Amnesty's and Airwars's research in figures:

- -2 years <u>analysing</u> open-source evidence, both in real time and after the battle;
- -more than 1,000 civilians killed during the attacks named (Amnesty has directly verified 641 of those on the ground in Raqqa, and there are very strong multiple-source reports for the rest);
- -2 months spent on the ground in Raqqa on the from Amnesty's researchers since the battle;
- -200 strike locations investigated by Amnesty's staff;
- -more than 400 witnesses and survivors interviewed by Amnesty's staff;
- -3,000 digital activists in 124 countries took part, analysing more than two million satellite image frames.

The much higher than previously reported civilian death toll reflects the Coalition's relentless barrage of munitions that were

inaccurate to the point of being indiscriminate when used near civilians. During the four-month bombardment (June to October 2017), almost 80% of the city was left uninhabitable (including more than 11,000 buildings), and Raqqa is widely considered the most-destroyed city of modern times.

Despite their best efforts, NGOs like Amnesty and Airwars will never have the resources to investigate the full extent of civilian deaths and injuries in Raqqa. The organisations are urging Coalition members to establish an independent, impartial mechanism to effectively and promptly investigate reports of civilian harm, including violations of international humanitarian law, and make the findings public. Additionally, Coalition members must create a fund to ensure that victims and their families receive full reparation and compensation.

Donatella Rovera, Amnesty International's Senior Crisis Response Adviser, said: "Amnesty International and Airwars call upon the Coalition forces to end their denial about the shocking scale of civilian deaths and destruction caused by their offensive in Ragga."

LGBTI Rights

International Day against Homophobia, Transphobia and Biphobia on is on 17th May, when Al sections around the world will be taking part in a global petition hand-in to the Russian authorities calling for an end to the persecution of LGBTI people in Chechnya. Two people have been tortured to death in new attacks on LGBTI people in Chechnya. Around 40 men and women have been abducted and detained in a government building, based on their alleged sexual orientation.

Tell President Putin to investigate these reports and to ensure that anyone found guilty or complicit in these crimes is brought to justice. We're aiming to reach 100,000 signatures, so **please sign and share before 17**th **May**.

AIUK Annual General Meeting and National Conference

Several of us attended the UK Sections National Conference and AGM in April. As always, we learnt a lot and came away feeling inspired.

Of particular note was the speech and Q&A session with the new Amnesty International Secretary General, Kumi Naidoo. He is an eloquent speaker and really stirred the audience.

He started off by stating that times are such that if we tried to pass the Human Rights Declaration today, we would probably fail. For Amnesty to be really effective, to really be listened to by politicians, we need to reach 17 million members (currently 7 millions). We need to loosen up and take risks, if we want to

attract more people. He highlighted Climate change (the clock is ticking!), Inequality and Technology (threat to jobs) being the biggest causes of today's social tensions.

In the Q&A one member of the audience asked him about Amnesty's stance on political impartiality. His answer was: 'Impartial to political parties yes. Impartial to injustice never. Xenophobia, racism, sexism: this is injustice and we will not be impartial on this'



He ended by inviting the student groups up on stage to highlight their concerns on climate change.

We also had a superb panel discussion on People Power which included Lyndsay Burtonshaw, one of the Stanstead 15 and was chaired by Amal Azzudin, one of the Glasgow girls who

campaigned against detention and deportation of asylum seekers in Glasgow. The overall message was that although s people sometime associate Amnesty with long-term and abstract campaigns and this can be off putting If they taste People's Power, they will stick with us. We need to empower people

There were many more excellent speeches, not least from Kate Allen (AlUK director), Ruth Breddall (retiring Board chair) and Tom Chigbo (chair of Activism sub committee).

International Conscientious Objectors' Day

On Wednesday, 15th May, Quakers and the Friends of Manchester Peace Garden will hold a vigil on the steps of the Friends' Meeting House, Mount Street, central Manchester, to commemorate International Conscientious Objectors' Day, from 12.30 pm to 2.0 pm. They will be holding placards with messages, including, "Resist All Wars', 'Honour COs', 'Stop the Arms Trade', and 'It Takes Courage to be a CO' and giving out explanatory leaflets. They would welcome support.

A Peace Trail around central Manchester, led by Steve Roman, will start at 2.15 and finish at 4.00, at the Friends' Meeting House. The walk will cover Manchester as a centre for peace and radical political activity, including John Dalton, MAG and the Nobel Peace Prize, the Nuclear Ban Treaty, Peterloo, Gandhi and campaigns against slavery.
