## **Next Group Meeting**

We are continuing to raise the plight of Mohammed al-Roken and Ahmed Mansoor with local leaders within Manchester asking them to raise the cases with their contacts in the UAE. Over the last month, Kathryn raised their cases with Joanne Roney (Chief Executive) and Eddie Smith (Strategic director) on the City Council Executive and Anne wrote to Paul Denett who holds the housing portfolio at the Greater Manchester Combined Authority.

This requires you to take some action every 2-3 months or so with anything from a quick Tweet to detailed letters, in the belief that a range of different approaches might help the message get through.

Ahmed is himself a poet and the evening will include readings of his poems alongside new work created by Young Identity and young Amnesty members. This event is part of the PHM Thursday Lates programme and will be called *Screams, chants and tight-lipped silence: poetry and protest*. We will also be involved in *Have Your Say* which precedes this and will highlight the moral dilemma that Manchester faces in the extensive links that the city has with the UAE.

We will start planning these events in earnest at our September meeting. Come along and get involved.

## MYANMAR

# On the second anniversary of attacks on Rohingyas no justice has been done

Sunday 25TH August marked the second anniversary of Myanmar's military campaign against the Rohingyas, which saw at least 10,000 Rohingya women, men and children killed, and forced more than 740,000 Rohingya to flee their homes and seek refuge in Bangladesh. after being subjected to brutal assaults.

Amnesty International has warned that Rakhine State remains unsafe while those responsible for the violence continue to evade justice.

In September 2018, the UN Human Rights Council adopted a resolution to create an accountability mechanism to collect and preserve evidence of crimes under international law in Myanmar. Other accountability efforts have included targeted sanctions against military officials by several states and by the European Union, as well as a request from the Prosecutor of the International Criminal Court to open an investigation into crimes under the Court's jurisdiction committed against the Rohingya population since October 2016.

In June 2018 an Amnesty report named 13 officials in the security forces – all the way up the chain of command to Senior General Min Aung Hlaing – who should be investigated and prosecuted for crimes against humanity. The European Union has imposed targeted sanctions on 11 of the 13 singled out in that report.

Amnesty has welcomed these steps towards accountability, but continues to call for the situation in Myanmar to be referred to the International Criminal Court.

Amnesty also calls on the international community to not facilitate ongoing crimes, by means of donations to Myanmar, and instead press Myanmar to restore the Rohingya's rights, including citizenship rights. The international community should also work with Bangladesh to support Rohingya refugees to rebuild their lives in dignity. No decisions about the future of the Rohingya should be taken without proper consultation with the Rohingya themselves."

## PALESTINE

# Work of humanitarian organisations increasingly difficult in Israel:

According to Amnesty, in recent years, the climate for human rights defenders in both Israel and the Occupied Palestinian Territories has rapidly deteriorated. Israeli authorities have taken steps to unduly restrict the rights to freedom of expression and association inside Israel, with officials intimidating human rights defenders critical of the government and introducing legislation to silence dissent.

### Amnesty International and others

In July, anonymous death threats were sprayed outside the offices of Amnesty International Israel in Tel Aviv and ASSAF, an organization working to assist refugees and asylum-seekers in Israel. At the same time, a box containing death threats and a

dead mouse was left at the entrance to the Elifelet Children's Activity Center for refugees.

Amnesty's International Secretariat has called on the Israeli authorities to urgently investigate these death threats.



### Human Rights Watch

Amnesty International has joined a legal case brought by Human Rights Watch to challenge the Israeli government's decision to revoke the work permit of Human Rights Watch's Israel and Palestine Director, Omar Shakir.

In May 2018, the Israeli Ministry of Interior revoked Shakir's work permit, citing a 2017 amendment to the Entry to Israel Law which refuses entry to Israel and the Occupied Palestinian Territories to anyone who supports or calls for a boycott of Israel as defined under the country's "anti-boycott" law. \*

The outcome of the legal case has not been confirmed.

\*The "anti-boycott law" of 2011, formally known as the Law for Prevention of Damage to State of Israel through Boycott, makes it a civil wrong in Israel to call for a boycott of any entity because of its affiliation to Israel or to a territory under its control, including entities operating in illegal settlements in the Occupied Palestinian Territories. A 2017 amendment to the Entry to Israel Law prohibits granting an entry visa to Israel (and therefore to the Occupied Palestinian Territories which are under Israeli control) to anyone who knowingly published, or operates within an organisation who knowingly published, a call for a boycott as defined under the 2011 law.

## **SYRIA**

# UN to investigate into Syrian government attacks in Idlib

In August the UN Secretary General António Guterres stated that he will establish a "board of inquiry" to investigate attacks that have taken place during the Syrian government's offensive on the province of Idlib. Sherine Tadros, Head of Amnesty International's UN Office in New York, said:

"The plans for a UN investigation into attacks targeting hospitals in Idlib - and other buildings clearly identified as civilian objects by the UN - offer hope that perpetrators of war crimes and crimes against humanity, can be identified and held accountable.

Amnesty International has documented at least eight attacks targeting hospitals, a blood bank, an ambulance response unit and rescue workers in Idlib in recent months. Our research shows that the bombing of medical facilities - which is itself a war crime - has become part of a pattern by the Syrian authorities to systematically attack the civilian population, which is also a crime against humanity.

It is crucial that this investigation identifies the perpetrators responsible for these ghastly attacks and establishes whether coordinates supplied by the UN to ensure the protection of medical facilities are being exploited. The investigation's findings must be made public."

Amnesty is independently looking for proof of crimes against humanity in Syria, by visiting sites of bombings, interviewing people inside and outside Syria and by analysing satellite images. ## YEMEN



## PROTEST FOR YEMEN -Sunday 15th September 12.30pm at the Friends Meeting House, 6 Mount Street, Manchester, M2 5NS

Join us and the Quakers of Manchester in a protest against the UK Government's decision to appeal against the UK Court's ruling that in June 2019 declared the sales of arms to Saudi Arabia illegal. Since the start of the war in 2015 the UK has sold many millions worth of arms to Saudi Arabia, which have been transferred to Yemen and used by the Yemeni Government and unregulated militias against the Huthi rebels. Thousands of civilians have been killed as a direct consequence of the use of these weapons.

Our protest will be silent, but some of us will ask passers-by to sign letters addressed to their MPs, asking them to raise the issue in Parliament for the appeal to be withdrawn.

## Europe (inc Turkey)

### Another Urgent Action

Gökhan Türkmen and Mustafa Yılmaz have been missing since 7 and 19 February 2019 respectively and are suspected to have been abducted and forcibly disappeared. The authorities have so far been denying that they are being held in official custody. On 29 July four men who had been missing since around the same time have resurfaced in detention at the Anti-Terrorism Branch of the Ankara Police Headquarters. The authorities must promptly investigate to determine the whereabouts of Gökhan Türkmen and Mustafa Yılmaz and urgently inform their families.



## **Children's rights**



The petition calling on the UK Government to ratify the Optional Protocol to the UN convention on the Rights of the Child and make rights real for #AllChildren is now live. We haven't got long.

In September Amnesty will be handing in the petition and cards in advance of the UN General Assembly Treaty Events taking place in the Autumn.

The ratification of OP3 would allow complaints about violations of children's rights in the UK to be taken to the UN Committee on the Rights of the Child, making children's rights real and enforceable.
