Private donations of £174 were received. The accounts were made up to the end of the financial year. In 2018 we donated £4,372.00 to Amnesty – very comfortably ahead of our budgeted expectations.

Children at Risk: Egypt

We wrote to the Egyptian Interior Minister regarding **Asser Mohamed.** Amnesty has published a joint Statement with the Egyptian Front for Human Rights highlighting the persistent violation of children's rights in Egypt. As a Signatory to the UN Convention on the Rights of the Child, the Egyptian Government has a duty to ensure its children are protected, and in particular from torture. It is known that at least 13 children have been detained and 12 'forcibly disappeared'. At least six are known to have undergone torture. Asser Mohamed was 14 when he was arrested and forcibly disappeared for 34 days. He has been accused of being a member of the Muslim Brotherhood — a proscribed group, without any evidence to substantiate the claim. Asser faces up to 15 years imprisonment if convicted. At the grossly unfair trial, the Prosecutor indicated torture had been used to extract a confession as Asser's denials were met with the comment 'it seems that you want to go back to

the electric shocks again'. We have written demanding Asser's immediate and unconditional release, and reminding the Interior Minister of his responsibilities under the UN Conventions Egypt is a party to.
