## Upcoming Matched Funding Opportunity

One of Amnesty International UK's major donors has offered us £18,000 in 'matched funding' for local groups. In March and April local group contributions up to this amount will be doubled until that sum has been used up. The donations from groups will go directly to the Section but the matched funds will ongoing human rights research on the ground in Syria.
