### Amnesty action: campaigns & letter-writing

Some good news



**Thursday 2 April:** After 12 long years in prison, Moroccan-Belgian citizen **Ali Arraas** is finally released. We thank everyone who has campaigned on his behalf and took the time to demand justice in his case, which has been raised a number of times since his extradition on 14 December 2010, when Ali was forcibly returned to Morocco from Spain, where he had been caring for his ageing father. The extradition took place despite warnings from both Amnesty and the UN Human Rights Committee that doing so would put the father-of-one at risk of torture and other ill-treatment. Torture is central to Morocco's 'justice' system.

Ali cannot leave Morocco at the moment because of travel restrictions and is not talking to the press.

### Action: Egypt update

*Campaign Co-ordinator Margaret Robertson writes:* Thanks to all members who have been using their 'enforced detention' to support campaigns. Amnesty is increasingly worried about Egyptian prisoners, in view of the alarming spread of coronavirus in Egyptian jails. Amnesty is calling for the immediate release of all prisoners of conscience, human rights defenders, non violent offenders and those subjected to enforced disappearance, including our new adopted prisoner, Ibrahim Ezz El-Din (see below).

If you can possibly take urgent action on the two cases on behalf of Azza Soliman and Ibrahim Ezz El-Din as soon as possible I'd be very grateful.

### Action: Egypt - appeal against the travel ban

This is a general action for human rights defenders in Egypt. We have been asked to write to the Egyptian embassy in the UK concerning this. The reason for writing now is that the appeal against the travel ban (case 173) is coming up on 23 April. This has been imposed on individuals, many of whom work for human rights NGOs. **Azza Soliman** is one of them. The request is also more general in asking for all Human Rights Defenders to be unconditionally released.

Your Excellency

I am writing to express my grave concern about the human rights situation in Egypt. I am particularly disturbed by the plight of many NGO workers and human rights defenders who have endured intimidation, harassment and even detention as a result of their work on behalf of some of the most vulnerable members of Egyptian society.

I am aware that a court hearing of Closed case 173 relating to travel bans on some NGO workers is due to take place on 23 April. I urge you to support a call for these bans to be lifted immediately and unconditionally. I am particularly concerned about **Azza Soliman**, a lawyer who has worked bravely and selflessly on behalf of disadvantaged women in Cairo.

May I respectfully call upon you to urge the government to release all human rights defenders and those detained because of their peaceful exercise of their right to freedom of expression. I also call for the repeal of the NGO law and welcome President al-Sisi's comments in support of the work of civil society in advancing social aspirations.

I look forward to hearing your response to my appeal.

Dear Counsellor

I am extremely concerned about the case of **Ibrahim Ezz El-Din**, a 26 year old housing rights researcher for the Egyptian Commission for Rights and Freedoms, who was subject to enforced disappearance in June 2019.

He alleges that, whilst in detention, he was kept in inhumane conditions and tortured into making false confessions. He reappeared in November 2019 at a trial in which no additional evidence was brought against him; he was not allowed to consult his lawyer in private; his lawyer was not allowed access to his case file.

In view of the unsatisfactory nature of court proceedings and the increasingly dangerous conditions in Egyptian prisons because of the spread of the coronavirus, I urge you to order his immediate and unconditional release. I also call upon you to release all other human rights defenders, non violent offenders and those subjected to enforced detention.

Please order an investigation into Ibrahim Ezz El-Din's allegations of torture and ill treatment and end the use of enforced disappearance and pre-trial detention.
