Other events

Since the last email, Amnesty has launched an [online action](#), calling on the government to protect the rights of individuals who we believe to be at particular risk as a result of the Covid-19 crisis - women who are victims of domestic abuse, refugees and migrants, and essential workers. Some of us may fall into one or more of those categories ourselves, others will have family members, friends and neighbours who do. Please take this action and share it as widely as you can in your communities.

Internationally, Amnesty has warned that the Qatari authorities appear to have used the pandemic as a smokescreen for further abuses against migrant workers and we have called on the Turkish authorities to release those convicted in unfair trials under the country's overly broad anti-terrorism laws, who also now face the prospect of infection from coronavirus. In Iran, we have called for an independent investigation into the torture and deaths in custody of prisoners who protested after the authorities reneged on promises to release some inmates to prevent the spread of Covid-19. Amnesty action: campaigns & letter-writing

Action: Egypt update

Our Campaign Co-ordinator, Margaret Robertson, writes:

“Thanks to all of you who are continuing to use your time during lockdown to write on behalf of victims of human rights abuses, especially our Egyptian prisoners.

In view of the alarming spread of Covid 19 in Egyptian jails, Amnesty is calling for the immediate release of nonviolent offenders and prisoners of conscience. This month we have received requests for action on behalf of three prisoners with severe health problems, namely **Ibrahim Ezz El-Din**, a housing rights researcher who has already made two suicide attempts; **Alaa Abdel Fattah**, an activist who is on hunger strike in protest against conditions in jail and human rights lawyer, **Mohamed el-Baqer**, who already suffers from asthma, chest and back pain and kidney problems. They are all extremely vulnerable and need urgent help.

Azza Soliman's court hearing about her appeal against her travel ban has been postponed from 23 April to an, as yet, unspecified date. There will be further actions later. Meanwhile, we have sent her a birthday card and good wishes from the group so that she knows she is not forgotten at this difficult time.

My thanks to all of you who support these appeals. I hope you are all staying safe and well.”

Dear Counsellor

In view of the alarming spread of Corvid 19 in Egyptian jails, I am extremely concerned about the health of prisoners, particularly those with underlying health problems.

I am especially disturbed to learn of the plight of Ibrahim Ezz El-Din, a human rights researcher with ECRF, who is suffering from severe depression as a result of the torture which he has suffered and the insanitary conditions in which he is held. I understand that he has twice attempted to commit suicide.

I am also distressed to hear of the condition of Alaa Abdel Fattah, a human rights activist, and Mohamed al-Baqer, a human rights lawyer, both held at Tora Maximum Security Prison 2. Alaa Abdel Fattah is apparently on hunger strike in protest against the conditions in which he is being held. Mohamed al-Baqer already suffers from asthma, back and chest pain and kidney problems. They are, therefore, particularly vulnerable to the Covid 19 virus.

May I respectfully appeal to you to order the immediate and unconditional release of these named men and all other non violent prisoners of conscience, detained solely because of their peaceful exercise of the right to freedom of expression and assembly.

I also call upon you to do all in your power to ensure that all prisoners are guaranteed adequate healthcare and preventative measures are taken to control the spread of the Covid 19 virus.

Action for individuals: India - crackdown on dissent continues during Covid-19

Activists Gautam Navlakha and Anand Teltumbde were arrested by the National Investigative Agency (NIA) on 14 April 2020 and charged under various provisions of the Indian Penal Code along with the Unlawful Activities (Prevention) Act (UAPA) for their involvement in the 2018 Bhima Koregaon riots.

These arrests appear to be politically motivated and relate to the massive crackdown on human rights defenders in 2018, when nine other prominent activists were arrested in the same case.
