## **Campaign News**

**I WELCOME REFUGEES**: *Jenny Gateau says*: Good news! Thanks to your real generosity, we have just had a hectic and marvellous few weeks with five Syrian/Kurdish families from Taunton/Wellington staying in the splendid Baptist Holiday Apartments, right beside the sea. This meant that five families – 27 people including three babies - have had the time of their lives playing on the beach, in the sea and in the park. Three of these families have never had a family holiday before. I quote from the beautiful card that Asmaa (9) made us: *"Thank you :-) Jenny and your friends and thanks for the invitation. I hope we can come again."* I can honestly say they have all benefitted immeasurably in wellbeing, confidence, English, self-sufficiency and sheer joy. They loved their accommodation. Mamood cried when it was time to go, and of course they all



want to come again. Some of the other families have heard about it...... Thanks to Amnesty members who helped raise money towards the cost of these holidays through our mini AmnesTeas in June.

**INDIA:** *Cherry writes* – Amnesty India is calling for investigation by independent civilian authorities into alleged extrajudicial executions of three labourers by troops on 18 July 2020 in the Shopian district of **Jammu & Kashmir**. The Indian army say three 'terrorists' were killed, but families in the area have reported three labourers missing. The Defence spokesperson says the army had noted social media inputs and were 'investigating the matter.' Amnesty India has repeatedly called for repeal of the Armed Forces Special Powers Act as it grants members of the security forces virtual impunity from prosecution for alleged human rights violations.

**NEPAL**: Al is planning to scale up campaigning on migrant labour rights as we come closer to the 2022 FIFA World Cup in Qatar. Al wants to bring positive change for the more than 2 million migrant workers in the Gulf, such as addressing non-payment of salaries and impounding of passports. In a study by VSO in four rural districts where they have a project helping girls to attend school, 89% of girls reported increased pressure to do housework or agricultural labour instead of school work. There has also been an increase in early marriage. In the districts where VSO works, families rely on migrant labour as a major source of income. Since many workers have lost their jobs, rural households are struggling to stay afloat and the pressure on young girls to marry increases. It is known that marriage at a young age can have devastating and lifelong consequences. Beyond the immediate loss of their education, it puts girls at increased risk of a life of abuse, ill health and poverty.

**DEATH PENALTY:** There has been some good news regarding **Magai Matiop Ngong**, a young boy in South Sudan who was facing a death sentence for a crime he committed when he was just 15. Under South Sudan and international law a child cannot be sentenced to death. Magai's death sentence has now been dropped and his case will be sent back to the High Court to rule on an appropriate sentence.

**World Day against the Death Penalty** is on Saturday 10 October. We had hoped to stage a vigil in Minehead but have decided that this would be impractical owing to the current Covid restrictions. Instead we invite you to look for Urgent Actions on the AIUK website and take action on a death penalty case.
