#### Egypt Urgent Action: update from our Campaign Co-ordinator, Margaret Robertson

As we face the winter months ahead and the prospect of further restrictions, it is becoming increasingly challenging to find original and creative ways to continue our campaigning. #### Future action and events: Case 173



As you know, our campaign in support of the Egyptian human rights lawyer, Azza Soliman, has now become part of the general campaign in support of NGO workers and human rights defenders facing charges and restrictions under the **Case 173**. Under the repressive NGO Law 2019, Azza and 14 others have faced the imposition of travel bans and asset freezes but their appeal against the ban was rejected in July 2020. We have been asked to express international dismay at the decision, by sending as many creative images of the number 173 as possible to the Egyptian authorities with short messages in support of Azza and other NGO workers.

We are hoping to meet online with our friends in the Horsham Amnesty group at **7.30 p.m. on 29 October** to share ideas and information about the campaign and to launch a joint response. Those of you feeling creative might like to think about simple but effective ways of designing images of the number 173 (raid the cupboards for beads, buttons, Smarties, pebbles...) or you might prefer to use the ready made templates supplied for the occasion. ### Message

*Ibrahim Ezz El-Din is a housing rights researcher in Cairo who was arrested in June 2019. While in detention, he was tortured to extract a false confession and has been convicted of joining a 'terrorist group.' There is no other evidence against him and Amnesty International believes him to have been detained solely because of his housing rights activism. He is currently in very poor mental and physical health and has twice attempted to take his own life.*

*I appeal to you to release him immediately and unconditionally.*

### Action: Iran: Free Nasrin Sotoudeh



Sentenced to 38 years and 148 lashes for her work defending women's rights, Nasrin is a human rights lawyer who had dedicated her life to this cause. She protested against Iran's discriminatory and degrading forced veiling laws. This is the harshest sentence Amnesty has seen in Iran against a human rights defender in recent years.

Her health is at serious risk following her hospitalisation when her health deteriorated following her hunger strike. The hunger strike was in protest at the Iranian authorities abuses in the criminal justice system, including their refusal to release eligible prisoners held on politically motivated charges. *On 10 August 2020, unjustly jailed human rights lawyer Nasrin Sotoudeh, aged 57, began a hunger strike in protest at the Iranian authorities ongoing abuses in the criminal justice system. On 19 September 2020, Nasrin Sotoudeh, whose health deteriorated on hunger strike, was transferred to a hospital outside of prison. Reza Khandan, Nasrin Sotoudeh's husband, said on Twitter at the time that she was in "dire health" and was suffering from an irregular heartbeat, low blood pressure, and shortness of breath making her unable to complete sentences. After she was transferred to Tehran's Evin prison on 23 September, she communicated in a phone call that she needed a medical procedure on her heart according to doctors who treated her in the hospital outside prison. Despite this, she is now held in the women's ward quarantine section of Evin prison while on hunger strike, without the round-the-clock presence of health professionals monitoring her condition. Her transfer from hospital to the quarantine section of the prison raises serious concerns that she is not receiving the specialized medical care she requires, which is unavailable in prison. During her hospitalization, security forces barred her family from communicating with her and her family was not able to access her treating physicians or test results. The lack of information surrounding her diagnosis only adds to her family's anguish about her health and wellbeing.*

*Nasrin Sotoudeh was sentenced to a total of 38 years and six months in prison and 148 lashes following two grossly unfair trials in 2016 and 2018 for her peaceful human rights work, including opposing Iran's abusive, degrading and discriminatory forced veiling laws and the death penalty. In late March 2020, a prison official verbally told Nasrin Sotoudeh that she had been granted a pardon for the 2016 sentence, but she has not been formally notified in writing. If this pardon applies, under Iran's sentencing guidelines, she must serve 12 years. She and her family have been subjected to repeated reprisals and harassment, including most recently the arrest of Mehraveh Khandan, her daughter, on 17 August 2020 and the blocking of her bank accounts.*

*I urge you to release Nasrin Sotoudeh immediately and unconditionally as she is a prisoner of conscience, jailed solely for her peaceful human rights work. Pending her release, ensure that she is provided with the specialized health care she needs outside prison, in compliance with medical ethics, including the principles of confidentiality, autonomy and informed consent, and that she has family visits. I also urge you to ensure an end to state harassment and intimidation of her family.*
