### Campaign for the release of Dr Mohamed al-Roken and Ahmed Mansoor, imprisoned in the UAE.

We continue to be concerned about the wellbeing of Dr Mohamed al-Roken and Ahmed Mansoor because of ongoing reports of cases of Covid19 in three UAE prisons. Human Rights Watch (HRW) have received reports from relatives that prisoners continue to be held in overcrowded and unsanitary conditions and are denied adequate medical care. They have not been issues with increased supplies of soap or hand sanitiser nor given masks and gloves. HRW has called on the UAE to urgently address the outbreak of Covid 19.

In April the UAE released 4,000 detainees, but this amnesty didn't include any of the many political detainees help for peaceful dissent.

#### Beirut Explosion: international investigation needed

Instead of supporting those impacted by the Beirut explosion and the severe economic crisis, the Lebanese state is attacking its population.

The explosion of 4 August 2020 killed over 200 people with an estimated 6,000 more injured and 300,000 left homeless.

Full accountability over the explosion has been one of the key calls made by the thousands of protesters who streamed onto the streets four days after the explosion. These protests were met by\_excessive use of force by the military and security forces, leading to hundreds of injuries.

So far Lebanon's President has rejected calls for an international inquiry into the incident.

#### Crackdown on Freedom of Expression

Since the 17 October 2019 protest movement, Lebanon's security and military agencies have summoned, interrogated and intimidated dozens of individuals in reaction to social media posts criticizing the authorities. None of these agencies are mandated to investigate issues of free speech.

This harassment continued this year despite the country's Covid19 lockdown and is particularly worrying when considered alongside the force used against the post-explosion protests.

## **Israel and Palestine**

#### UAE-Bahrain-Israel agreement

The United Arab Emirates (UAE) and Bahrain have signed agreements to normalise relations with Israel, without a resolution of Israel's decades-old conflict with Palestinians, who have condemned the agreements.

While some have hailed this as a diplomatic achievement, many Palestinians believe it is a broken promise by Arab states who have embraced ties with Israel without the creation of Palestinian statehood.
