# FUNDRAISING UPDATE



#### **March 2021**

Amnesty International's 60<sup>th</sup> birthday is coming up in May. This is the perfect opportunity to organise a fundraising event celebrating the achievements of the movement and committing to the challenges that we face in the modern world. All going well, the UK will be partially emerged from lockdown by this point and you'll be able to hold events in the real world again! This month's mailing features some ideas of events you could organise to celebrate the birthday of our movement and also some stories from groups who have already organised successful fundraising events.

### 60th Birthday Fundraising Ideas

- **60km for 60-Years:** sponsored walks are great Spring/Summer fundraisers. They're easy to make socially distant, cheap to organise and there's an easy way to link them to our birthday by using the number 60 (or 6 if 60 is a bit much!) For a one-day event, all you need to do is agree on a route near you and recruit people to walk it on a set day. Alternatively, you could take on a challenge as a group to cover a 60km distance over a set period. Maybe 2km a day for the month of May?
- **60 questions for 60-Years:** fundraising quizzes are always popular the Woking group recently had success with one they ran over Zoom. They are fun and accessible so are the perfect fundraiser for a birthday celebration. All you need to do to put on a quiz is a venue (or streaming platform!), a question master to write/read out the questions and teams to pay to enter and compete. You could have sixty questions to link it Amnesty International's 60<sup>th</sup> birthday but that isn't essential.
- **Sing for Sixty:** live music, either streamed or performed in person at a venue always works well as a fundraising event. It's unlikely that you'll be able to get people into a venue by May, but streamed events have worked well for many groups see previous fundraising updates for more details so you could go down that route. You'll need contacts who can perform if you're running a music events and someone who's confident enough with IT to setup a stream though we can help with that if you're struggling.
- **Other ideas:** there's loads of events that might work for a 60<sup>th</sup> birthday fundraiser so please feel free to come up with your own ideas! Let us know what your group comes up with and we'd be happy to see what we can do to help.

Whatever it is you do to raise money on our 60<sup>th</sup> birthday, we can help you by offering advice, promote your events to the wider public and offering free fundraising materials, including contactless collection devices. You can use the <u>Just Giving platform</u> to setup a fundraising page to work with all of these events. These allow you to take donations, claim Gift Aid and keep a live fundraising total to see how your event is going.

### Church Stretton's 60th Birthday Sponsored Walk

One group are ahead of the game and have already organised a 60<sup>th</sup> birthday fundraiser. The Church Stretton Amnesty Group held a 50km sponsored walk through the Shropshire Hills for Amnesty International's 50<sup>th</sup> birthday back in 2011 that raised over £2000 and they're following that up with a 60km walk this May to mark our 60<sup>th</sup>. We can't wait to see how this year's event goes!
