Covid 19 and UAE prisons

On 22nd February, several human rights organisations called on the UN to take urgent action to remind the UAE authorities of their responsibilities to introduce preventative and protective measures against Covid 19 in their prisons.

This includes the immediate and unconditional release of prisoners of conscience.

The absence of sanitation products, the impossibility of social-distancing in vastly overcrowded cells, and the notorious lack of medical care put prisoners in an extremely vulnerable position. Princess Latifa and other women detained in the UAE.

Many human rights organisations are appealing for the release of Princess Latifa and using this to highlight prisoners of conscience being held well beyond the end of their sentences, including two women.

Sadly, the implication is that once Ahmed Mansoor completes his sentence, he'll be held in a "counselling centre" and not released in March 2027 as he should be according to the law in the UAE.

Refugee Rights

The main news for this month is around the evaluation of the I Welcome Refugees campaign. It ran from 2016 to 2020 and explored new ways of working, focusing on collaboration, local mobilisation and a strong communications strategy to call for refugee rights and welcome refugees in the UK.

Key elements of this campaign focused on the launch of the Families Together coalition in 2018, as well as Football Welcomes. I Welcome becomes Amnesty UK's highest-profile campaign: potential audience reach 950 million. Our group took part in several events and actions, gaining 100s of signatures for petitions and providing opportunities for local residents to express their welcome to refugees.

At the evaluation webinar last week, Tom Davis, Global Campaign Manager, highlighted that holding the line for refugee rights in the coming year will be an achievement in itself, recognising



the challenges on the horizon. The upcoming Immigration Bill, in whatever format it will take, is likely to be another attack on refugees, weakening their rights and making it easier to remove and deport people with unstable legal status.

Upcoming events – April sees us celebrating a month of Football Welcomes, we're busy trying to finalise activities and events with the National Football Welcomes but we hope to bring you a panel discussion, an interactive and online exhibition among other things! Keep an eye out on our social media for more information once we've had everything confirmed.

Historic ICC ruling brings new hope to victims of crimes under international law

In early February 2021, the International Criminal Court announced that it had confirmed that it has jurisdiction to investigate possible war crimes in the West Bank, including East Jerusalem, and Gaza.

The ruling opens the way for an investigation into crimes committed in the OPT since June 13, 2014. These include allegations against Israel of war crimes, including settlement-related activities, and crimes against humanity, such as persecution, deportation and transfer, as well as the crime of apartheid against Palestinian civilians in the West Bank, including East Jerusalem; crimes allegedly committed by Israel and Palestinian armed groups during the 2014 assault on Gaza and during the Great March of Return protests in 2018-19; and allegations against the Palestinian authorities in the West Bank of torture and support for attacks against Israeli citizens.

Tawfiq Abu Jame' is one of just three survivors of an Israeli air strike in Gaza which killed 25 members of his family, including 19 children, on 20 July 2014. He told Amnesty what an ICC investigation would mean to him:

"[An investigation] would not, for sure, bring my kids back to life, however I am certain that I need to continue to try to find some sort of justice. It is shocking to me that six years after I lost so many members of my family and my house that impunity reigns supreme for those implicated in the tragic crime committed [....] We can never achieve justice in Israeli courts, the ICC represents our only hope to achieving long-denied accountability and justice."

SYRIA

Justice For Syria -First Conviction

Last year we reported that a former Syrian security officer, Eyad al-Gharib, was subjected to trial in the Higher Regional Court in Koblenz, Germany, after having been arrested in Feb 2020 by German and French police. The charges against him were that of 'aiding and abetting the torture of detained protesters in Damascus'. The prosecutors applied the principle of universal jurisdiction.

On 24th February we received news that the Higher Regional Court in Koblenz has sentenced Eyad al-Gharib to four-and-a-half

years in prison.



Lynn Maalouf, Amnesty International's Deputy Director for the Middle East and North Africa, said: "Today's historic verdict – the first of its kind for crimes under

international law committed by a Syrian government official- is a resounding victory for the tens of thousands of Syrian torture survivors and victims of enforced disappearance as well as for Syrian and international human rights and litigation organisations who together, for years, have fought relentlessly for truth and justice".

"During these ten years, the international community has consistently fallen short of taking concrete action in the face of ongoing egregious violations and to hold those responsible accountable.

"We call on more states to follow Germany's example by investigating and prosecuting individuals suspected of committing war crimes or other crimes under international law in Syria through their national courts under the principle of 'universal jurisdiction'. We also reiterate our call to the UN Security Council to urgently refer the situation in Syria to the International Criminal Court to ensure that perpetrators from all parties to the conflict – including those 'most responsible' - high-ranking officials and commanders - face justice."

MYANMAR

Death Of Protester

Responding to news of the death of Mya Thwe Thwe Khaing, a 20-year-old woman who was shot in the head by Myanmar police during protests in Nay Pyi Daw on 9 February, Joanne Mariner, Amnesty International's Director of Crisis Response, said:

"This is the devastating consequence of the security forces' reckless use of lethal weapons against peaceful protesters.

"Instead of issuing blanket denials, the Myanmar military authorities should launch a prompt, thorough, independent and impartial investigation into her killing and other reports of unnecessary and excessive use of force by the security forces.

"As protests continue to grow, Myanmar security forces must cease carrying and using lethal weapons and must respect people's right to peacefully express their grievances.

"It is only a matter of time before the same brutal and abusive policing leads to more death and sorrow."

This is a good example of such abuse. The UN Basic Principles on the Use of Force and Firearms by Law Enforcement Officials state that security forces must exhaust all non-violent means before employing force as the last resort.

YEMEN

Amnesty's Oral Statement at 46th UN Human Rights Council

Given the serious violations of human rights committed by all parties in the conflict in Yemen, including arbitrary and incommunicado detention, torture and other ill-treatment, during the 46th UN Human Rights Council, Amnesty International has called on the UN Security Council to refer the situation in Yemen to the International Criminal Court. This would open the way to accountability for violations of international human rights and humanitarian law. Campaigns

Normally, we receive a Planning Pack for the year outlining campaigns that we can get involved in. This is not available this year, however we know that the AIUK priorities for this year include:

Legislative threats to human rights in the UK, e.g the human rights act and through the Overseas Operations Bill, the Covert Human Intelligence Services Bill and the Counter Terror bill.

Syria - marking 10 years of the Syrian conflict (March)

Refugees - family reunion, campaigning (from May) and Football Welcomes (April)

Israel/OPT – campaign around the forthcoming IS report on Israel/OPT institutional discrimination, due on 5 May.

Covid –which could involve workers' rights in the gig economy (from May); the IS report on Covid and UK prisons (due in March); care homes and vaccines.

Individuals at Risk: Work on individual cases is always key to our work and we are encouraged to sign up to work on individual cases and world regions. Currently we work on 2 cases in the UAE and the Europe world region (including Turkey). We also get involved in Crisis and Tactical campaigns which currently includes Syria, Palestine, Yemen and Myanmar. We always take part in the Write for Rights campaign in the run up to Christmas.

We need to discuss where we will concentrate our efforts and decide who is going to take a lead in each area. For a major campaign we would hope that we can form a subgroup to help the lead plan the work of the group – we currently have subgroups running for our Palestine/OPT and UAE work and it would be good to get a subgroup going to support our Refugee work.

If you would like to get involved, either as a campaign lead, as part of a subgroup – let us know.


Amnesty Live! International Women's Day

Migrant policy in the NHS

We've been contacted by a group within Greater Manchester Keep Our NHS Public who are concentrating on ending the "Hostile Environment" for migrants policy in the NHS in Greater Manchester.

As a first step, they have written to Council Leaders and Chairs of Health & Wellbeing Boards in all the 10 boroughs of Greater Manchester and the Greater Manchester Mayor, outlining the consequences to migrants being charged for NHS services and their being subject to patient data sharing, between local NHS Trusts and the Home Office.
