# Amnesty's response: a quick guide to the survey questions

This quick reference table outlines how Amnesty will respond to the New Plan for Immigration consultation. Our responses may help you formulate your own answers. **QUESTIONS 40-44:** inviting comment on Equalities Act considerations

Amnesty's response: We respond briefly to these questions but believe they are not suitable for a consultation

of this type.

## Amnesty's response: a quick guide to the survey questions

#### Survey 2: New Plan for Immigration – Further detailed questions

**QUESTION 1:** Inviting additional feedback on various aspects of the what is presented as the overview to the Home Office 'plan'

**Amnesty's response:** Comments, stressing that the UK's immigration and asylum systems will only be further undermined by these proposals. See full response here

**QUESTION 2:** on safe and legal routes **Amnesty's response:** Decline to answer.

**QUESTION 3:** on integration of people recognised as refugees in the UK.

Amnesty's response to each part of the question: Strongly agree.

**QUESTION 4:** inviting further feedback on proposals on safe and legal routes.

**Amnesty's response:** We explain how the proposals would not improve protection for refugees, and would be detrimental, harmful and in some cases unlawful. <u>See full response here</u>

QUESTION 5: on removing or reducing registration rights of stateless UK-born children.

Amnesty's response: Strongly disagree.

**QUESTION 6:** on amending naturalisation law to increase discretion to grant naturalisation (particularly to victims of Windrush scandal).

Amnesty's response: Agree.

**QUESTION 7:** Inviting further feedback on proposals in Chapter 3 (nationality law).

**Amnesty's response:** The proposals do not go far enough and there are more problems the Home Office has the power to correct. <u>See full response here</u>

**QUESTION 8:** on a two-tier asylum system (excluding or reducing rights for people for whom there are no safe and legal routes provided)

Amnesty's response: Government should not create a two-tier asylum system. See full response here

QUESTION 9: on a more restrictive standard of proof to establish someone is at risk of persecution.

Amnesty's response: This is a particularly dangerous proposal. See full response here

**QUESTION 10:** on proposals to restrict admission to the UK asylum system and reduce rights for people admitted to that system

Amnesty's response: We decline to respond.

**QUESTION 11:** *Invites comment on plans for a new National Age Assessment Board* **Amnesty's response:** Not at all effective.

**QUESTION 12:** *Invites view on Local Authorities undertaking age assessments or NAAB referrals.* **Amnesty's response:** Not at all effective.

**QUESTION 13:** on proposals to give wider license for immigration officers to refuse to accept a person is or may be a child.

**Amnesty's response:** Not at all effective.

#### Survey 2 (contd): Further detailed questions

**QUESTION 14:** on proposals to replace judicial review with appeal rights against age assessment decisions.

Amnesty's response: Not at all effective.

QUESTION 15: Inviting further feedback on proposals in Chapter 4 (various asylum proposals).

Amnesty's response: We will supplement points made in our responses to 8 and 9.

QUESTION 16: on visa system and people whose visa expires or is cut short.

Amnesty's response: We decline to answer.

QUESTION 17: on a 'one-stop asylum process'.

Amnesty's response: Comments on past experience and problems that lie with the Home Office itself.

**QUESTION 18:** Requests further feedback on proposals in Chapter 5 (asylum claims and appeals).

**QUESTION 20:** on civil penalties and border security in relation to goods vehicles.

Amnesty's response: Decline to answer.

QUESTION 21: on civil penalties for haulage sector and others.

Amnesty's response: Decline to answer.

**QUESTION 22:** relates to Question 22. **Amnesty's response:** Decline to answer.

QUESTION 23: Invites further feedback on proposals in Chapter 7 (haulage sector, civil penalties etc).

Amnesty's response: The proposals fail to address why people fleeing persecution and/or seeking family

reunion must rely on smugglers and/or irregular journeys. See full response here

#### **QUESTIONS 24-25:**

**24:** Invites view on notice period before someone is removed.

25: Relates to Question 24.

**Amnesty's response to 24 and 25:** People facing forcible removal must be given sufficient opportunity to obtain legal representation. Their circumstances must be carefully evaluated. <u>See full response here</u>

QUESTION 26: Invites further feedback on proposals in Chapter 8 (removal from the UK).

**Amnesty's response:** Existing approaches to removing people are flawed; the plan does not correct this. Reform of the system is needed. See full response here
