Actions you can take this month:

✓ **Sign the petition** calling on the UK government to secure the release of British-Iranian **Anoosheh Ashoori** and bring him home. Anoosheh Ashoori is a retired British-Iranian who has been arbitrarily imprisoned in Iran for almost four years. His family are worried for his health and want him back home with them in London. Go to the home page of the AIUK website to sign the petition – www.amnesty.org.uk



- ✓ Send a letter by post or email to the President of Venezuela. On 10 February, five staff members from Azul Positivo, a medical and humanitarian NGO in Zulia (Western Venezuela), were conditionally released from detention. Johan León Reyes, Yordy Bermúdez, Layners Gutiérrez Díaz, Alejandro Gómez Di Maggio and Luis Ferrabuz remain charged with financial crimes and 'association to commit crimes' and must report themselves to court every 30 days. Al considers them to be prisoners of conscience as their prosecution appears to be solely based on the humanitarian work they do for Azul Positivo. Alison and Cherry recently listened to an inspiring on-line presentation on the **Schools Human Rights Conference 2021.** *Alison writes:* Peter Radford, Founder of Beyond This (www.beyondthis.co.uk), is an Amnesty school speaker and former head teacher who works to promote understanding of human rights within schools and organisations. He spoke of his vision to supplement the 'academic machine', that our education system has become, to help young people better prepare for life in terms of responsible citizenship and political awareness. One of the ways he has promoted this is through the UNICEF Rights Respecting Schools award, for which he is an assessor.

In 2019 Peter organised a 'Stand Up' conference for secondary schools on human rights, with the aim of engaging young people and empowering them to use their voice in constructive ways. He wants to break away from the polarisation created by social media 'echo chambers' and enable debate and understanding based on listening. He is organising another on 21 September this year, which will focus on racism and equality. [Alison has written to our local

college about this, but has had no response as yet.]

Campaign News

India and Nepal Cherry writes: Amnesty India Office Shutdown - The office remains closed and Amnesty is continuing to work globally for release of their assets, with no progress to date. At the European Parliament, Rajat Khosla, Senior Director for Research, Advocacy and Policy at AI, expressed grave concerns about the increasing clampdown by Indian authorities on human rights, with civil society under more pressure and human rights defenders facing harassment, intimidation, arrest and detention under 'anti-terror' and foreign funding laws. Students, activists, journalists, lawyers and peaceful protestors critical of the government are targeted. Meanwhile impunity is granted to the police and army. Concerns have been expressed by a number of NGOs, including Amnesty, about the invitation extended to India to join the **G7 gathering** in June as a member of the 'democratic 10' invitees. This is particularly relevant as one of the priority themes of the meeting is open societies!

Modern slavery in India: Currently, debt slavery or bonded labour is the most common method of enslavement globally, with more than 8 million people bonded to labour illegally. The practice is prevalent in south Asia, even though most countries in the region are party to the UN convention on the abolition of slavery. Bonded labour produces goods ranging from frozen shrimp to bricks, diamonds and clothing.

Estimates range from 20-40 million workers, mainly children, working through debt bondage in India alone, with some 40,000 working as brick kiln workers. The International Labour Organisation estimates that more than \$51 billion is

made annually in the exploitation of workers through debt bondage.





Information Technology Bill Threatens Freedom of Expression

In a country that, not so long ago, was envied across the region for its openness to different opinions and criticism of authorities, it is sad to see that **Nepal**'s proposed IT Bill will empower the government to censor online/ social media content, punishing offenders with up to five years in prison and fines equivalent to around \$13,000. It has provoked widespread criticism from civil society, which is calling for amendments to bring it into line with international standards and ensure it is not used to criminalise peaceful exercise of the right to freedom of expression.

Changes at the top of Amnesty International

At the end of March, a new **Director General of AI** was appointed – **Dr Agnes Callamard**, a French national, who has had a distinguished career in the international human rights and humanitarian sectors, working across NGOs, academia, and the United Nations. Recently she was the UN Special Rapporteur on extrajudicial, summary or arbitrary executions. Dr Callamard worked with AI from 1995-2001, including as Chef de Cabinet for then-Secretary General Pierre Sané. She has led human rights investigations in more than 30 countries and published extensively on human rights, women's rights, freedom of expression, refugee movements, and the methodology of human rights investigations.





Kate Allen, Director of AlUK, has recently announced her retirement in September, after 21 years leading the UK Section. We have sent her a card (a picture of Minehead by local artist Leo Davey) from the group, thanking her for all her work for Amnesty over the years.
