Human Rights in the UK Stop the Rights Raid Week of Action



The various pieces of legislation which will significantly affect rights in this country are continuing to progress through parliament and during the week of $10^{th} - 17^{th}$ October Amnesty held a week of action (in conjunction with many other organisations) throughout the UK to draw attention to this raid on our rights.

We did our bit and hope that we have made a difference:

We had hoped to have a meeting with Lucy Powell MP as well but there was a diary mix-up but we hope to reschedule. Turkey

Welcome acquittal of all Pride participants: "A victory that should never have been necessary."
Responding to the decision of Ankara Criminal Court of First Instance No. 39 to acquit 18 students and an academic who were prosecuted for taking part in a campus-based Pride parade in May 2019. Massimo

Moratti, Amnesty International's Europe Deputy Director said: "More than two years ago, a peaceful Pride march in Ankara was met with police using pepper spray, plastic bullets and tear gas, and participants were rounded up and dragged through the courts. Today's verdict is a victory for justice, but this protracted legal battle should never have happened. "

Today we take a moment to rejoice but tomorrow we will continue the struggle to end the crackdown on human rights in Turkey, and redouble our efforts to protect freedom of expression and peaceful assembly.

Malta

Three youths risk life in prison for their roles in helping fellow asylum-seekers escape torture.
Call for justice for The El Hiblu 3. Call on the Maltese Attorney General to drop all charges against The El Hiblu 3 and close the case before trial.

UAE Update

More good news!

Cambridge University announced that they have paused talks with Dubai about a 400M deal because of concerns about the use of spyware by the UAE government on UK mobile numbers. Thank you to members who wrote or asked contacts who were alumni of the university to write to the Dean.

Fatih and Kathryn met with two people from the UAE desk at the Foreign, Commonwealth and Development Office (FCDO) in London on Friday 28th October, along with Oscar Jenz, the

Amnesty co-ordinator for the UAE. We shared our concern for the well-being of Mohammed Al-Roken and Ahmed Mansoor; that both men have been in solitary confinement for over 4 years and as far as we are aware, do not have a mattress or clean water. It was a constructive discussion and a couple of promises were made to us about broaching the subject with authorities in the UAE. We were also given advice on how we could be more effective in our work.

We hope to keep a dialogue open with the FCDO in the future.

Crisis and Tactical

Syria



March 2021 marked the 10th anniversary of the start of the Syrian conflict. As Amnesty International stated, even now parties to the

conflict continue to commit, with impunity, "serious violations of international humanitarian law, including war crimes, and gross human rights abuses".

As recently as October 2021, in a briefing to the UN Security Council, the UN Under-Secretary-General for Humanitarian Affairs and Emergency Relief Coordinator, Martin Griffiths, spoke of a humanitarian crisis that continues to worsen. He noted increasing poverty, a water crisis, growing food insecurity, and increasing attacks against civilians.

On **Monday 8th November at 6.30pm**, Manchester Amnesty group will be holding an online event focusing on Syria. At the November meeting, speakers from *Amnesty International UK* and *Rethink Rebuild Society* (a Manchester-based charity that works towards improving the lives of refugees, asylum seekers, and immigrants), will provide updates on the situation in Syria and how we can support their work.

An important part of our support for Syria is fundraising for both Amnesty and Rethink Rebuild. 

Refugee Campaign

At our October meeting, Quentin Duflos (a previous member of Manchester amnesty) gave a presentation about his work as a legal caseworker with young unaccompanied minors near Calais. He also updated us on the situation for migrants in Calais, which continues to result in the denial of basis human rights and a rising death toll. Since 1999, 304 people have died at the Franco-British border and Quentin reports that the situation is not improving. Currently, some of the volunteer workers at Calais are on hunger strike in protest at the treatment of the migrants who they are trying to help. On a more positive note, Quentin reminded us about the Walk with Amal, which reached Calais soon after he spoke to us & he sent these photos when the Calais Amnesty group went to meet her:

You may have already seen coverage of the Walk with Amal in the UK media recently. At the heart of *The Walk* is 'Little Amal', a 3.5 metretall puppet of a young refugee girl, created by the acclaimed Handspring Puppet Company. Representing all displaced children, many separated from their families, Little Amal is travelling over 8,000km embodying the urgent message "Don't forget about us".

Little Amal's journey will be ending in Manchester on Wednesday 3rd November at 7pm in Castlefield Bowl. Manchester International Festival are organising the event which unfortunately is now sold out. However, it may be worth checking on this link to see any last minute tickets become available.

Anti-Racism

Anti-racism subgroup

At our first meeting we discussed three possible strands of our anti-racism work:

- Education on anti-racism for ourselves
 & group members we decided to read the book 'Me and White Supremacy' by Layla F. Saad with a view to using sections and exercises from the book in group meetings during the year ahead.
- We also hope to take advantage of any training workshops that may be provided by AIUK over the next 12 months.
- Anti-racism campaigning Mary Gibbs updated us on the work already carried out with regard to Greater Manchester Police and their response to the Black Lives Matter movement, specifically the over-policing of people of colour within GM. This is on-going work and we will

be working out how best to respond following the recent Achieving Race Equality report commissioned by Andy Burnham, which found GMP to be 'institutionally racist'. Despite the evidence contained in the report, Stephen Watson, the chief constable of GMP since May 2020, has rejected this finding.

 Making links with other local antiracism campaigning groups – we discussed a range of possible anti-racism groups that it may be useful to contact & explore ways of working together on local and/or national anti-racism campaigns. Groups discussed included Black Lives matter, Manchester stand Up to Racism, Runnymede Trust, UK Is Not Innocent.

This was a shocking and frightening experience for all the members of the synagogue as well as the wider Jewish community in Greater Manchester. Along with many individuals and organisations in Manchester, we have sent a message of support and solidarity to the synagogue congregation via Twitter and also by email to Rabbi Robyn who was present at the service. All the messages were gratefully received by the synagogue & they responded with their own message, 'Together we are stronger'.


