## Write for Rights

Every year in November and December, Amnesty International runs a global campaign to show solidarity for 10 people and organisations around the world enduring human rights abuses. It only takes a few minutes to write a letter or card, send an email or social media message, or sign a petition but for an environmental activist facing a long prison sentence, a citizen journalist detained for reporting on the pandemic, or an LGBTI organisation suffering homophobic attacks, these simple gestures have a powerful impact. As past campaigns have shown, our messages of solidarity – alongside those of fellow Amnesty supporters across the globe – are a great source of comfort and support for people doing the difficult and often dangerous work of standing up for human rights. Our letters, words and actions also put pressure on the authorities to take action to free prisoners of conscience, protect the vulnerable, and bring perpetrators of human rights abuses to justice.

The Stop the rights Raid campaign is on-going. We expect to be asked to take more actions, especially when the long-awaited report of the review of the Human Rights Act is published.

## UAE Update

### Concern over appointment of Emirati to head of Interpol

Human rights organisations and MEPs have expressed deep concern about the recent appointment of General Ahmed Naser Ak-Raisi as president of Interpol. He is the inspector general of the United Arab Emirates' interior ministry and has recently faced complaints of torture, filed in France and Turkey. One of these is from the British national Matthew Hedges who was detained in the UAE in 2018 on false charges of

espionage during a study trip for his PhD. He claims to have been tortured during his detention. Another complainant is the British citizen, Ali Issa Ahmad who was accosted and detained for wearing a Qatar football shirt. Interpol has the right to issue red notices – a call by one country for the arrest of individuals in another country. Human Rights organisations are concerned that Raisi's election will increase the risk of Interpol allowing abusive states to use politically motivated 'red notices' to pursue political vendettas.

## Europe and Turkey

### Italy

Healthcare workers in Italy who raised concerns about unsafe working conditions in care homes during the Covid-19 pandemic have been subjected to disciplinary proceedings and retribution from their employers. A new report from Amnesty International has underlined how employers attempted to silence workers with dismissal and anti-union measures for raising awareness of the issue, with over a third of

those interviewed by AI reporting “a climate of fear and retaliation” in the workplace.

Amnesty calls on the Italian parliament to set up an independent commission of inquiry into the situation at residential facilities, along with the serious concerns raised by staff about their working conditions during the pandemic.

### Poland

There were mass protests in Poland last month after a pregnant woman died following a refusal to grant her access to an abortion, despite multiple scans demonstrating the foetus was incompatible with life. Named only as Izabela, the 30-year-old woman suffered septic shock when the foetus died in the 22nd week of her pregnancy, during which time multiple medical professionals had confirmed as the foetus as

incompatible with life, but refused to perform an abortion whilst they still detected a heartbeat. Poland has the most restrictive abortion laws in Europe, and removed last year the last legal access to abortion on grounds of fetal abnormality. ### Austria

Amnesty International has produced new research about the exploitation and poor working conditions of migrant care workers in Austria, the majority of whom are women who work as live-in carers for the elderly. These conditions have reached breaking point as a result of the pandemic, and have been compounded by a lack of access to minimum wage, working hours’ protection and access to sick pay. 98% of live-in care workers are self-employed, so do not obtain these benefits, leading to a wide disparity in working and living conditions for those in the industry.

### Turkey

We reported last month on the acquittal of Özgür Gür, Melike Balkan and 17 other defendants on charges brought following the break up by police of the Pride sit-in at the Middle East Technical University (METU) in 2019. ## Crisis and Tactical

### Syria

Manchester Amnesty's November meeting was a special event, featuring guest speakers and a raffle. Many thanks to our invited guest speakers, Dr. Haytham Alhamwi, from Rethink Rebuild Society, and Kristyan Benedict, from the Crisis and Tactical team at Amnesty International UK.

Both speakers brought different perspectives on the ongoing crisis in Syria, and we are grateful that they were willing to share their expertise and experiences with us. Kristyan spoke on Amnesty's advocacy work and their support for justice and accountability, including strategic litigation. He also noted Amnesty's role in providing training and strategic advice.

Kristyan referenced the legal work being done in Germany, which has been reported by Amnesty, including in this February 2021

Noting that the Syria conflict has been ongoing for over 10 years, Haytham generously provided the group with a brief history of the conflict, addressing the military situation, the

geopolitical factors, the economic position, and humanitarian concerns.

When asked what Manchester Amnesty members can do, either individually or as a collective, Haytham suggested:

- Campaign against the return of refugees
- Campaign for humanitarian access to be maintained/restored
- Advocate for the rights of detainees
- Call for accountability.

The raffle prizes for the Syria evening were generously donated by members of Manchester's Syrian community and members of Manchester Amnesty. We were thrilled to have so many people attend the meeting and buy raffle tickets.

We sold 147 tickets and raised £735. Of this, £366 has been given to Rethink Rebuild Society and £366 will be forwarded to AIUK via Manchester Amnesty group funds.

### Refugees

Following on from the appalling loss of life in the English channel and the government's response to this tragedy, an emergency demonstration was called, which took place in St Peter's Square on 28<sup>th</sup> November. Despite the

## Palestine

In mid November, Amnesty produced a major new report on the role of the UK digger company JCB in manufacturing and selling equipment which is used in the destruction of homes and the construction of illegal settlements in Occupied Palestinian Territories. These actions deny Palestinians their human rights, including the right to housing.

## Anti-Racism

### Anti-racism subgroup

The anti-racism subgroup is currently meeting every 6 weeks and discussing 3 areas of work:

- Education for ourselves and the wider group
- Anti-racism campaigning
- Links with local anti-racism organisations

We are currently reading the book, 'Me and White Supremacy' by Layla F. Saad, which we are all finding very interesting and a challenging read in terms of exploring our own white privilege and the systems that support it. We have decided to work steadily through the book and will be discussing the first section called 'The Basics' in our next meeting.

Mary Gibbs continues to co-ordinate our campaigning work, which is focused on Greater Manchester Police and issues of racial disparities in policing. We are currently working out how to move this campaign forward and are considering ways of working alongside other anti-racism organisations.

Several Manchester Amnesty members attended a demonstration in St Peter's Square organised by Manchester Stand Up to Racism

and Care for Calais following the deaths of 27 people in the English Channel as they tried to reach the UK. It felt important for Manchester Amnesty to stand in solidarity on this tragic occasion alongside many other Manchester organisations who work to support refugees and asylum seekers as well as organisations working for anti-racism.

Three of us also attended a recent online meeting with Manchester Stand Up to Racism, which was called in order to start building support for the UN Anti-Racism Day 2022. This takes place on Saturday March 19<sup>th</sup> so please get the date in your diaries!

We would very much welcome more members in the Anti-Racism sub-group. We welcome anyone who would like to learn alongside us as we develop this part of Manchester Amnesty's work. There is no expectation of anti-racism expertise – we are all learning as we go and also making mistakes along the way so please feel free to join us! ## Group News

### Results of group survey on meetings

Thank you to everyone who took part in the survey for all members about our meetings (timing, format, content etc.) for 2022 onwards. We had 25 responses in total with the following findings:

- The majority of people (18 out of 25) want a mixture of online and in-person meetings and can see the benefits of both formats.
- The majority of people would prefer online & in-person meetings to start at 7.00pm. (The majority was smaller for online meetings than in-person).
- The responses showed that members like to have a range of different types of meetings. Visiting speakers, campaign planning & education workshops were all very popular. Craftivism and letter-writing attract a smaller number of people but still enough to make them an important part of the group's work going forward.

Following a co-ordinators' meeting, we have decided to **change the start of meeting times to 7.00pm from January 2022.**

### Newsletter and weekly action emails – future plans

At a recent coordinators meeting we discussed the possibility of modifying the format and frequency of the group newsletter and the weekly action email. The suggestion is to make the weekly action email the main vehicle for conveying news of events and group activities

We will maintain a mix of online and in-person meetings & activities throughout 2022 but we have decided to keep all our monthly group meetings online for the time being. This will be reviewed every few months as the Covid situation changes.

We will continue to provide speakers, campaign planning & workshop style meetings. However, if we want to have regular speakers from outside Amnesty, we decided that we need to consider making a donation to their organisations as well as covering any expenses. We will discuss this in more detail at our AGM in March 2022 but it is likely that we will set up a specific fund to cover this, which will be part of our suggested annual subscription for all group members.

Following some specific feedback in the survey, we have also decided that any photo actions will take place at the end of online meetings so that people do not feel under any pressure to participate. We fully understand that there are a variety of reasons, including people's personal safety, which mean that individuals would prefer not to be included in photo actions and we don't want anyone to feel under any pressure to participate.

So it would be useful if members could think about what they get out of the newsletter and weekly action emails ahead of the AGM which will take place in March, where these proposals will be discussed.
