### Human Rights in the UK

#### Nationality and Borders Bill

Thank you if you contacted your MP about the Nationality and Borders Bill, as requested in our December newsletter. This Bill is currently being scrutinised by the House of Lords. Amnesty believes that the Bill seeks to largely shut down the UK's asylum system and criminalise and punish refugees from around the world.

#### Police, Crime, Sentencing and Courts Bill

The House of Lords has voted out some of the restrictions on protest in the Policing Bill – the government lost every single vote. This is a huge victory so thank you to all of you who have already taken action on this issue.

Amnesty is concerned that a few of the amendments (especially ones banning noisy or annoying protests) could still be put back when MPs debate the Bill in February.

#### **Human Rights Act**

In December, the government announced a consultation on the future of the Human Rights Act (HRA). Their proposals go far beyond the recommendations from their own panel of experts and Amnesty believes that they threaten to undermine human rights protections in the UK for everyone. This is a power grab by the government.

The proposals would dramatically weaken people's ability to hold the executive to account and defend themselves from rights violations by the state. They would place huge power in the Executive, at the head of a large parliamentary majority, and would put the less powerful or influential in society in a vulnerable position.



AIUK are busy preparing a defence of the HRA and we will hear more shortly.

However, the government is asking through their consultation what people think about these proposals and we will be encouraged to tell them! More details on how to do this will appear on the AIUK website from 14 February and we'll let you know through the Weekly Action email.

### **UAE Update**

Members of the European Parliament have written an open letter to the Emerati government calling for indefinite detention to be stopped in the UAE.

As of April 2021, nine prisoners of conscience have continued to be detained in the UAE after serving their full sentences. Instead of being released as is their right in both international and UAE law, they are transferred to 'Munasaha centres'. These are 'counselling' centres and are based within the prison facility. They remain unable to leave or receive calls or visits from outside. It is thought that the Emerati authorities are using these centres as political tools to silence all forms of criticism.

#### **Sportswashing**

### Further feedback on December 'Write for Rights' event

We have received the final totals of letters and cards written at the December Write for Rights event in Whalley Range, organised by the Whalley Range Peace and Justice Group. As in previous years, we were invited to have an Amnesty stall at which we sold Christmas cards and other seasonal goods, and highlighted the plight of Uyghur children separated from their families with a letter that people could sign. We would like to thank Whalley Range Peace and Justice for inviting us and congratulate them for putting on such a successful "in person" event. Far exceeding the rough calculation mentioned in the December newsletter, a total of 797 actions were taken in relation to the 10 cases in the Write for Rights booklet. Of these, 511 were letters, cards or messages of support to the individuals under threat, and there were 286 letters to authorities demanding action. Thanks to our members who supported this event.

### Syria

In light of the successful Amnesty Manchester event on Syria last year, an update on the campaigns discussed and the situation in Syria:

Relatedly, the first worldwide case of torture in Syria was held in Germany. In January 2022, the Koblenz Higher Regional Court convicted a senior Assad government official, Anwar Raslan, to a life sentence for crimes against humanity in Syria. He was linked to the torture of over 4,000 people in a jail known as "Hell on Earth". Raslan was found to have "verifiably overseen" the murder of at least 27 people and the torture of over 4,000 people. Also listed in Raslan's crimes against humanity are 25 cases of dangerous bodily harm, two cases of rape and sexual coercion, two cases of sexual abuse, 14 cases of deprivation of liberty lasting longer than a week, and two cases of kidnapping. Following the verdict, Amnesty International's Deputy Director for the Middle East and North Africa, Lynn Maalouf, called on states around the world to

> "follow Germany's lead and initiate similar proceedings against individuals suspected of committing crimes under international law. With domestic criminal prosecutions in Syria inconceivable and no pathway for referring cases to the international criminal court, universal jurisdiction is the only way to achieve justice."

### Refugees



We had an excellent turnout of 27 people at our demonstration outside the Polish consulate in Manchester on 15<sup>th</sup> January. Thanks to all who supported this event. We were protesting against the suffering of men, women and children trapped outside in the freezing cold, without shelter, food or access to health care, in the forested and swampy area between Poland and Belarus. Many of these people have fled war and persecution in Afghanistan, Syria, Yemen and Iraq, and include pregnant women, small children, elderly and injured people. In the absence of legal routes to flee, they have been enticed to enter Belarus in the hope of entering the EU, only to find themselves unwanted, trapped in a no-man's land, subject to brutal treatment and push-backs by the Belarussian and Polish forces alike. We demonstrated to demand immediate access to these vulnerable people by NGOs and humanitarian organisations, and the recognition of their right to apply for asylum.

## ISRAEL'S APARTHEID Against Palestinians

CRUEL SYSTEM OF DOMINATION AND CRIME AGAINST HUMANITY



Amnesty have recently launched a major new campaign with the publication of a report entitled "Israel's Apartheid against Palestinians."

The decision to use the word "apartheid" came after intensive research and expert legal analysis. The new

report details how Israel enforces a system of apartheid against Palestinians wherever it has control over their rights. This includes Palestinians living in Israel and the Occupied Palestinian Territories, as well as Palestinian refugees currently in other countries.

## Tell Israel: Demolish Apartheid, Not Palestinian Homes

The first action in this campaign relates to the Palestinian experience of being denied a home. For over 73 years, Israel has forcibly displaced entire Palestinian communities and demolished hundreds of thousands of Palestinians' homes, causing terrible trauma and suffering. Today, *over 6 million Palestinians are refugees.* At least another 150,000 are at real risk of losing their homes. **Palestine** (continued). Every week, the Israeli authorities forcibly evict Palestinians from their homes, demolishing their houses and seizing their land for Israeli settlers. These acts form part of a systematic and widespread attack against the Palestinian population.

### Afghanistan

Amnesty has announced that it will be supporting an activist-led campaign on human rights in Afghanistan. At the moment, there are three strands to the campaign.

These are: 1) a focus on the rights of Afghan women, with a demonstration planned outside the Afghanistan embassy in London on 8<sup>th</sup> March – international women's day; 2) holding the government to its promise to resettle 20,000 Afghan refugees in the next 5 years via the Afghanistan Citizens Resettlement Scheme (ACRS), while also arguing that this scheme is nowhere near sufficient; and 3) a scheme to encourage local groups to sponsor refugee families.

Amnesty are also supporting calls for governments of the world to make a concerted effort to use their influence to require the Taliban to respect the rights of the women and girls. Click this link to sign a petition about this:


