Amnesty International UK's **Make a Will Month** is a great opportunity for you to get the important task of making or updating your Will out of the way.

To help you do this, we have partnered with the National Free Wills Network and Co-op Legal Services to provide a Free Wills Service for supporters like you.



We have also put together this guide, with advice to help make the process of making or changing your Will as simple and convenient as possible.

Most people who use the Make a Will Month scheme do kindly choose to leave a gift to Amnesty International UK in their Will. You don't have to but we hope you will consider it. Any gift, whatever its size, really is priceless to us – gifts left in Wills by our supporters now fund around 20% of our campaigns.

HOW TO TAKE PART

Our **Free Wills Service** makes it easy for you to write or update your Will at no cost to you*. Our hand-picked will-writing partners can help you prepare a 'simple' Will in person, online and over the phone. Simply choose the option which best suits your needs.

YOUR OPTIONS



IN PERSON WITH A LOCAL SOLICITOR

Our partnership with the National Free Wills

Network offers access to over 800 solicitors across the UK** and allows you to write or update your Will in person with a solicitor near to where you live.

- Request referral to the Network by completing and returning the enclosed form in the FREEPOST envelope provided
- The Network will send you details of your nearest participating solicitors
- Arrange an appointment with your preferred solicitor to discuss your free Will



BY PHONE AND ONLINE

If you live in England** or Wales, **our partnership with Co-op Legal Services** allows you to write your Will, in the comfort of your home, by phone and online, with a dedicated Wills specialist.

- Start your Will online by visiting www.co-oplegalservices.co.uk/amnesty and then you will get a follow-up call from one of their dedicated Wills specialists to answer any queries and finalise your Will
- Or call 0330 0417 799 to request a call-back to write your Will entirely over the telephone

*Both schemes cover the cost of a 'simple Will' which Amnesty International UK pays a discounted fee for. If your Will is more complex, any additional charges would be agreed between you and your chosen solicitor or Wills specialist. **The schemes are not available in the Channel Islands and Isle of Man.

SUGGESTED LEGACY WORDING FOR YOUR WILL

Here is some sample wording you may find useful if you do choose to leave a legacy to Amnesty International UK in your Will.

For a percentage of your estate after specific gifts and debts have been paid (a residuary gift):

"I give a % share of the residue of my estate to... (see wording below)

For a specific sum (a pecuniary gift):

"I give the sum of \pounds (words and figures) to... (see wording below)

Then add this wording:

...Amnesty International UK Section Charitable Trust, The Human Rights Action Centre, 17-25 New Inn Yard, London, EC2A 3EA, registered charity number 1051681 to be used for its general charitable purposes and I declare that the receipt of their Treasurer or other proper officer shall be a full and sufficient discharge."

YOUR WILL PLANNER

Before you start writing your Will, you can use this **simple Will planner** to work out the value of your estate, and decide who you would like to benefit from your Will.

YOUR BENEFICIARIES

Make a list of the family, friends and charities you would like to benefit in your Will and think about what you would like them to receive.

Your executors

These are the people who will ensure everything happens. You can have up to four executors. They could be friends or family or a solicitor.

Please note that Amnesty International UK cannot act as an executor of your Will.

LEGAL TERMS

Here is a short glossary of the legal terms you might find useful when making your Will.

An **administrator** is someone who is appointed by law to settle your affairs if you die with no Will.

A **beneficiary** is anyone who receives something from a Will.

A **bequest** (legacy) is a gift left in a Will. It can be:

- residuary: a gift of money or assets left when other legacies and expenses have been paid

 normally expressed as a part or percentage of the residue of your estate
- pecuniary: a gift of a particular sum of money
- specific: a definite object or property

A **codicil** is an addition or amendment to an existing Will.

Your **estate** is the total value of everything you own at your death, less any outstanding commitments.

An **executor** is the person or people you choose to make your Will happen. They can be a relative, a

friend or your solicitor. Amnesty International UK cannot act as an executor of your Will.

Guardians are the people chosen by parents to look after their children in the event of their death.

Intestacy is the name for the situation that arises when someone dies without making a Will.

Inheritance tax is a 40 per cent tax deducted from estates with a value of more than £325,000. Money left to your spouse or a charity is not taxed. Anyone leaving 10% or more of their taxable estate to charity may qualify for a reduced rate of Inheritance tax - 36% rather than 40%.

Probate (**Confirmation** in Scotland) is the legal process to establish whether your Will is valid. If not, an administrator is appointed.

A testator/testatrix is the person making the Will.

A **trust** is an arrangement you can make in your Will to administer part of your assets after your death.
