### Human Rights in the UK

#### **Human Rights Act**

The government have been holding a consultation on their plans to replace the Human Rights Act with a 'Bill of Rights'. Their proposals are very wide ranging but at their core, Amnesty believes that they would lead to human rights protections being severely weakened and make it much harder to hold the state to account for any violations. Behind all of the technical language is a move to gut the Human Rights Act and limit not only what rights are but who gets them.

The consultation closes on March 8<sup>th</sup>. Quite a few of us have had a go at responding using the online form. This has not been a quick exercise as many of the questions are quite technical but was made far easier thanks to the AIUK guidance.

#### **Nationality and Borders Bill**

## **UAE Update**

Thank you to everyone who took part in the meeting last month. The UAE subgroup has since met to discuss the ideas that came out of the small group discussions. We will be trying to keep our campaign local to Manchester, possibly approaching the Manchester Business School, the Manchester Law Society and the UAE tourist board. I will keep you updated. We are calling for the release of Mohammed al-Roken at the end of his 10-year sentence on 17<sup>th</sup> July 2022 (not 2023 as I said last month). There is concern that he will be subjected to an indefinite extension of his sentence in the 'Munasaha (counselling) centres' like many similar prisoners of conscience in the UAE. The letter writing rota will switch the focus to calling on his release. We hope to plan some more Twitter storms with other Amnesty groups leading up to 17<sup>th</sup> July.

# **Crisis and Tactical**

### **Ukraine update**

On Saturday 26<sup>th</sup> February, members of Manchester Amnesty joined a crowd of over a thousand people at the peace rally held in Piccadilly Gardens. Similar peace rallies in support of Ukraine were held around the world.



In the past week, news of the escalating Russian invasion of Ukraine has been swiftly changing, but has remained hugely distressing. As Amnesty <u>notes</u>, "Russia's invasion of Ukraine is a manifest violation of the United Nations Charter and an act of aggression that is a crime under international law".

Rather than attempt to recount the events of the war, following are some resources I have collated – please get in touch if you have others that you would like to share:

- Amnesty's <u>country page</u> on Ukraine includes a range of reports and news articles – many of these are an opportunity to learn about Ukraine beyond the war
- Evidence from Amnesty's <u>Crisis Evidence</u> <u>Lab</u> verifying indiscriminate attacks during the early stages of this most recent invasion
- Amnesty UK <u>press release</u> on the use of cluster munitions (press release from 27<sup>th</sup> February) – this includes

information on cluster munitions, which, as inherently indiscriminate weapons, are prohibited under customary international humanitarian law.

- Amnesty UK <u>briefing</u> on the "Human Rights Catastrophe"
- Freedom from Torture <u>petition</u> calling on the UK government to help Ukrainian refugees
- <u>Information</u> on Russian police violence in Russia towards anti-war protesters within Russia itself, recalling that protest is a human right.
- The London School of Economics has refuted the version of history Putin has attempted to use to justify this aggression

- The BBC has launched the Ukrainecast <u>podcast</u>
- The Kyiv Independent provides
  updates <u>online</u> and via <u>twitter</u>
- The Ukraine Crisis Media Center
- The UK Disasters Emergency Committee Ukraine <u>Appeal</u> (involves 15 charities, including the British Red Cross)
- Suggestions from the <u>Guardian</u> of "ways you can help the people of Ukraine from the UK", including contributing to campaigns, supporting local journalism, and writing to your MP.

<u>Amnesty Action</u>: send an email to Ministry of Defence of the Russian Federation and demand that Russia ends the aggression immediately, protects civilians and respects international law.

## **Syria**

Amnesty International UK does not appear to be updating the *Justice for Syria* page regularly, but the content there remains an interesting read: <u>https://www.amnesty.org.uk/issues/syria</u>

Amnesty International maintains a Syria <u>country</u> <u>page</u>, which includes reports and news. The most recent news published by Amnesty addresses the deeply concerning violence in the <u>al-Hol camp</u>. At the start of February, at least one child was killed, and another three children and three women were injured by Asayish, the Syrian Kurdish Autonomous Administration's police force.

This case, Amnesty noted, is a "chilling reminder" of the conditions faced by those forced to live in the camps since the conflict with the Islamic State armed group ended in 2019. Diana Semaan, Amnesty International's Syria researcher, recalled the tens of thousands of children currently living in such camps, and the urgent need for "States with nationals in al-Hol must take meaningful action to end the horrors at the camp and repatriate the tens of thousands of children living there. Governments must stop ignoring their international human rights obligations and take all measures to uphold the right of every child to life, survival and development."

At the other end of the age spectrum, Human Rights Watch published a <u>report</u> at the end of February called *No One is Spared: Abuses Against Older People in Armed Conflict*, which features Syria as one of the example case studies. The report presents accounts of older people – particularly older refugees – who have faced human rights abuses and persecution. (This report contains distressing content).

### **Palestine**

On February 1, Amnesty launched a landmark report, Israel's Apartheid Against Palestinians. The report marks the beginning of a multi-year campaign to help dismantle Israel's crushing system of apartheid against Palestinians. The campaign has received widespread media coverage and high profile support, including the South African Foreign Minister and the UNs expert on human rights in the OPT, Michael Link. Amnesty are holding a meeting online on Tuesday, March 8, 7-8 pm. They will discuss how activists and groups can participate in a week of action, which will take place between 21-27 March.

The UNHCR is regularly updating <u>this page</u> to report on those fleeing the war in the Ukraine.



#### Asylum seekers in the UK

Further to the piece on the Nationalities and Borders Bill which appears above in the Campaigns Section (Human Rights in the UK), one of the significant amendments to the bill which passed in the Lords would allow asylum seekers to work if their case had not been settled within 6 months. If retained in the Commons, this would make a major difference to the lives of many asylum seekers in the UK. You can take this action sponsored by Refugee Action.
