- Support our Write for Rights Coffee Morning on Friday 9 December 1000 to 1200 in the Avenue Methodist Church, Minehead. Enjoy tea/coffee and cake and sign letters to the authorities and messages of solidarity to people from around the world featured in this year's campaign.
- Visit our Amnesty Tree in the Minehead Christmas Tree Festival at the Avenue Methodist Church from 2 to 4 December open from 1000 to 1600 on Friday and Saturday and 1200 to 1600 on Sunday. We have decorated the tree with pictures from the Write for Rights campaign booklet.

During protests in response to the death of Mahsa (Zhina) Amini, Iran's authorities have used violence, killing dozens, with impunity. ## Campaign News

#### Afghanistan [Cherry Bird]

The lives of women in Afghanistan continue to be severely restricted by the extremist form of Sharia law imposed by the Taliban government. Every single human right is under threat under the Taliban regime, affecting not only women, but also their families and communities. Policies severely restrict women's freedom of movement and expression and undermine girls' access to education and employment. The Taliban have eroded two decades of women's contributions to the country. To mark this year's 16 Days of Activism against Gender-Based Violence, Amnesty is highlighting the plight of Afghan women. India: BK16 [Cherry Bird]

We are expecting a petition for the BK16 to go live on Amnesty's website on 10 December – Human Rights Day. Meanwhile, there is news that, under a ruling from the Supreme Court, one of the BK16 prisoners, Gautam Navlakha, was

released from prison on 19 November because of his failing health. Although this is a positive development, he is to remain under house arrest, and the fact that he is in such poor health after years in prison is hardly cause for optimism. It is also worth noting that the Indian Government challenged the Court, saying he remained a security risk, but was over-ruled by the Court.



Israel and Occupied Palestinian Territories [Source: AIUK website] Recent news was that a school was demolished in Masafer Yatta in the Occupied West Bank.1,150 people in the area remain at risk of having their homes demolished and being forcibly removed. Israel's execution of this largescale expulsion would amount to forcible transfer, which is a war crime and crime against humanity - and takes place within the wider context of Israel's system of apartheid.
