Amnesty action: campaigns & letter-writing

Egypt update from Margaret, our Campaign Co-ordinator

Alaa Abdel Fattah

Alaa is well physically and mentally now. His prison conditions have changed slightly - he can watch sport (but nothing else) on TV. He can exercise but only in a hall, not outdoors. He can receive books. At his sister Mona's last visit, they talked mostly about her pregnancy (her baby is due in early June).

The Egyptian authorities are making it difficult for Alaa to renounce his Egyptian citizenship, a prerequisite before he is treated as British. This is a barrier they did not impose when Sanaa was in prison and obtained her British citizenship. Alaa is particularly wanting to have access to consular visits which continue to be denied by the Egyptian authorities.

There has been a lot of discussion of Egypt at UN level, which Amnesty, the family and the Foreign Office have contributed to.

- Sanaa Seif, Alaa's sister, <u>spoke about Alaa</u> on 14th March at the UN Human Rights Council
- The UK gave a <u>Statement</u> under Item 4 General Debate to the Human Rights Council meeting on 22nd March 2023.
- "The ongoing detentions of human rights defenders and reports of worsening prison conditions in Egypt is concerning. We
 urge Egypt to ensure media can operate freely, and lift travel bans and asset freezes on civil society leaders, including Egyptian
 Initiative for Personal Rights staff."
- Amnesty International Secretariat sent a <u>submission</u> about Egypt to the UN Human Rights Committee to inform its findings. The UN Human Rights Committee published its <u>findings on Egypt</u> on 24th March 2023.

Action:

Alaa's sisters have asked us to take an action during Ramadan. This is because the President pardons some prisoners when Ramadan ends at Eid.

Please send a card to President Al-Sisi. Your card can be an Eid Mubarak card or a plain card, bought or handmade. Margaret has alo created a template for you to copy, if you prefer.

Please write Ramadan Mubarak inside the card: this means Have a blessed Ramadan or happy Ramadan

Then write your own message asking the President to free Alaa, or use one of these messages


- During this month of forgiveness, please pardon Alaa Abdelfattah
