2	China Campaigns – Debrief from discussion at August meeting (Angela, All)	Angela China: Angela has contacted Nabila about planning to use an IFTA to make contact with the Pakastani diaspora in UK and raise awareness AI and the plight of the Uyghurs in China. There is a written that will be sent to us to explain the IFTA procedure. A flagship IFTA is planned that will involve all London AI groups and Sadiq Khan and other notables next year, probably in March but the exact date will be revealed after discussions in November 2023. Visits to other local IFTAs will be encouraged by joining with other groups to raise funds. Angela will join an IFTA call on 16 th October.
3	Country/regional campaigns – updates from Country Contacts (All) Update on Guantanamo vigil (Anne F)	Africa (W&C) — Anne F reported: DCR (Democratic Republic of Congo) The expansion of industrial scale cobalt and copper mines (neded for most lithium-ion batteries!!!) has led to enforced eviction of entire communities and grevious human rights abuses including sexual assault, arson and beatings Action: Please send a message to the President via Al Urgent Actions Sierra Leone: Violent episodes during election campaign as well as accusations of vote tampering involving both major parties have led to the USA refusing visas to anyone involved. Niger: Since the military overthrow of the government in Juy Jihadist assaults on the aermy have increased, about 20 troops have recently been killed. Nigeria: 4 Nigerians were sentenced in France to between 10 and 10 years in prison for forcing young Nigerian women into prostitution. Stanis Bujakera arrested on Sept 11 th — any letter? China — see above. Europe - Brigitte reported on the conviction in Poland of Justyna Wydrzynska for helping a pregnant woman getting access to an abortion pill Action: Brigitte to prepare a letter to the Prosecutor General asking for the conviction be overturned Mexico & C. America — Roger absent Iran: Graham joined an AIUK video call on 14 September with Paul Dawson, CC Middle East & Gulf, Assaneh Coleman, CC Iran, and Graham B, Sutton. AIUK had been quiet on the 'Left Behind' campaign at the request of the Families. This was born out a few days later when Morad Tabas among others was released by a deal with the USA, circulated to the group on 19 September. In other news, protester Abbas Deris is at urgent risk of execution in relation to the November 2019 nationwide protests in Iran
