#### 27/01/2024: International Day of Commemoration in memory of the victims of the Holocaust

- Holocaust Memorial Day Trust (HMDT) promote and support Holocaust Memorial Day (HMD) – the international day to remember the 6 million Jews murdered during the Holocaust, alongside the millions of people murdered under Nazi persecution of other groups and during more recent genocides in Cambodia, Rwanda, Bosnia and Darfur. 27 January marks the anniversary of the liberation of Auschwitz-Birkenau.

Amnesty action: campaigns & letter-writing

Egypt update from Margaret, our Campaign Co-ordinator

Tragically, the ongoing catastrophe in the Middle East, triggered by the horrific events in Israel and Gaza, have overshadowed other recent developments in the region.

Unsurprisingly, President al-Sisi won an overwhelming victory (89.6% of the vote) in the December presidential elections, having amended the constitution to enable him to stand for a third term and ensured that there were no credible opponents standing. However,



we have heard from our Egypt Coordinator, Debora Singer, that one beneficial effect of the constant communication between UK Government and Egypt about the current conflict, is that:

- The Foreign and Commonwealth Office has reported to us that they have had lots of engagement with the Egyptian authorities due to the conflict in Israel/Gaza. They said they are using every one of these opportunities at all levels (the Prime Minister, Foreign Secretary, Lord Tariq) to raise Alaa's case to show how important it is for the UK government. Foreign Secretary, David Cameron, is taking an interest in Alaa's case.
- While we cannot be sure, I believe that part of the reason that the government is raising Alaa's case so regularly
  during meetings about the conflict in the Middle East is due to the continuing pressure Amnesty members have
  been putting on them.

It is, therefore, vitally important that we keep up the pressure to remind the Egyptian authorities about the need for justice for the **Giulio Regeni**, the Italian student allegedly murdered by security services in Egypt, and to continue to call for the release of **Alaa Abd El-Fattah**.

#### Your Excellency,

I am writing at the time of the anniversary of the murder of **Giulio Regeni** eight years ago to ask for justice for Giulio and also freedom for another human rights defender, **Alaa Abdelfattah.** 

Giulio Regeni, 28 at the time of his death, was a PhD student at Cambridge University researching Egypt's independent trade unions. He was abducted from the streets of Cairo on 25<sup>th</sup> January 2016. His body was found on 3 February 2016, with numerous injuries indicating that he had been tortured. We continue to demand an independent investigation into his abduction and murder and for his perpetrators to be held to account.

Meanwhile Alaa Abdelfattah, 42, continues to be imprisoned after almost a decade. As a prominent human rights activist and writer, he played a prominent role in the 2011 protests and the public discourses at the time around the constitution, the law, the judiciary and democratic institution-building. He is currently held in Wadi al-Natrun prison after being unfairly convicted late in December 2021 on spurious charges of "spreading false news" in social media posts. Amnesty have studied his case and declared him a prisoner of conscience – and so is advocating for his immediate and unconditional release.

We believe these two cases are illustrative of systemic human rights abuses in Egypt, where thousands of people are arbitrarily detained for political reasons. Many of these cases involve human rights defenders being imprisoned for exercising, or defending, their right to freedom of expression and freedom of association. Amnesty believes that freedom of expression is a basic human right and it must be defended everywhere.

We would urge the Egyptian authorities to open a new chapter and to recognise the global importance of justice for Giulio Regeni and freedom for Alaa Abdelfattah.
