NOVEMBER MEETING ACTIONS

IOPT - We are asked to keep contacting our MPs about the ongoing war in Israel / Palestine.

The Economic Activity of Public Bodies (Overseas Matters) Bill currently going through Parliament will make it potentially unlawful for public bodies such as councils and NHS trusts to consider human rights and ethical issues when making decisions about procurement or their investment of funds.

DEATH SENTENCES OVERTURNED



Thousands of you have supported our campaign in support of those who protested in

Iran following the death of Mahsa Amini last year. The impact of your actions has set people free. Protesters Arshia Takdastan, Mehdi Mohammadifard and Kambiz Kharout, sentenced to death for daring to speak out in Iran following grossly unfair trials, had their death sentences overturned after we issued an urgent action to our supporters.

RELEASED FROM PRISON



Yasaman Aryani and Monireh Arabshahi, two Iranian human rights defenders we highlighted as part of our Write for Rights campaign back in 2019, were released from prison after serving four years of their 16-year sentence for speaking out against Iran's discriminatory forced veiling laws.

LGBTQIA+ RIGHTS



Sareh Sedighi-Hamadani's death sentence for defending LGBTQIA+ rights has been overturned after

facing unjust imprisonment and charges from Iranian authorities. Today, thanks to the support of passionate people like you, she has been released on bail.

CAMPAIGN TO ABOLISH DEATH PENALTY

The death penalty campaign has also made strides this year.

MALAYSIA has made significant steps in abolishing the death penalty, abolishing the punishment entirely for seven offences. Ghana's parliament also voted to remove the death penalty from its laws, making the country abolitionist in practice. Both developments are a victory for all those who have tirelessly campaigned to consign this cruel punishment to history.

GHANA: Landmark vote to remove death penalty from laws a major step forward Ghana's Parliament voted to remove the death penalty from the 1960 Criminal and Other Offences Act as well as the 1962Armed Forces Act.

GAZA



Thousands of you have supported our efforts to support those currently suffering in Gaza. Over 25,000 supporters here in Ireland alone have signed our petition demanding a ceasefire in Gaza. The City Councils of Dublin and Limerick also joined Cork and Fingal in endorsing our report declaring Israel an apartheid state, adding to the pressure on the Irish Government to take action.
