#### INTRODUCTIONS

Parts of the Amnesty International UK movement have been attending Pride celebrations and Pride protests for decades, and local pride events are a highlight in the calendar for many of our local groups and student groups, as well as individual activists who attend, organise, marshal and otherwise get involved with events up and down the country.

The importance of Pride events is hard to overstate - as a protest with historic and demonstrable power, as a demand for recognition, as a statement of identity, and as an opportunity for solidarity - Pride is a fundamental cultural touchstone that demands inclusion, and demands Human Rights.

There can be no more fundamental right than the ability to say "I am who I am" - and to be heard.

While rights around recognition and expression of sexuality have seen a reasonably steady upward trajectory in the last several decades, discrimination is still rife, with social media a particularly effective tool for delivering hate speech. The rights and identity of people who are trans remain under public and sustained attack. Globally, over 60 countries around the world still have laws criminalising homosexuality. The need to Pride has not passed.

This pack contains actions that groups and individuals can take to pride events, knowing that the same actions will be taken up and down the country by other parts of the Amnesty movement, and that individually they will be contributing their voices to a collective that is a powerful voice for change.

This year, we're delighted to include an action from the Amnesty Feminists Network as part of their emerging 'My Body My Rights' campaign, which focused on bodily autonomy, including an absolute end to 'conversion therapies'.

Over the past few years, hate crimes against trans people have skyrocketed. In the same period, hostile portrayal of trans people has dramatically increased in the UK media landscape. Home Office's analysis suggest that the two are linked.

Since 2015 an average of 154 articles have been published about trans people every month. This amounts to 13,000 articles, focused on less than 1% of the UK population. This increase has been overwhelmingly negative.

The media has extraordinary power in setting the tone of conversations about Human Rights, and this is particularly the case when speaking about the rights of marginalised communities.

Media regulators such as Ofcom and IPSO have highlighted bad practices such as including anti-trans voices to 'balance' content and a disproportionate focus on transition and medical issues. The lives of trans people are treated as a 'debate' in a way that would not be tolerated with any other minority.

What's more, most of the media is not facilitating the participation of trans people so that they can speak for themselves, The current dehumanising political discourse, amplified by British media, has real consequences, coinciding with a substantial decrease in support for trans people, particularly their right to have their gender legally recognised.

The BBC is not immune from this trend. Several times over the past few years the BBC has had to defend and amend articles that demonstrated substantial anti-trans bias, described the rights of trans people as "an area of controversy" and issued an editorial briefing which seems more focused on the right to choose to label oneself transphobic, or not, than to listen to trans people themselves.

The BBC is a leader in journalism and public debate in both the UK and around the world. We strongly encourage you use this role to actively seek to protect the rights of all people-Making people's lives a

debate and treating positions of hatred and prejudice as 'one' side of the issue is disingenuous and feeds into the scapegoating of minorities that we increasingly see in the political discourse. Human rights are universal and interlinked. When dehumanising a minority becomes acceptable, it opens the door for further erosions of human rights protections.



## TRANS DISCOURSE IN UK MEDIA

We the undersigned call on the BBC to:

- Develop an editorial policy that emphatically recognises that trans people have equal rights, including the right to self-expression and determination, and should be able to talk about themselves.
- Scrutinise whether the coverage of hostile anti-trans narratives is in the public interest and refrain from presenting the rights of trans people as a debate with sides.
- Consistently challenge politicians and opinion makers on why they are disproportionately focused on trans people.

## **CRIMINALISATION IN RUSSIA**



On 30 November 2023, the Supreme Court of Russia ruled to recognise "the international public LGBT movement" as "extremist". This has effectively outlawed any public association with the LGBTQI+ community. Russia must immediately review this ruling to prevent widespread persecution of LGBTQI+ people.

#### "There is little if any doubt that it will lead to the persecution of LGBTI activists while threatening to inspire and legitimize whole new levels of violence against LGBTI persons across Russia."

People found guilty of committing "extremist" activities may face up to 10 years in prison, employment restrictions and restrictions on other rights. Even displaying a Pride flag or other LGBTQI+ symbols can now be expected to lead to an arrest and detention for up to 15 days, or 4 years for a repeated violation.

We must show solidarity with the Russian LGBTQI+ community and demand an end to these oppressive actions to safeguard the principles of equality, freedom and justice for all. No-one should be persecuted for who they love.

## **CRIMINALISATION IN RUSSIA**

We the undersigned call on the Russian authorities to immediately review the decision by the Supreme Court to recognise "the international public LGBT movement" as "extremist", effectively outlawing any public association with LGBTQI+ communities in Russia, and facilitating widespread discrimination.

We further call on Russian authorities to take all possible steps to end the discrimination against all communities marginalised by their sexuality or gender identity.

#### MY BODY, MY RIGHTS END CONVERSION THERAPY

Conversion 'therapy' refers to practices that seek to change, modify or suppress a person's sexual or gender identity. Fundamentally, they identify these aspects of someone's identity as a problem that needs to be 'cured'.

People exploring their sexual or gender identity have the right to do so in an affirming, appropriate and supportive environment - not be shamed, othered, marginalised and abused in the name of being 'fixed'.

According to the Government's 2018 "LGBT survey", in the UK, 7% of LGBTIQ+ individuals had been offered, or had undergone, some form of conversion therapy - with that rising to 13% of people who are trans. Over 50% of those subjected to conversion therapy experienced it in a faith setting, but almost 20% were offered it through a medical or healthcare setting.

The UK government must introduce a comprehensive legislative ban on all conversion therapies.
