
Other events

IT was two years ago that David and Judith Box read an article on Amnesty Interna-tional, and decided that they wanted to become a part of the growing organisation.

"We found that the nearest branch to us was at Selsey," said David. "We joined the group which comprised of about 30 members.



"But communication as grew rather hard during the winter months my wife and I decided to start a group in Bognor," added David.

So in January of this year Mr and Mrs Box formed a Bognor Regis branch of Amnesty International, with the headquarters at their home in Shelley Road, Bognor Regis.

"We now have a membership of 50 and have already been involved in the release of prisoners," he continued.

"When we become more established we will then be able to adopt a prisoner and work solely for his release."

With Mrs Eileen Thomas, of Fernhurst Gardens, Rose Green, as chairman, and a committee of eight, the group has held many organised events to raise money to help them carry out its work.

The group has already been campaigning for prisoners in such countries as Argentina, El Salvador and Guinea.


"We do however need more members if we want to fight for more prisoners," empha-sised David. "Even if they only have time to write one campaigning letter, it all

Amnesty action: campaigns & letter-writing

Egypt update from Margaret, our Campaign Co-ordinator

Laila Souief. After last month's very worrying reports, I am sure you will all be very relieved to hear that Alaa's mother, Laila, has been persuaded to end her hunger strike in protest at her son's continued detention. In a recent update from Amnesty this week we received the news that: Laila has now begun a re-feeding plan in the hospital, and they are monitoring all her vital indicators moment by moment to make sure that her body has reached a stable enough point for her to be discharged. Alaa remains imprisoned as a prisoner of conscience, targeted solely for his peaceful expression and political beliefs.



We wish her a return to health and continue to campaign for Alaa's release.

Petition to call on the U.K. Government to ratify the UN Convention on Enforced Disappearance

Thanks to all of you who attended the recent concert by Rebecca Grove and friends, which not only raised an amazing amount of money in donations to our Amnesty Group but also gathered 42 signatures in support of this important petition. These were duly sent to the petition organizer, to strengthen the call upon our government to ratify the convention which aims to:

- introduce measures to prevent the use of enforced disappearance in the U.K. and in other countries throughout the world where it is widely used to suppress opposition to the state. Mexico alone admits there have been more than 100,000 enforced disappearances.
- enable the U.K. to address the issue of enforced disappearance elsewhere and give protection to UK citizens throughout the world and access to justice and reparation to victims.
- demonstrate commitment to human rights and the rule of law

Ibrahim al-Dersi (Libya) Member of the House of Representatives (Libya's parliament)

Ibrahim al-Dersi went missing on 16 May 2024 after he attended a parade held by the self-proclaimed Libyan Arab Armed Forces (LAAF) in Benghazi. His fate and whereabouts remain unknown. In early May 2025, disturbing videos emerged on social media, showing Ibrahim al-Dersi shirtless in a dimly lit, confined space with concrete walls, bearing visible signs of torture. A heavy metal chain and large padlock were tied around his neck. The LAAF authorities must ensure that information about Ibrahim al-Dersi's fate and whereabouts is disclosed immediately. All those suspected of involvement in his enforced disappearance and torture, including high-ranking officers and commanders, must be brought to trial in fair proceedings. Abdul Rahman Al-Qaradawi (United Arab Emirates)

Egyptian-Turkish poet Abdul Rahman Al-Qaradawi has been subjected to enforced disappearance since his extradition from Lebanon to the United Arab Emirates (UAE) on 8 January 2025. He was arrested by Lebanese security forces on 28 December at the border crossing between Lebanon and Syria. The Lebanese authorities accepted the extradition request by the Emirati authorities on charges of spreading "fake news" and "disturbing public security", in a video he posted on his social media platform while in Syria. This criticised Egyptian, Emirati and Saudi Arabian authorities. There are concerns for his safety, as his family has been unable to obtain any information about his fate, exact whereabouts or legal status; and he has been denied consular visits by Turkish authorities EGYPTIAN-TURKISH POET FORCIBLY DISAPPEARED



Action: end human rights backsliding in Tunisia

25 July 2025 marked the fourth anniversary of President Saied's power grab.

Act now and sign the petition, asking the Tunisian authorities to immediately release all those arbitrarily detained, to end the escalating crackdown on human rights including the rights to freedom of expression, association and peaceful assembly, refrain from compromising judicial independence and uphold the rule of law and the rights of migrants and refugees.

Action: Stop the executions of Pakhshan Aziz and Verisheh Moradi

Pakhshan Azizi and **Verisheh Moradi**, both from Iran's oppressed Kurdish minority, are at imminent risk of execution in Iran. Pakhshan, a humanitarian aid worker, is being punished just for helping women and children displaced by ISIS. Verisheh, a member of the group East Kurdistan Free Woman Society, faces the death penalty following a grossly unfair trial.

Since their arrests in separate cases in August 2023, both have revealed being tortured and otherwise ill-treated, including gender-based violence, and held in solitary confinement. Their trials were deeply unjust, and they are at grave risk of execution.



In the aftermath of the #WomanLifeFreedom uprising, Iran's authorities have intensified the use of the death penalty as a tool of repression and fear, including against women detained on politically-motivated charges. In 2023 alone, the Iranian authorities executed at least 853 people—the highest number in eight years.
