We were very sorry to hear of the recent death of **Colin Crouch**, who continued to be a dedicated supporter of Amnesty International long after his stalwart volunteering for a number of roles in the Group committee, including Chair and Publicity officer. The Group archive includes an article from November 1982 highlighting Colin's membership of Amnesty, whilst working as an English teacher at Midhurst Grammar School; and after his retirement, Colin was a regular speaker about Amnesty in local schools (often turning up, to the excitement of the kids, on his beloved motorbike). Colin, as Chair, was the driving force behind the installation of the Amnesty plaque in Bognor and the service at Chichester Cathedral to celebrate the 50th anniversary of the Universal Declaration of Human Rights, which attracted the talents of Geraldine James, Patricia Routledge and Christopher Timothy. Pamela and Colin also regularly hosted garden parties at their lovely home in Aldwick.

A petition a week. This is a free initiative from Oliver Rothnie, from the Colwyn Bay Amnesty Group, in North Wales. You can sign up to receive a petition related to human rights in the United Kingdom and around the world, with a short background (likely no longer than 200 words) into your inbox every Tuesday.

- You can access the service via Substack blogging platform (at https://apetitionaweek.substack.com), or simply receive the petitions in your inbox as they would for any other mailing list. There is also an Instagram account at @apetitionaweek.
- The petitions will primarily be from Amnesty International and other human rights organisations, as well as the UK Parliament petitions service, which I think is a useful resource, and unfortunately is being used by the far-right for their own deeds.
- The aim is to share important petitions more widely among activists (i.e. Amnesty members) but also people who care about human rights but are not necessarily currently involved in groups. Therefore, the plan is for the initial people on the mailing list to be Amnesty members, but for the service to expand out to others in the community.

Amnesty action: campaigns & letter-writing

Egypt update from Margaret, our Campaign Co-ordinator

### Case of Alaa Abdel Fattah

In the past few days, we have heard from Amnesty's Egyptian Coordinator, Diana Hysenaj, that:

'It has been announced that Egyptian President Abdel Fattah al-Sisi has ordered authorities to study the possible pardon of high-profile Egyptian-British activist and blogger Alaa Abdel Fattah, according to a statement by the Egyptian National Council for Human Rights. Sadly, it has also been reported that on September 1st, Alaa began his latest hunger strike in protest against his detention. I will keep you updated as developments unfold, and we remain hopeful in the meantime. At this stage, there are no further actions planned for this case while we wait. However, if anything changes, I will let you know.'



In an interview on 9 September 2025 on the BBC's *Today Programme*, Sanaa Souief, Alaa's sister, responded to the news that the Egyptian State was reviewing Alaa's appeal for a presidential pardon. Whilst there is no guarantee that it will be granted, it does offer a glimmer of hope for the future. Sanaa sounded very weary and expressed deep disappointment that the family now faces re-starting their campaign for Alaa's release with yet another new Foreign Secretary after the Cabinet re-shuffle this week.

Sanaa also reported that, following the end to her hunger strike, her mother, Laila, was gradually regaining strength but is not likely to recover fully.

We will all hope for a positive outcome to the review of the presidential pardon for Alaa and improved health and strength for Laila.

Action: Saudi Arabia- women's rights activist Manahel al-Otaibi re-sentenced

On 21 August 2025, the appeals court of Saudi Arabia's Specialized Criminal Court (SCC) resentenced fitness influencer and women's rights activist **Manahel al-Otaibi** to five years imprisonment followed by a five-year travel ban. Manahel al-Otaibi has been imprisoned since 16 November 2022. On 9 January 2024, the SCC sentenced Manahel al-Otaibi to 11 years in prison for "terrorist offences" in a secret trial. She was initially charged with violating the Anti-Cyber Crime Law, then faced additional charges under the counter-terror law due to her tweets in support of women's rights as well as posting photos of herself at the mall without an abaya (a traditional loose-fitting long-sleeved robe) on Snanchat



Saudi authorities have subjected her to torture and other ill-treatment, as well as enforced disappearance; she should be immediately and unconditionally released.
