Egypt update from Margaret, our Campaign Co-ordinator

Alaa Abd El-Fattah Pardoned and Released from prison 23 September 2025

We were overjoyed to hear the news of Alaa's release from jail on 23 September and to share the delight of his family as they celebrated their reunion. This photo of Alaa and his mother, Laila (image courtesy of Sky News), who has herself undergone prolonged hunger strikes in protest against his treatment, marks a special moment for us all. So far, we have little information about his future plans. We assume that it will take time to make the necessary arrangements, but we hope that it may eventually be possible for him to be reunited with his son and other family members in the U.K. We will keep you updated as we learn more about his situation.



Sincere thanks to all of you who have campaigned so long and hard over many years on Alaa's behalf. Five other prisoners were also released, so we hope this might mark a softening of the Egyptian regime's attitude towards political activists as we consider the possibility of adopting another of the many political prisoners unjustly detained in Egypt.

Action: call for the release of Tunisian lawyer Ahmed Souab

Ahmed Souab is a prominent Tunisian lawyer and human rights defender known for his outspoken criticism of violations of fair trial rights, executive interference with judicial independence and executive overreach, particularly under President Kais Saied's administration. He previously served as a judge at the Administrative Court and was a vocal critic of the dismantling of the rule of law following President Saied's 25 July 2021 power grab.

Souab represented several high-level victims of violations like Sonia Dahmani in addition to lawyers and political opposition activists Ghazi Chaouachi and Ridha Belhaj, both defendants in the "conspiracy

Nasser Zefzafi: Butterfly Action

Nasser Zefzafi is one of the key figures of the Moroccan protest movement known as "Hirak El-Rif" which erupted in 2017 in Al Hoceima, Zefzafi's hometown. Nasser took to the streets like many in the region who had had enough of poor healthcare, education and employment opportunities. He was arrested in May 2017. In June 2018, he was sentenced by a Casablanca court to 20 years in prison for his peaceful activism. He is currently in poor health.
