**Wed 25 February** at 1430: Minehead Group's AGM at the Minehead QMH, with a talk on minorities in South Asia.

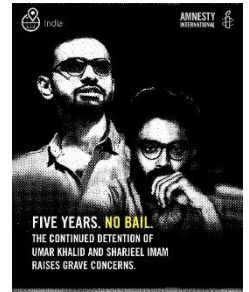
**Tues 10 March** 1400 to 1530 at the Beach Hotel. Letter writing for International Women's Day.

## South Asia Campaign News – update on India: [Cherry writes]

Only three of the **BK16** are left in prison, **Surendra Gadling, Ramesh Gaichor and Sagar Gorkhe**. You can continue writing solidarity letters and cards to them at Taloja Central Prison, Kharjar, Navi Mumbai, Maharashtra 410210, India. [See *Actions overleaf*.]

Separately, **Umar Khalid** a Muslim student activist who is also an Amnesty 'Individual at Risk' case, has been jailed without trial since 2020 under the Unlawful Activities Prevention Act (like the BK16). He spoke at protests against the controversial Citizenship Amendment Act, which links citizenship to religion by excluding Muslims from a path to Indian citizenship, which is available to non-Muslim refugees. Umar has again been refused bail and banned from applying for another year. Please write a solidarity letter or card to Umar. [Address overleaf under *Actions*.]



Interestingly, recent data revealed by the Ministry of Home Affairs in India shows the conviction rate of those arrested under the Unlawful Activities Prevention Act is only 3.2%. This indicates that there was no clear evidence to support most of these arrests, despite the fact that they are often detained for years, as Umar Khalid and the BK16 have been, among many others.

Further evidence of the **increasing intolerance towards other religions**, in a country once known for its secular constitution and religious diversity, is highlighted in two recent incidents. (1) In Bihar state the Chief Minister was seen pulling the hijab off a Muslim woman who was receiving an award at a public awards ceremony for Ayush practitioners. A video of the incident went viral and caused a storm of protest at his disrespect for her as a woman and a Muslim. (2) A report by the NGO, Citizens for Justice and Peace, says that violence against Christian communities has intensified. Between 2014 and 2024, documented incidents of violence against Christians rose from 139 to 834, and in 2025 alone more than 700 incidents were recorded.

### Kashmir:

A **webinar** entitled 'Kashmir: Where Human Rights are Denied' is taking place on **Thursday 5 March** from 1930 to 2100. You will be able to find out about the current human rights situation on the ground and about action you can take. There will be a panel discussion and Q&A. Panel speakers will include **Mirza Saaib Bég**, a lawyer from Indian-Administered Kashmir, and Sajad Rasool, a journalist and activist from Indian-administered Kashmir. A third speaker, to be confirmed, will be from Azad Kashmir, on the Pakistan side, looking at the issues that lie behind recent protests by students and small business entrepreneurs.
